8 An Act relating to alcoholic beverages; amending 37A
9 O.S. 2021, Section 2-107, which relates to wine and
10 spirits wholesaler license; providing for the ability
11 to sell to a charitable organization; and declaring
12 an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 37A O.S. 2021, Section 2-107, is
15 amended to read as follows:

16 Section 2-107. A. A wine and spirits wholesaler license shall
17 authorize the holder thereof:

18 1. To purchase and import into this state spirits and wines
19 from persons authorized to sell same who are the holders of a
20 manufacturer or nonresident seller license, and their agents who are
21 the holders of manufacturer's agent licenses;

22 2. To purchase spirits and wines from licensed distillers,
23 rectifiers and winemakers in this state;

1 3. To purchase spirits and wines from licensed wholesalers, to
2 the extent set forth in subsections B and C of this section;

3 4. To sell in retail containers in this state to retailers~~T~~i
4 mixed beverage, caterer, special event, public event, hotel beverage
5 or airline/railroad beverage licensees~~T~~i or to a charitable
6 organization spirits and wines which have been received and unloaded
7 at the bonded warehouse facilities of the wholesaler before such
8 sale;

9 5. To sell to licensed wholesalers, to the extent set forth in
10 subsections B and C of this section, spirits and wines which have
11 been received and unloaded at the bonded warehouse facilities of the
12 wholesaler before such sale;

13 6. To sell spirits and wines out of this state to qualified
14 persons; and

15 7. To sell to licensed distillers spirits that were
16 manufactured by that distiller and which have been received and
17 unloaded at a bonded warehouse facility of a wholesaler before such
18 sale.

19 Provided, however, sales of spirits and wine in containers with
20 a capacity of less than one-twentieth (1/20) gallon by a holder of a
21 wholesaler license shall be in full case lots and in the original
22 unbroken case. Wholesalers shall be authorized to place such signs
23 outside their place of business as are required by Acts of Congress
24 and by such laws and regulations promulgated under such Acts.

1 B. A wholesaler may sell spirits and wine to other wholesalers
2 or purchase spirits and wines from other wholesalers without
3 complying with subsection A of this section in the case of the sale,
4 purchase or other transfer or acquisition of the entire business of
5 a wholesaler including the inventory of spirits and wine.

6 C. A wholesaler license shall authorize the holder thereof to:

7 1. Maintain not more than three (3) self-owned or leased and
8 self-operated bonded warehouses within this state. All invoices
9 shall be stored at the principal place of business for which the
10 wholesaler license was granted; and

11 2. Accept as payment cash, personal check, cashier's check,
12 money order or electronic fund transfer from persons licensed to
13 purchase alcoholic beverages; provided, a wholesaler shall not be
14 permitted to accept payment by credit card.

15 SECTION 2. It being immediately necessary for the preservation
16 of the public peace, health or safety, an emergency is hereby
17 declared to exist, by reason whereof this act shall take effect and
18 be in full force from and after its passage and approval.
