14	Section 1-124. A. Unless otherwise specifically defined, "per-
15	pupil expenditure" shall mean the aggregate current expenditures of
16	school districts, from all funding sources including federal funds,
17	state funds and local funds, plus the direct support aggregate
18	current expenditures of the state for the day-to-day operations of
19	schools and school districts from all funding sources including
20	federal funds, divided by the aggregate student membership number
21	for the same fiscal year for which the expenditures are determined.
22	The aggregate student membership number shall be the count of
23	students enrolled on October 1 or the school day closest to October
24	1 to whom school districts in the state provide a public education.
