11                                   COMMITTEE SUBSTITUTE

12                   An Act relating to the Oklahoma Department of  
13                   Agriculture, Food, and Forestry; requiring that  
14                   portions of certain appropriated funds be used for  
15                   certain purposes; providing procedures; providing  
16                   lapse dates; and requiring and prohibiting certain  
17                   budget procedures.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19                   SECTION 1. From the funds appropriated to the Oklahoma  
20                   Department of Agriculture, Food, and Forestry in Enrolled Senate  
21                   Bill No. 1922 of the 2nd Session of the 57th Oklahoma Legislature,  
22                   the sum of Two Million Eight Hundred Eighty Thousand Dollars  
23                   (\$2,880,000.00) shall, under the direction of the Commissioner of  
24                   Agriculture, be allocated to extension offices and research centers

1 that are affiliated with the Oklahoma State University Agricultural  
2 Extension Service and Experiment Stations.

3 SECTION 2. Appropriations made to the Oklahoma Department of  
4 Agriculture, Food, and Forestry by Enrolled Senate Bill No. 1922 of  
5 the 2nd Session of the 57th Oklahoma Legislature, not including  
6 appropriations made for capital outlay purposes, may be budgeted for  
7 the fiscal year ending June 30, 2021 (hereafter FY-21) or may be  
8 budgeted for the fiscal year ending June 30, 2022 (hereafter FY-22).  
9 Funds budgeted for FY-21 may be encumbered only through June 30,  
10 2021, and must be expended by November 15, 2021. Any funds  
11 remaining after November 15, 2021, and not budgeted for FY-22, shall  
12 lapse to the credit of the proper fund for the then current fiscal  
13 year. Funds budgeted for FY-22 may be encumbered only through June  
14 30, 2022. Any funds remaining after November 15, 2022, shall lapse  
15 to the credit of the proper fund for the then current fiscal year.  
16 These appropriations may not be budgeted in both fiscal years  
17 simultaneously. Funds budgeted in FY-21, and not required to pay  
18 obligations for that fiscal year, may be budgeted for FY-22, after  
19 the agency to which the funds have been appropriated has prepared  
20 and submitted a budget work program revision removing these funds  
21 from the FY-21 budget work program and after such revision has been  
22 approved by the Office of Management and Enterprise Services.
