7 An Act relating to the Oklahoma Department of  
8 Agriculture, Food, and Forestry; requiring that  
9 portions of certain appropriated funds be used for  
10 certain purposes; providing procedures; providing  
11 lapse dates; and requiring and prohibiting certain  
12 budget procedures.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. From the funds appropriated to the Oklahoma  
15 Department of Agriculture, Food, and Forestry in Enrolled Senate  
16 Bill No. 1922 of the 2nd Session of the 57th Oklahoma Legislature,  
17 the sum of Two Million Eight Hundred Eighty Thousand Dollars  
18 (\$2,880,000.00) shall, under the direction of the Commissioner of  
19 Agriculture, be allocated to extension offices and research centers  
20 that are affiliated with the Oklahoma State University Agricultural  
21 Extension Service and Experiment Stations.

22 SECTION 2. Appropriations made to the Oklahoma Department of  
23 Agriculture, Food, and Forestry by Enrolled Senate Bill No. 1922 of  
24 the 2nd Session of the 57th Oklahoma Legislature, not including

1 appropriations made for capital outlay purposes, may be budgeted for  
2 the fiscal year ending June 30, 2021 (hereafter FY-21) or may be  
3 budgeted for the fiscal year ending June 30, 2022 (hereafter FY-22).  
4 Funds budgeted for FY-21 may be encumbered only through June 30,  
5 2021, and must be expended by November 15, 2021. Any funds  
6 remaining after November 15, 2021, and not budgeted for FY-22, shall  
7 lapse to the credit of the proper fund for the then current fiscal  
8 year. Funds budgeted for FY-22 may be encumbered only through June  
9 30, 2022. Any funds remaining after November 15, 2022, shall lapse  
10 to the credit of the proper fund for the then current fiscal year.  
11 These appropriations may not be budgeted in both fiscal years  
12 simultaneously. Funds budgeted in FY-21, and not required to pay  
13 obligations for that fiscal year, may be budgeted for FY-22, after  
14 the agency to which the funds have been appropriated has prepared  
15 and submitted a budget work program revision removing these funds  
16 from the FY-21 budget work program and after such revision has been  
17 approved by the Office of Management and Enterprise Services.
