ΤΤ	WHEREAS, before World War II African Americans had very limited
12	roles in the defense of the United States and none in military
13	aviation, and when the nation was drawn into the war, African
14	Americans were aspiring to more meaningful roles in the military
15	including flying and maintaining aircraft; and
16	WHEREAS, the rapid expansion of aircraft production during the
17	war created a greater need for military pilots, public outcry from
18	civil rights groups and black professional organizations exhorted
19	the United States War Department to extend to all military members
20	the opportunity to fly airplanes; and
21	WHEREAS, the United States War Department's Civilian Pilot
22	Training Program (CPTP) authorized colleges and universities to
23	train students in order to increase the number of civilian pilots
24	and thereby increase the nation's military preparedness; and

WHEREAS, Alabama's Tuskegee Institute was one of six black
 colleges and universities chosen to participate in the CPTP, was
 later selected to offer advance training, and finally became the
 sole site for segregated military flight training; and

5 WHEREAS, the month of March is significant to the Tuskegee 6 Airmen as it is the month in which five of thirteen cadets in the 7 first class completed training and received their silver wings 8 becoming the nation's first black military pilots; and

9 WHEREAS, Charles B. Hall, originally from Brazil, Indiana, while 10 escorting a group of bombers on July 2, 1943, would shoot down an 11 enemy aircraft becoming the first African American assigned to the 12 U.S. Army Air Corps becoming the first to do so, and after his 13 military career would make Oklahoma City his home working for the 14 Federal Aviation Administration and later Tinker Air Force Base; and 15 WHEREAS, Harold H. Brown of Weleetka, Joseph D. Elsberry of 16 Langston, Samuel J. Foreman of Tulsa, James B. Knighten of Tulsa, 17 Faythe A. McGinnis of Muskogee, Lincoln J. Ragsdale of Ardmore, 18 Robert C. Smith of Muskogee, Yancey Williams of Tulsa, and Isaac R. 19 Woods of Tulsa would all commit to serve in the U.S. Army Air Corps 20 to become Tuskegee Airmen representing the spirit of Oklahomans to 21 service to their nation.
