8 AS INTRODUCED

9 A Resolution recognizing February 6, 2019, as Rose
10 Day 2019 at the State Capitol; and expressing the
11 significance of Rose Day.

13 WHEREAS, one of the great hallmarks of our American form of
14 government is the right of our citizens to express their opinions on
15 matters of great import to their elected officials; and

16 WHEREAS, all members of the Oklahoma House of Representatives
17 greatly esteem and respect this right of the citizens to give their
18 considered input and insight to elected members of the Oklahoma
19 House of Representatives, who are solemnly charged with crafting
20 legislation for the people as a whole; and

21 WHEREAS, the right to life of the unborn is one of the great
22 public policy issues of our day, both for the American people and
23 for Oklahomans of whatever political philosophy or persuasion; and

1 WHEREAS, members of the Oklahoma House of Representatives affirm
2 that all human life is sacred from the point of conception; and

3 WHEREAS, members of the Oklahoma House of Representatives have
4 led the nation in adopting legislation to defend unborn children;
5 and

6 WHEREAS, embryonic stem cell research leads to the destruction
7 of embryonic human beings; and

8 WHEREAS, members of the Oklahoma House of Representatives oppose
9 any policy that would require citizens to pay for abortions through
10 their taxpayer dollars or medical insurance premiums; and

11 WHEREAS, members of the Oklahoma House of Representatives are
12 opposed to trafficking in body parts of aborted babies; and

13 WHEREAS, Oklahoma will continue to lead the nation in the
14 introduction and enactment of legislation to protect unborn
15 children; and

16 WHEREAS, on Rose Day 2019, hundreds of our fellow Oklahomans
17 will take time out of their busy lives to come to their State
18 Capitol to make a public statement respecting the sanctity of human
19 life and the worth of every unborn individual and to speak with
20 their elected officials; and

21 WHEREAS, members of the Oklahoma House of Representatives
22 greatly appreciate the heartfelt involvement of these committed
23 Oklahoma citizens, both young and old, male and female.

1 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
2 OF THE 1ST SESSION OF THE 57TH OKLAHOMA LEGISLATURE:

3 THAT Wednesday, February 6, 2019, is hereby recognized by the
4 Oklahoma House of Representatives and the State of Oklahoma as Rose
5 Day 2019.

6 THAT Rose Day will be a reminder to all members of the House of
7 Representatives that the fight to save the unborn will continue
8 until legal protection for the lives of unborn children has been
9 restored.
