6 AS INTRODUCED

7 An Act relating to state government; creating the  
8 Elimination of Non-Essential Governmental Spending  
9 Act; providing short title; abolishing the Oklahoma  
10 Space Industry Development Authority, the J.M. Davis  
11 Memorial Commission, the Will Rogers Memorial  
12 Commission and the Native American Cultural and  
13 Educational Authority; providing for continuation of  
14 certain actions; requiring that certain funds revert  
15 to General Revenue Fund; transferring certain  
16 property; repealing 53 O.S. 2011, Sections 47.1,  
17 47.2, 47.3, 47.4, 47.4A, as amended by Section 226,  
18 Chapter 304, O.S.L. 2012, 47.5, 47.6, 47.8 and 47.9  
19 (53 O.S. Supp. 2014, Section 47.4A), which relate to  
20 the Will Rogers Memorial Commission; repealing 53  
21 O.S. 2011, Sections 201A, 201B, 201C, 201D, as  
22 amended by Section 1, Chapter 144, O.S.L. 2014, 201E,  
23 201F and 201G (53 O.S. Supp. 2014, Section 201D),  
24 which relate to the J.M. Davis Memorial Commission;  
repealing 74 O.S. 2011, Sections 1226, 1226.1,  
1226.2, 1226.3, 1226.4, 1226.4A, as amended by  
Section 934, Chapter 304, O.S.L. 2012, 1226.5,  
1226.6, 1226.7, 1226.8, 1226.9, 1226.10, 1226.11,  
1226.12, 1226.13, 1226.14, 1226.15, 1226.16 and  
1226.17, as amended by Section 935, Chapter 304,  
O.S.L. 2012 (74 O.S. Supp. 2014, Sections 1226.4A and  
1226.17), which relate to the Native American  
Cultural and Educational Authority; repealing 74 O.S.  
2011, Sections 5201, 5202, 5203, 5204, 5205, 5206,  
5207, 5208, 5208.1, as amended by Section 1044,  
Chapter 304, O.S.L. 2012, 5208.2, 5209, 5210, 5211,  
5212, 5213, 5214, 5215, 5216, 5217, 5218, 5219, 5220,  
5221, 5222, 5223, 5224, 5225, 5226, 5227, 5228, 5229,  
5230, 5231, 5232, 5233, 5234, 5235, 5236 and 5237 (74  
O.S. Supp. 2014, Section 5208.1), which relate to the  
Oklahoma Space Industry Development Authority;

1 providing for noncodification; providing an effective  
2 date; and declaring an emergency.

3  
4 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

5 SECTION 1. NEW LAW A new section of law not to be  
6 codified in the Oklahoma Statutes reads as follows:

7 A. This act shall be known and may be cited as the "Elimination  
8 of Non-Essential Governmental Spending Act".

9 B. Effective July 1, 2015, the following state entities are  
10 hereby abolished:

- 11 1. The Space Industry Development Authority;
- 12 2. The J.M. Davis Memorial Commission;
- 13 3. The Will Rogers Memorial Commission; and
- 14 4. The Native American Cultural and Educational Authority.

15 C. All orders, determinations, rules, regulations, permits,  
16 certificates, licenses, contracts, rates and privileges which have  
17 been issued, made, granted or allowed to become effective by an  
18 entity abolished by this section or by any provision of law affected  
19 by this section, shall continue in effect according to their terms  
20 until terminated or modified by operation of law.

21 D. All funds in possession or under the control of an entity  
22 abolished by this act shall revert to the General Revenue Fund on  
23 July 1, 2015.

1 E. All property or other tangible assets in possession or under  
2 the control of an entity abolished by this act shall be transferred  
3 to the Office of Management and Enterprise Services on July 1, 2015.

4 SECTION 2. REPEALER 53 O.S. 2011, Sections 47.1, 47.2,  
5 47.3, 47.4, 47.4A, as amended by Section 226, Chapter 304, O.S.L.  
6 2012, 47.5, 47.6, 47.8 and 47.9 (53 O.S. Supp. 2014, Section 47.4A),  
7 are hereby repealed.

8 SECTION 3. REPEALER 53 O.S. 2011, Sections 201A, 201B,  
9 201C, 201D, as amended by Section 1, Chapter 144, O.S.L. 2014, 201E,  
10 201F and 201G (53 O.S. Supp. 2014, Section 201D), are hereby  
11 repealed.

12 SECTION 4. REPEALER 74 O.S. 2011, Sections 1226, 1226.1,  
13 1226.2, 1226.3, 1226.4, 1226.4A, as amended by Section 934, Chapter  
14 304, O.S.L. 2012, 1226.5, 1226.6, 1226.7, 1226.8, 1226.9, 1226.10,  
15 1226.11, 1226.12, 1226.13, 1226.14, 1226.15, 1226.16 and 1226.17, as  
16 amended by Section 935, Chapter 304, O.S.L. 2012 (74 O.S Supp. 2014,  
17 Sections 1226.4A and 1226.17), are hereby repealed.

18 SECTION 5. REPEALER 74 O.S. 2011, Sections 5201, 5202,  
19 5203, 5204, 5205, 5206, 5207, 5208, 5208.1, as amended by Section  
20 1044, Chapter 304, O.S.L. 2012, 5208.2, 5209, 5210, 5211, 5212,  
21 5213, 5214, 5215, 5216, 5217, 5218, 5219, 5220, 5221, 5222, 5223,  
22 5224, 5225, 5226, 5227, 5228, 5229, 5230, 5231, 5232, 5233, 5234,  
23 5235, 5236 and 5237 (74 O.S Supp. 2014, Section 5208.1), are hereby  
24 repealed.

1 SECTION 6. This act shall become effective July 1, 2015.

2 SECTION 7. It being immediately necessary for the preservation  
3 of the public peace, health and safety, an emergency is hereby  
4 declared to exist, by reason whereof this act shall take effect and  
5 be in full force from and after its passage and approval.
