7 An Act relating to security of public buildings;  
8 directing certain entities to contract with the  
9 Department of Public Safety for certain services;  
10 amending 73 O.S. 2021, Section 173, which relates to  
11 the Oklahoma Capitol Improvement Authority; updating  
12 statutory language; removing certain references;  
13 providing for codification; providing an effective  
14 date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 1096 of Title 64, unless there  
18 is created a duplication in numbering, reads as follows:

19 The Commissioners of the Land Office and the Office of  
20 Management and Enterprise Services (OMES) shall contract with the  
21 Department of Public Safety for security and law enforcement  
22 services in all facilities under the jurisdiction of the  
23 Commissioners of the Land Office, OMES, or the Department within the  
24 State Capitol Park in Oklahoma City and the Executive Center at 201  
West 5th Street and appurtenances thereto in Tulsa.

1 SECTION 2. AMENDATORY 73 O.S. 2021, Section 173, is  
2 amended to read as follows:

3 Section 173. A. The Oklahoma Capitol Improvement Authority may  
4 contract with the Office of Management and Enterprise Services to  
5 maintain grounds and for housekeeping, maintenance and repair of  
6 properties under the jurisdiction of the Authority.

7 B. The Oklahoma Capitol Improvement Authority and the Office of  
8 Management and Enterprise Services shall contract with the  
9 Department of Public Safety for security and law enforcement  
10 services in all facilities under the jurisdiction of the Authority  
11 or Department within ~~"State Capitol Park"~~ the State Capitol Park in  
12 Oklahoma City ~~and the J. Howard Edmondson Office Building, Robert S.~~  
13 ~~Kerr Office Building and appurtenances thereto in Tulsa.~~

14 C. The Oklahoma Capitol Improvement Authority shall provide  
15 office and operations space for Office of Management and Enterprise  
16 ~~Services'~~ Services functions.

17 D. The Office of Management and Enterprise Services shall  
18 establish accounts for the Office of Management and Enterprise  
19 Services, by building or other improvement, as the Director of the  
20 Office of Management and Enterprise Services considers necessary to  
21 properly account and identify receipts and expenditures related to  
22 construction, repair, maintenance, insurance and other operating  
23 expenses of buildings and improvements owned, used or occupied by or  
24

1 on behalf of the Oklahoma Capitol Improvement Authority, where the  
2 services are carried out by contract with the Authority.

3 SECTION 3. This act shall become effective July 1, 2024.

4 SECTION 4. It being immediately necessary for the preservation  
5 of the public peace, health or safety, an emergency is hereby  
6 declared to exist, by reason whereof this act shall take effect and  
7 be in full force from and after its passage and approval.
