11 An Act relating to the Oklahoma Highway Construction
12 Materials Technician Registration Act; amending 69
13 O.S. 2021, Section 1963, which relates to the Highway
14 Construction Materials Technician Certification Board
15 Revolving Fund; renaming Fund; modifying entity
16 responsible for fund; adding use for Fund; repealing
17 69 O.S. 2021, Sections 1951, 1952, 1953, 1954, 1955,
18 1956, 1957, 1958, 1959, 1960, 1961, 1962, and 1964,
19 which relate to certain definitions, the Highway
20 Construction Materials Technician Certification
21 Board, membership, rules, powers, and duties of the
22 Board, examinations, requirements, and issuance of
23 certificates, revocation and suspension of
24 certificates, independence of Board from the
Department of Transportation, and the liability of
the Board and its members; and providing an effective
date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 69 O.S. 2021, Section 1963, is
amended to read as follows:

1 Section 1963. There is hereby created in the State Treasury a
2 revolving fund to be designated the "Highway Construction Materials
3 Technician Certification ~~Board~~ Revolving Fund". The fund shall be a
4 continuing fund, not subject to fiscal year limitations, and shall
5 consist of all monies received ~~by the Board~~ for deposit in the fund.
6 All monies accruing to the credit of the fund are hereby
7 appropriated and may be budgeted and expended by the ~~Board~~
8 Department of Transportation for the purpose of conducting training
9 ~~and examination and the execution of the powers and duties of the~~
10 ~~Board as set forth in this act~~ or certification of individuals
11 seeking to become registered as highway construction materials
12 technicians. Expenditures from the fund shall be made upon warrants
13 issued by the State Treasurer against claims filed as prescribed by
14 law with the Director of the Office of Management and Enterprise
15 Services for approval and payment.

16 SECTION 2. REPEALER 69 O.S. 2021, Sections 1951, 1952,
17 1953, 1954, 1955, 1956, 1957, 1958, 1959, 1960, 1961, 1962, and
18 1964, are hereby repealed.

19 SECTION 3. This act shall become effective November 1, 2022.
