11 AMENDMENT NO. 1. Strike the title, enacting clause, and entire bill
12 and insert:

14 "An Act relating to the Progressing Rural Economic
15 Prosperity Fund; transferring and appropriating
16 funds; establishing amounts and sources; specifying
17 purpose; and providing for noncodification.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law not to be

20 codified in the Oklahoma Statutes reads as follows:

21 The Director of the Office of Management and Enterprise Services

22 shall transfer on the effective date of this act the sum of One

23 Hundred Forty-five Million Dollars (\$145,000,000.00) of the funds

24 appropriated to the Oklahoma Department of Commerce by Section 1 of

1 Enrolled House Bill No. 1038 of the 1st Extraordinary Session of the
2 59th Oklahoma Legislature to the Progressing Rural Economic
3 Prosperity Fund created in Section 256 of Title 62 of the Oklahoma
4 Statutes, to be budgeted and expended in accordance with law.

5 SECTION 2. NEW LAW A new section of law not to be
6 codified in the Oklahoma Statutes reads as follows:

7 There is hereby appropriated to the Progressing Rural Economic
8 Prosperity Fund created in Section 256 of Title 62 of the Oklahoma
9 Statutes from any monies not otherwise appropriated from the General
10 Revenue Fund of the State Treasury for the fiscal year ending June
11 30, 2024, the sum of One Hundred Five Million Dollars
12 (\$105,000,000.00), to be budgeted and expended in accordance with
13 law."

9 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

10 SECTION 3. The Director of the Office of Management and
11 Enterprise Services shall transfer on the effective date of this act
12 the sum of One Hundred Forty-five Million Dollars (\$145,000,000.00)
13 of the funds appropriated to the Oklahoma Department of Commerce by
14 Section 1 of Enrolled House Bill No. 1038 of the 1st Extraordinary
15 Session of the 59th Oklahoma Legislature to the General Revenue Fund
16 of the State Treasury for the fiscal year ending June 30, 2023.

17 SECTION 4. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
