- e. an overseas voter who was born outside the United

 States, is not described in subparagraph c or d of
 this paragraph, and, except for a state residency
 requirement, otherwise satisfies this state's voter
 eligibility requirements, if:

- 3. "Federal postcard application" means the application prescribed under Section 101(b)(2) of the Uniformed and Overseas Citizens Absentee Voting Act, 42 U.S.C. Section 1973ff(b)(2);
 - 4. "Federal write-in absentee ballot" means the ballot described in Section 103 of the Uniformed and Overseas Citizens Absentee Voting Act, 42 U.S.C. Section 1973ff-2;
 - 5. "Military-overseas ballot" means:
 - a. a federal write-in absentee ballot,
 - a ballot specifically prepared or distributed for use
 by a covered voter in accordance with this act Section
 14-136 et seq. of this title, or
 - c. a ballot cast by a covered voter in accordance with this act the Uniform Military and Overseas Voters Act;
 - 6. "Overseas voter" means a United States citizen who is outside the United States;
 - 7. "State" means a state of the United States, the District of Columbia, Puerto Rico, the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States;
 - 8. "Uniformed service" means:
 - a. active and reserve components of the Army, Navy, Air Force, Marine Corps, Space Force, or Coast Guard of the United States,

- b. the Merchant Marine, the commissioned corps of the

 Public Health Service, or the commissioned corps of

 the National Oceanic and Atmospheric Administration of

 the United States, or
 - c. the National Guard and state militia;
 - 9. "Uniformed-service voter" means an individual who is qualified to vote and is:
 - a. a member of the active or reserve components of the Army, Navy, Air Force, Marine Corps, Space Force, or Coast Guard of the United States who is on active duty,
 - b. a member of the Merchant Marine, the commissioned corps of the Public Health Service, or the commissioned corps of the National Oceanic and Atmospheric Administration of the United States,
 - c. a member on activated status of the National Guard or state militia, or
 - d. a spouse or dependent of a member referred to in this paragraph; and
 - 10. "United States", used in the territorial sense, means the several states, the District of Columbia, Puerto Rico, the United States Virgin Islands, and any territory or insular possession subject to the jurisdiction of the United States.
