| 17 | SECTION 1. AMENDATORY 62 O.S. 2011, Section 34.67, as  |
| 18 | amended by Section 390, Chapter 304, O.S.L. 2012 (62 O.S. Supp.  |
| 19 | 2016, Section 34.67), is amended to read as follows:   |
| 20 | Section 34.67. A. The Director of the Office of Management and   |
| 21 | Enterprise Services <del>is hereby authorized to</del> <u>shall</u> prescribe forms                    |
| 22 | and electronic systems to process claims and payroll to be used by                                     |
| 23 | the various agencies of the state. Any agency of the state may file                                    |
| 24 | a claim against more than one item of the current allotments within                                    |

1 funds by indicating on the claim or payroll the account, or accounts 2 to be charged. The Director shall approve and charge such claim to 3 the account, or accounts, indicated after proper audit of the claim 4 or payroll.

5 B. These payroll systems are hereby authorized for use in 6 claiming amounts due individually to all employees within an agency 7 of the state. Each payroll record shall show the total earnings, 8 the amount of each type of withholding and the net amount due each 9 employee. Withholdings may be reserved by the Director of the 10 Office of Management and Enterprise Services to be paid to the 11 proper entity by lump sum payments.

12 SECTION 2. It being immediately necessary for the preservation 13 of the public peace, health or safety, an emergency is hereby 14 declared to exist, by reason whereof this act shall take effect and 15 be in full force from and after its passage and approval.
