12	SECTION 1. AMENDATORY 21 O.S. 2021, Section 650.7, is

15	means a teacher, principal, or any duly appointed person employed by
16	a school system or employees of a firm contracting with a school
17	system for any purpose, including any personnel not directly related
18	to the teaching process and school board members during school board
19	meetings.
20	B. Any person who, without justifiable or excusable cause,
21	commits any assault, battery, or assault and battery upon the person
22	of a school employee while such employee is in the performance of
23	any duties as a school employee or upon any student while such
24	student is participating in any school activity or attending classes

SENATE FLOOR VERSION - SB1437 SFLR (Bold face denotes Committee Amendments) on school property during school hours shall, upon conviction, be guilty of a misdemeanor. The convicted person shall be punished by a term of imprisonment in the county jail for a period not exceeding one (1) year, or by a fine not exceeding Two Thousand Dollars (\$2,000.00), or by both such fine and imprisonment.

C. Any person who, without justifiable or excusable cause, 6 commits any battery upon the person of a school employee while such 7 employee is in the performance of any duties as a school employee 8 9 shall, upon conviction, be guilty of a felony. The convicted person 10 shall be punished by a term of imprisonment in the custody of the Department of Corrections for a period not exceeding two (2) years, 11 12 or by a fine not exceeding Three Thousand Dollars (\$3,000.00), or by both such fine and imprisonment. 13

D. Any person who, without justifiable or excusable cause, 14 commits any aggravated battery or aggravated assault and battery 15 upon the person of a school employee while such employee is in the 16 performance of any duties as a school employee shall, upon 17 conviction, be quilty of a felony punishable by a term of 18 imprisonment in the State Penitentiary custody of the Department of 19 Corrections for a period not exceeding  $\frac{1}{100}$  four (4) years, or by 20 a fine not exceeding Five Thousand Dollars (\$5,000.00), or by both 21 such fine and imprisonment. 22
