15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 3-130.1 of Title 26, unless
17	there is created a duplication in numbering, reads as follows:
18	A. This act shall be known and may be cited as the "Post-
19	Election Forensic Audit Act of 2022".
20	B. The Governor, the President Pro Tempore of the Senate, and
21	the Speaker of the House of Representatives shall appoint an
22	independent third party to conduct a forensic audit of the general
23	election that took place on November 3, 2020. Such independent

¹ third party shall be appointed no later than thirty (30) days after
² the effective date of this act.

C. The independent third party appointed under subsection B of this section shall complete an audit for every precinct in:

5 1. The three most populous counties as determined by the 2020 6 federal decennial census;

7 2. The three least populous counties as determined by the 2020 8 federal decennial census; and

9 3. Three counties randomly selected by the independent third 10 party.

D. Audits required by this section shall be completed no later than ninety (90) days after the date of the appointment of the independent third party. Upon completion, the independent third party shall submit a report to the Governor, the President Pro Tempore of the Senate, and the Speaker of the House of Representatives that identifies and details any anomaly or discrepancy in voter data, ballot data, or tabulation.

E. Funding required to complete the requirements of this
 section shall be appropriated by the Legislature from funds
 available from the Coronavirus Aid, Relief, and Economic Security
 Act (CARES) or the American Rescue Plan Act of 2021 (ARPA).

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby
