14	SECTION 1. AMENDATORY 47 O.S. 2011, Section 1104.11, as
15	amended by Section 189, Chapter 304, O.S.L. 2012 (47 O.S. Supp.
16	2014, Section 1104.11), is amended to read as follows:
17	Section 1104.11. A. Twenty Dollars (\$20.00) of the fee
18	authorized by Section 1135.5 of this title for the Patriot License
19	Plate shall be deposited in the Patriot License Plate Revolving Fund
20	created in subsection B of this section.
21	B. There is hereby created in the State Treasury a revolving
22	fund for the Military Department of Oklahoma to be designated the
23	"Patriot License Plate Revolving Fund". The fund shall be a
24	continuing fund, not subject to fiscal year limitations, and shall

    All monies accruing to the credit of the fund are hereby
    appropriated and may be budgeted and expended by the Military

    documents, displays, videos, and books that capture the National

        SECTION 2. It being immediately necessary for the preservation

    of the public peace, health and safety, an emergency is hereby
