Supp. 13 2014, Section 1104.11), is amended to read as follows: Section 1104.11. A. Twenty Dollars (\$20.00) of the fee 14 authorized by Section 1135.5 of this title for the Patriot License 15 Plate shall be deposited in the Patriot License Plate Revolving Fund 16 created in subsection B of this section. 17 There is hereby created in the State Treasury a revolving 18 fund for the Military Department of Oklahoma to be designated the 19 20 "Patriot License Plate Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall 21 consist of all monies received by the Military Department of 22 Oklahoma pursuant to the provisions of subsection A of this section. 23 All monies accruing to the credit of the fund are hereby 24

2	Department of Oklahoma for any deployment-related purpose <del>for</del>
3	Oklahoma residents who are members of the Oklahoma National Guard
