12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY Section 2, Chapter 281, O.S.L.
14	2023 (70 O.S. Supp. 2023, Section 5-148.2), is amended to read as
15	follows:
16	Section 5-148.2. A. There is hereby created in the State
17	Treasury a revolving fund for the State Department of Education to
18	be designated the "School Security Revolving Fund". The fund shall
19	be a continuing fund, not subject to fiscal year limitations, and
20	shall consist of all monies received by the State Department of
21	Education from:
22	1. Reimbursements, grants, or other monies received from other
23	state agencies and entities for school security;
24	

- 2. Reimbursements, grants, or other monies received from the United States government obligated to school security projects;
 - 3. Gifts, donations, and bequests; and
 - 4. Monies appropriated or apportioned by the Legislature.
- B. All monies accruing to the credit of the School Security
 Revolving Fund are hereby appropriated and may be budgeted and
 expended by the State Department of Education for the purposes of:
- Establishing and maintaining a School Resource Officer
 Program; and
- 2. Providing physical security enhancements for schools including, but not limited to, school resource officers, cameras, gates, lighting, locks, doors, windows, security geofencing, and ballistic storm shelters.
- Monies in the School Security Revolving Fund shall supplement and not supplant existing school security funding.
- C. Expenditures from the School Security Revolving Fund shall 16 be made upon warrants issued by the State Treasurer against claims 17 filed as prescribed by law with the Director of the Office of 18 Management and Enterprise Services for approval and payment. 19 Expenditures Annual school district allocations from the School 20 Security Revolving Fund shall not exceed Fifty Million Dollars 21 (\$50,000,000.00) in any fiscal year and shall be divided equally 22 among every public school district in the state. 23
