15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 47 O.S. 2021, Section 759, as last
17	amended by Section 3, Chapter 283, O.S.L. 2021, is amended to read
18	as follows:
19	Section 759. A. There is hereby re-created, to continue until
20	July 1, 2022 July 1, 2025, in accordance with the provisions of the
21	Oklahoma Sunset Law, the Board of Tests for Alcohol and Drug
22	Influence to be composed of the following members beginning July 1,
23	2015:

1 1. The Dean of the Oklahoma State University College of 2 Osteopathic Medicine, or a designee; The Dean of the University of Oklahoma College of Medicine, 3 2. or a designee; 4 5 3. The Commissioner of Public Safety, or a designee; The Director of the Oklahoma State Bureau of Investigation, 6 4. or a designee; 7 5. The State Commissioner of Health, or a designee; 8 9 6. The Director of the Council on Law Enforcement Education and 10 Training, or a designee; 7. One certified peace officer who is a member of a local law 11 12 enforcement agency selected by the Oklahoma Sheriffs and Peace 13 Officers Association; and 8. One person selected by the Oklahoma Association of Chiefs of 14 Police. 15 Members shall serve without pay other than reimbursement of 16 necessary and actual expenses as provided in the State Travel 17 Reimbursement Act. Each member shall receive an appointment in 18 writing which shall become a permanent part of the records of the 19 The chair and vice-chair shall be elected from the Board. 20 membership of the Board every two (2) years. The Board is 21 authorized to appoint a State Director of Tests for Alcohol and Drug 22 Influence and other employees, including, but not limited to, 23 persons to conduct training and provide administrative assistance as 24

1 necessary for the performance of its functions, subject to available 2 funding and authorized full-time equivalent employee limitations. The Board may expend appropriated funds for purposes consistent with 3 Sections 751 through 761 of this title and Sections 301 through 308 4 of Title 3 of the Oklahoma Statutes. The Legislature shall 5 appropriate funds to the Department of Public Safety for the support 6 of the Board of Tests For Alcohol and Drug Influence and its 7 employees, if any. Upon the transfer of any employees from the 8 9 Alcohol Drug Countermeasures Unit of the Department of Public Safety to the Board of Tests For Alcohol and Drug Influence on July 1, 10 2003, all funds of the Unit appropriated and budgeted shall be 11 12 transferred to the Board, and may be budgeted and expended to 13 support the functions and personnel of the Board.

Collection of a person's blood to be considered valid and Β. 14 admissible in evidence, whether performed by or at the direction of 15 a law enforcement officer or at the request of the tested person, 16 shall have been performed by a person authorized to collect blood 17 pursuant to the provisions of Section 752 of this title. Analysis 18 of a person's blood to be considered valid and admissible in 19 evidence, whether performed by or at the direction of a law 20 enforcement officer or at the request of the tested person, shall 21 have been performed by a laboratory accredited in accordance with 22 ISO/IEC 17025 as defined in Section 150.37 of Title 74 of the 23 Oklahoma Statutes. 24

1 C. Collection of a person's breath, to be considered valid and 2 admissible in evidence:

Shall have been performed by an individual possessing a
 valid permit issued by the Board of Tests for Alcohol and Drug
 Influence for this purpose; and

6 2. Shall have been performed on a breath alcohol measurement
7 device appearing on the most current conforming products list of
8 such devices published by the U.S. Department of Transportation in
9 the Federal Register, and utilizing a calibrating unit appearing on
10 the most current conforming products list of such devices published
11 by the U.S. Department of Transportation in the Federal Register;

Shall have been performed on a device maintained by the
 Board of Tests for Alcohol and Drug Influence; and

4. Shall have been performed in accordance with the operating
procedure prescribed by the State Director of Tests or the Board of
Test for Alcohol and Drug Influence.

D. The Board is authorized to prescribe uniform standards and 17 conditions for, and to approve satisfactory methods, procedures, 18 techniques, devices, equipment and records for tests and analyses 19 and to prescribe and approve the requisite education and training 20 for the performance of tests or analyses of breath to determine the 21 breath alcohol concentration. The Board shall establish standards 22 for and ascertain the qualifications and competence of individuals 23 to administer tests and analyses of breath to determine the breath 24

1 alcohol concentration, and to issue permits to individuals which 2 shall be subject to suspension or revocation at the discretion of The Board is authorized to prescribe uniform standards, 3 the Board. conditions, methods, procedures, techniques, devices, equipment and 4 5 records for the collection, handling, retention, storage, preservation and delivery of specimens of blood, breath, saliva and 6 urine obtained for the purpose of determining the alcohol 7 concentration thereof or the presence or concentration of any other 8 9 intoxicating substance therein. The Board may take such other 10 actions as may be reasonably necessary or appropriate to effectuate the purposes of Sections 751 through 761 of this title and Sections 11 12 301 through 308 of Title 3 of the Oklahoma Statutes, and may adopt, amend and repeal such other rules consistent with this chapter as 13 the Board shall determine proper. The Board is authorized to 14 delegate authority granted in this section to the State Director of 15 Tests as it deems appropriate. 16

Ε. The Board shall promulgate rules adopting uniform standards 17 and conditions and rules approving devices, equipment, methods, 18 procedures, techniques, and records for screening tests administered 19 for the purpose of determining the presence or concentration of 20 alcohol or any other intoxicating substance in a person's blood, 21 breath, saliva or urine. Such screening tests shall be performed in 22 compliance with the rules adopted by the Board of Tests for Alcohol 23 and Drug Influence. For purposes of this subsection, "screening 24

1 test" means the use of devices, equipment, methods, procedures,
2 techniques and records by law enforcement officers at roadside to
3 assist in the development of probable cause.

F. The Board may set rules and charge appropriate fees for
operations incidental to its required duties and responsibilities.

There is hereby created in the State Treasury a revolving 6 G. fund for the Board of Tests for Alcohol and Drug Influence to be 7 designated the "Board of Tests for Alcohol and Drug Influence 8 9 Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of monies received 10 pursuant to the provisions of subsection F of this section and any 11 funds previously deposited in the Board of Tests for Alcohol and 12 13 Drug Influence Revolving Fund. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by 14 the Board of Tests for Alcohol and Drug Influence for operating 15 expenses of the Board. Expenditures from the funds shall be made 16 upon warrants issued by the State Treasurer against claims filed as 17 prescribed by law with the Director of the Office of Management and 18 Enterprise Services for approval and payment. 19

20 SECTION 2. AMENDATORY 73 O.S. 2021, Section 83.1, is 21 amended to read as follows:

22 Section 83.1. A. There is hereby re-created to continue until 23 July 1, 2022 July 1, 2025, in accordance with the Oklahoma Sunset 24 Law, a Capitol-Medical Center Improvement and Zoning Commission to

exercise the functions and perform the duties hereinafter
 prescribed.

3 B. The Commission shall be composed of eleven (11) members as 4 follows:

5 1. The Director of the Office of Management and Enterprise
6 Services or his or her designee, who shall be ex officio chair of
7 the Capitol-Medical Center Improvement and Zoning Commission;

8 2. The Director of the Transportation Commission or his or her9 designee;

The President of the University of Oklahoma or his or her
 designee;

Two members appointed by the President Pro Tempore of the
 Senate;

14 5. Two members appointed by the Speaker of the House of 15 Representatives;

16 6. The Chair of the Planning Commission of Oklahoma City or his17 or her designee;

7. The Chair of the Long-Range Capital Planning Commission; and
8. Two members of the Commission appointed by the Governor,
with the advice and consent of the State Senate, for four-year
staggered terms with one term expiring on January 31 of each evennumbered year.

C. One of the two members shall be appointed upon therecommendation of the Citizens' Advisory Committee. The Commission

1 is authorized to appoint and hire a Director, who shall serve as the 2 chief administrative officer of the Commission, and other necessary 3 personnel. The Attorney General of the State of Oklahoma shall be 4 the legal advisor to the Commission in the same capacity as he or 5 she is to other boards and commissions.

D. At least one of the members appointed by the President Pro
Tempore of the Senate and the Speaker of the House of
Representatives shall be a resident within the boundaries of the
Capitol-Medical Center Improvement and Zoning District as set forth
in Section 83 of this title.

11 SECTION 3. AMENDATORY 74 O.S. 2021, Section 7005, is 12 amended to read as follows:

13 Section 7005. A. The Oversight Committee for State Employee Charitable Contributions shall be composed of the Director of the 14 Office of Management and Enterprise Services, or designee and six 15 state employees, of which two shall be appointed by the Governor, 16 17 two shall be appointed by the President Pro Tempore of the Senate and two shall be appointed by the Speaker of the House of 18 Representatives. Members shall serve at the pleasure of their 19 appointing authorities. The provisions of Section 6 of Title 51 of 20 the Oklahoma Statutes shall not apply to appointments to the 21 Committee. The Committee is re-created to continue until July 1, 22 2022 July 1, 2025, in accordance with the provisions of the Oklahoma 23 Sunset Law. 24

B. The Committee annually shall elect a chairman from its
 membership. The Director of the Office of Management and Enterprise
 Services shall serve as chairman until the first such election.

4 C. The Oversight Committee for State Employee Charitable
5 Contributions shall have the following duties and responsibilities:

6 1. Arrange for publication of information about the application7 process;

8 2. Review applications of federations electing to participate 9 in the State Charitable Campaign and certify that a federation and 10 each of its member agencies meet the eligibility criteria set forth 11 in Sections 7009 and 7010 of this title;

Notify in writing each of the applying federations of its acceptance or rejection. Provided, if a federation is rejected, the Committee shall provide the reason for rejection of each of the member agencies of the federation;

16 4. Hear appeals of rejected agencies;

5. Delegate to the principal combined fund-raising organization
the primary responsibility for the staffing and the financial
obligations necessary to comply with the provisions of this
subsection;

21 6. Develop a pledge card to be used throughout the State22 Charitable Campaign;

7. Select a principal combined fund-raising organization to
 assist the Committee in gathering and accumulating the applications;
 and

8. Promulgate rules to implement the provisions of the Oklahoma
5 State Employee Charitable Contribution Act.

D. The Office of Management and Enterprise Services shallprovide such staff support as is required by the Committee.

8 E. The Oversight Committee for State Employee Charitable 9 Contributions is authorized to appoint such advisory councils and 10 task forces as it deems necessary for counsel, advice and review 11 concerning the formulation and administration of the rules, 12 application review process and the implementation of the Oklahoma 13 State Employee Charitable Contribution Act.

14 SECTION 4. This act shall become effective July 1, 2022.

15 SECTION 5. It being immediately necessary for the preservation 16 of the public peace, health or safety, an emergency is hereby 17 declared to exist, by reason whereof this act shall take effect and 18 be in full force from and after its passage and approval.
