16	A. 1. Beginning July 1, 2023, and each fiscal year thereafter,

20	maintain a State Strategic Petroleum Reserve. The Reserve shall
21	contain up to fifteen million barrels of crude oil. The Corporation
22	Commission shall maintain the Reserve and is authorized to
23	promulgate rules necessary to effectuate the provisions of this act.

2. For the purposes of this act, "State Strategic Petroleum Reserve" means state-owned oil stocks maintained in oil wells within the boundaries of this state.

- B. Oil may be released from the Reserve by executive order of the Governor or by direction of the Legislature if a measure directing the release is enacted; provided, evidence of one or more of the following conditions or circumstances for release shall be established:
- 1. The state or any oil-producing entity operating in the state faces a disruption in supply;
- 2. An exchange agreement with another country, state, political subdivision, or oil company is entered into;
 - 3. The Governor has declared a state of emergency;
- 4. Non-emergency sales are deemed necessary to raise revenue or lessen supply disruptions;
- 5. The National Guard of Oklahoma or any other emergency response entity of this state or a political subdivision of this state demonstrates to the Legislature an increased need for oil; or
- 6. The price of gas or diesel has increased by more than twenty-five percent (25%) within a three-month period; provided, oil shall be released to service stations only following such stations entering into an agreement or contract that the oil shall be used to lower the cost of gas and diesel to consumers in this state.
