18 AMENDMENT NO. 1. Delete the title, enacting clause and entire bill  
19 and replace with:

20 "An Act relating to higher education; amending 70  
21 O.S. 2011, Section 4668, which relates to the  
22 Northeastern State University - Tulsa metropolitan  
23 area branch; eliminating certain prohibition against  
24 duplicate undergraduate degree programs; and  
providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 70 O.S. 2011, Section 4668, is  
3 amended to read as follows:

4 Section 4668. On July 1, 2001, there may be established a  
5 branch of Northeastern State University within the Tulsa  
6 metropolitan area. The Oklahoma State Regents for Higher Education  
7 are authorized to make upper division undergraduate and graduate  
8 course offerings at the Northeastern State University branch  
9 available as the State Regents shall determine are appropriate.  
10 ~~Undergraduate degree programs offered through Oklahoma State~~  
11 ~~University/Tulsa shall not duplicate those undergraduate degree~~  
12 ~~programs offered by Northeastern State University in Tulsa, as~~  
13 ~~determined by the Oklahoma State Regents for Higher Education.~~

14 The Oklahoma State Regents for Higher Education shall fund  
15 Northeastern State University at a level not less than its fiscal  
16 year 1998 level, and its Education and General Budget shall be held  
17 harmless from reductions in succeeding years.

18 It is the intent of the Legislature that Northeastern State  
19 University be funded at a level consistent with the average  
20 allocation and allotment of the institutions in the regional funding  
21 tier as established by the Oklahoma State Regents for Higher  
22 Education.

23 Beginning with the 2001-2002 academic year, degrees earned at  
24 Northeastern State University Branch in Tulsa shall be designated as

1 awarded by the Oklahoma State Regents for Higher Education acting  
2 through Northeastern State University.

3 SECTION 2. This act shall become effective November 1, 2021."

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 3. AMENDATORY 70 O.S. 2011, Section 626.4, is  
amended to read as follows:

Section 626.4. State tuition aid grants shall be awarded ~~to all~~  
~~eligible applicants~~ without any limitation on the number to be  
awarded in any year other than the amount of appropriations  
available therefor. The institution involved may appropriately

1 schedule work to permit recipients to earn the amount of said  
2 tuition grants.

3 Definitions of full-time and part-time undergraduate and  
4 graduate students shall be established by the Oklahoma State Regents  
5 for Higher Education.

6 SECTION 4. AMENDATORY 70 O.S. 2011, Section 626.7, is  
7 amended to read as follows:

8 Section 626.7. A college tuition aid grant ~~shall~~ may be awarded  
9 annually to each eligible, qualified full-time or part-time  
10 undergraduate or graduate student enrolled in a curriculum leading  
11 to a degree or certificate in an institution of collegiate grade or  
12 postsecondary institution providing a program of training to prepare  
13 students for employment in a recognized occupation in Oklahoma  
14 approved or accredited by the Oklahoma State Regents for Higher  
15 Education or appropriate postsecondary agency in accordance with the  
16 following:

17 1. Eligibility. Each full-time or part-time resident student  
18 will be eligible to receive a grant in an amount as provided in  
19 paragraph 2 of this section. The Oklahoma State Regents for Higher  
20 Education shall determine by rules and regulations the maximum  
21 number of semesters a student may be eligible for grants. No  
22 student shall be eligible for grants unless the student maintains  
23 such minimum standards of academic performance as are required by  
24 the institution in which the student is enrolled.

1 In the event a student for any reason ceases to continue to be  
2 enrolled during the course of an academic year, the student shall  
3 cease to be eligible for tuition aid.

4 2. Amount of grant. The amount of tuition aid grant to any  
5 student under ~~this act~~ the Oklahoma Higher Education Tuition Act for  
6 any semester shall represent a percentage not greater than seventy-  
7 five percent (75%) of the tuition and enrollment fees normally  
8 charged to residents of the State of Oklahoma by the institution of  
9 attendance. The Oklahoma State Regents for Higher Education shall  
10 determine by rules the annual maximum award amount based on an  
11 annual assessment of funds availability. ~~The State Regents shall~~  
12 ~~not increase the annual maximum award amount unless funding is~~  
13 ~~sufficient to serve at least the same number of students as the~~  
14 ~~previous academic year.~~

15 ~~For the 2000-2001 academic year and each academic year~~  
16 ~~thereafter, the percentage of aid shall be based on a need analysis~~  
17 ~~system that is consistent with federal student financial aid~~  
18 ~~regulations. The Oklahoma State Regents for Higher Education shall~~  
19 ~~set an annual award payment schedule based upon a maximum grant of~~  
20 ~~seventy-five percent (75%) of tuition and fees with grants based on~~  
21 ~~lower percentages of tuition and fees being awarded to students who~~  
22 ~~demonstrate lower financial need.~~

23 ~~Any student who receives an award for the 1999-2000 academic~~  
24 ~~year shall not be denied additional awards because of inability to~~

1 ~~meet the financial standards established in this act as long as~~  
2 ~~other eligibility criteria continue to be met and as long as the~~  
3 ~~award status of the student is renewed on an annual basis. The~~  
4 ~~Oklahoma State Regents for Higher Education are authorized to~~  
5 ~~establish procedures to determine the financial need of the student~~  
6 ~~under the standards used during the 1999-2000 academic year until~~  
7 ~~the initial degree requirements are met by the student.~~

8 Financial assistance received under ~~this act will~~ the Oklahoma  
9 Higher Education Tuition Act shall be considered as part of a  
10 student's financial aid package.

11 SECTION 5. AMENDATORY 70 O.S. 2011, Section 626.8, is  
12 amended to read as follows:

13 Section 626.8. The Oklahoma State Regents for Higher Education  
14 may adopt rules and regulations, prescribe and provide appropriate  
15 forms for application and employ such persons, contract for such  
16 services and make such additional expenditures as may be necessary  
17 or appropriate for effectuating the provisions of ~~this act~~ Section  
18 626.1 et seq. of this title.

19 The Oklahoma State Regents for Higher Education are hereby  
20 authorized to determine priorities for participation in this tuition  
21 aid program ~~by~~ based upon factors including but not limited to full-  
22 time, or part-time enrollment status, undergraduate ~~and~~ or graduate  
23 ~~students~~ enrollment status, unmet financial need, continuous  
24 enrollment, nearness to completion of a degree or certificate, state

1 employment needs, eligibility for other state and institutional  
2 student financial aid and based on available state funding.

3 SECTION 6. This act shall become effective July 1, 2021.

4 SECTION 7. It being immediately necessary for the preservation  
5 of the public peace, health or safety, an emergency is hereby  
6 declared to exist, by reason whereof this act shall take effect and  
7 be in full force from and after its passage and approval.
