3 2. a. Every person registering a motor vehicle in this
4 state, except a motor vehicle which is not being used
5 upon the public highways or public streets, or a
6 manufactured home while on a permanent foundation, at
7 the time of registration of the vehicle, shall certify
8 the existence of security with respect to the vehicle
9 by ~~surrendering~~ providing to a motor license agent or
10 other registering agency ~~a necessary information from~~
11 the current owner's security verification form from an
12 ~~insurance carrier authorized to do business in this~~
13 ~~state or an equivalent form issued by the Department~~
14 ~~of Public Safety~~ in a manner that allows verification
15 of coverage through the online verification system.
16 The information shall include the name or number
17 issued by the National Association of Insurance
18 Commissioners of the current insurance carrier
19 authorized to do business in this state and the policy
20 number applicable to the vehicle being registered. A
21 motor license agent or other registering agency shall
22 require the ~~surrender~~ submission of the form or other
23 verifying information prior to processing an
24 application for registration or renewal.

1 b. Every motor license agent or other registering agency
2 shall use the online verification system to certify
3 the existence of security with respect to the vehicle
4 from an insurance carrier authorized to do business in
5 this state unless the online verification system is
6 not online or the required information is otherwise
7 not available. In such a case, the license agent or
8 other registering agency may accept verification as
9 provided in subparagraph a of this paragraph to
10 certify the existence of the required insurance prior
11 to processing any application for motor vehicle
12 registration.

13 3. Fleet vehicles operating under the authority of the
14 Corporation Commission, the Federal Highway Administration, or
15 vehicles registered pursuant to the provisions of Section 1120 of
16 this title, shall certify the existence of security with respect to
17 each vehicle at the time of registration by submitting one of the
18 following:

- 19 a. a current owner's security verification form verifying
20 the existence of security as required by the
21 Compulsory Insurance Law, or
22 b. a permit number verified by the Corporation Commission
23 indicating the existence of a current liability
24 insurance policy. Provided, in the event the

1 Corporation Commission is unable to verify the
2 existence of insurance as provided herein in a prompt
3 and timely fashion, the Corporation Commission may
4 accept a current single state registration form issued
5 by the Corporation Commission or any other regulating
6 entity with which the Corporation Commission has
7 entered into a reciprocal compact or agreement
8 regarding the regulation of motor vehicles engaged in
9 interstate or foreign commerce upon and over the
10 public highways.

11 4. The following shall not be required to carry an owner's or
12 operator's security verification form or an equivalent form from the
13 Department of Public Safety during operation of the vehicle and
14 shall not be required to surrender a security verification form for
15 vehicle registration purposes:

- 16 a. any vehicle owned or leased by the federal or state
17 government, or any agency or political subdivision
18 thereof,
- 19 b. any vehicle bearing the name, symbol, or logo of a
20 business, corporation or utility on the exterior and
21 which is in compliance with the provisions of the
22 Compulsory Insurance Law according to records of the
23 Corporation Commission which reflect a deposit or
24 fleet policy,

- c. fleet vehicles maintaining current vehicle liability insurance as required by the Corporation Commission or any other regulating entity,
- d. any licensed taxicab, and
- e. any vehicle owned by a licensed used motor vehicle dealer.

5. Any person who knowingly issues or promulgates false or fraudulent information in connection with either an owner's or operator's security verification form or an equivalent form which has been issued by the Department of Public Safety shall be guilty of a misdemeanor and upon conviction shall be subject to a fine not exceeding Five Hundred Dollars (\$500.00), or imprisonment for not more than six (6) months, or by both such fine and imprisonment.

B. Each motor license agent is authorized to charge a fee of One Dollar and fifty cents (\$1.50) to each person to whom the agent issues a certificate of registration and who is required to surrender proof of financial responsibility, or for whom the motor license agent certifies the existence of financial responsibility through an authorized online certification system, pursuant to the provisions of the Compulsory Insurance Law. The fee may be retained by the agent as compensation for services in processing the proof of financial responsibility and for processing the driver license information, insurance verification information, and other additional information furnished to the agent pursuant to Section

1 1112 of this title, if such agent does not receive the maximum
2 compensation as authorized by law.

3 SECTION 2. This act shall become effective November 1, 2015.
