14	SECTION 1. AMENDATORY 69 O.S. 2011, Section 1600.1, as
15	amended by Section 12, Chapter 372, O.S.L. 2013 (69 O.S. Supp. 2014,
16	Section 1600.1), is amended to read as follows:
17	Section 1600.1. Highways, bridges, and other facilities which
18	are part of the state highway system may be considered for
19	dedication in honor of individuals deserving of commendation for
20	their active involvement in the project or for outstanding service
21	to the nation, this state, or their community. Persons proposed to
22	be so honored shall have been deceased not less than three (3) years
23	prior to consideration. The provisions of this section shall not
24	apply to the naming of highways and bridges on the state highway

1 system designed to honor members of the United States Armed Forces, 2 members of law enforcement or firefighters fallen in the performance 3 of their duties. The provisions of this section shall also not 4 apply to the naming of highways and bridges on the state highway 5 system designed to honor Medal of Honor recipients both living and deceased. Proposals for the dedication of state highway facilities 6 7 should specifically state the accomplishments upon which the proposal is based. 8

9 SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.213 of Title 69, unless 10 there is created a duplication in numbering, reads as follows: 11 12 The section of U.S. Highway 81 beginning at the intersection of U.S. Highway 70 and extending north to the municipal limits of 13 Addington shall be designated as the "Command Sergeant Major Benny 14 G. Adkins Highway". The Department of Transportation shall cause 15 suitable permanent markers bearing that name to be placed on the 16 highway. 17

SECTION 3. This act shall become effective July 1, 2015.
SECTION 4. It being immediately necessary for the preservation
of the public peace, health and safety, an emergency is hereby
declared to exist, by reason whereof this act shall take effect and
be in full force from and after its passage and approval.
