From the funds appropriated to the Oklahoma State 15 Regents for Higher Education in Enrolled House Bill No. 1004 of the 16 1st Extraordinary Session of the 59th Oklahoma Legislature, the 17 Oklahoma State Regents for Higher Education are authorized to expend 18 during the fiscal year ending June 30, 2024, the sum of Seventeen 19 20 Million Four Hundred Thousand Dollars (\$17,400,000.00) for the incentive scholarship program and teacher employment incentive 21 program, pursuant to Section 698.3 of Title 70 of the Oklahoma 22 Statutes. Such funds shall be used to supplement rather than 23 24 replace existing resources and programs.

Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Twelve Million Five Hundred Thousand Dollars (\$12,500,000.00) for the purpose of establishing the National Guard Educational Assistance Fund.

SECTION 3. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Forty-eight Million Nine Hundred Eight Thousand Two Hundred Sixteen Dollars (\$48,908,216.00) for the purpose of faculty pay raises.

SECTION 4. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Twenty Million Dollars (\$20,000,000.00) for the purpose of expanding engineering programs. Such funds shall be used to supplement rather than replace existing resources and programs.

SECTION 5. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Five Million Dollars (\$5,000,000.00) for the purpose of application-based health care.

SECTION 6. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Twelve Million Five Hundred Thousand Dollars (\$12,500,000.00) for the purpose of developing critical workforce development initiatives.

SECTION 7. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Twelve Million Five Hundred Thousand Dollars (\$12,500,000.00) for the purpose of ensuring student success and institutional excellence.

SECTION 8. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the
