

1 SECTION 2. From the funds appropriated to the Oklahoma State
2 Regents for Higher Education in Enrolled House Bill No. 1004 of the
3 1st Extraordinary Session of the 59th Oklahoma Legislature, the
4 Oklahoma State Regents for Higher Education are authorized to expend
5 during the fiscal year ending June 30, 2024, the sum of Twelve
6 Million Five Hundred Thousand Dollars (\$12,500,000.00) for the
7 purpose of establishing the National Guard Educational Assistance
8 Fund.

9 SECTION 3. From the funds appropriated to the Oklahoma State
10 Regents for Higher Education in Enrolled House Bill No. 1004 of the
11 1st Extraordinary Session of the 59th Oklahoma Legislature, the
12 Oklahoma State Regents for Higher Education are authorized to expend
13 during the fiscal year ending June 30, 2024, the sum of Forty-eight
14 Million Nine Hundred Eight Thousand Two Hundred Sixteen Dollars
15 (\$48,908,216.00) for the purpose of faculty pay raises.

16 SECTION 4. From the funds appropriated to the Oklahoma State
17 Regents for Higher Education in Enrolled House Bill No. 1004 of the
18 1st Extraordinary Session of the 59th Oklahoma Legislature, the
19 Oklahoma State Regents for Higher Education are authorized to expend
20 during the fiscal year ending June 30, 2024, the sum of Twenty
21 Million Dollars (\$20,000,000.00) for the purpose of expanding
22 engineering programs. Such funds shall be used to supplement rather
23 than replace existing resources and programs.

1 SECTION 5. From the funds appropriated to the Oklahoma State
2 Regents for Higher Education in Enrolled House Bill No. 1004 of the
3 1st Extraordinary Session of the 59th Oklahoma Legislature, the
4 Oklahoma State Regents for Higher Education are authorized to expend
5 during the fiscal year ending June 30, 2024, the sum of Five Million
6 Dollars (\$5,000,000.00) for the purpose of application-based health
7 care.

8 SECTION 6. From the funds appropriated to the Oklahoma State
9 Regents for Higher Education in Enrolled House Bill No. 1004 of the
10 1st Extraordinary Session of the 59th Oklahoma Legislature, the
11 Oklahoma State Regents for Higher Education are authorized to expend
12 during the fiscal year ending June 30, 2024, the sum of Twelve
13 Million Five Hundred Thousand Dollars (\$12,500,000.00) for the
14 purpose of developing critical workforce development initiatives.

15 SECTION 7. From the funds appropriated to the Oklahoma State
16 Regents for Higher Education in Enrolled House Bill No. 1004 of the
17 1st Extraordinary Session of the 59th Oklahoma Legislature, the
18 Oklahoma State Regents for Higher Education are authorized to expend
19 during the fiscal year ending June 30, 2024, the sum of Twelve
20 Million Five Hundred Thousand Dollars (\$12,500,000.00) for the
21 purpose of ensuring student success and institutional excellence.

22 SECTION 8. From the funds appropriated to the Oklahoma State
23 Regents for Higher Education in Enrolled House Bill No. 1004 of the
24 1st Extraordinary Session of the 59th Oklahoma Legislature, the

1 Oklahoma State Regents for Higher Education are authorized to expend
2 during the fiscal year ending June 30, 2024, the sum of Two Hundred
3 Thousand Dollars (\$200,000.00) for the purpose of establishing a
4 food pantry.
