14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. There is hereby appropriated to the Department of
16	Mental Health and Substance Abuse Services from any monies not
17	otherwise appropriated from the General Revenue Fund of the State
18	Treasury for the fiscal year ending June 30, 2018, the sum of One
19	Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be
20	necessary to perform the duties imposed upon the Department of
21	Mental Health and Substance Abuse Services by law.
22	SECTION 2. Appropriations made by this act, not including
23	appropriations made for capital outlay purposes, may be budgeted for
24	the fiscal year ending June 30, 2018 (hereafter FY-18), or may be

    Funds budgeted for FY-18 may be encumbered only through June 30,

    2018, and must be expended by November 15, 2018. Any funds

    lapse to the credit of the proper fund for the then current fiscal
    year. Funds budgeted for FY-19 may be encumbered only through June

    These appropriations may not be budgeted in both fiscal years
