16	SECTION 1. There is hereby appropriated to the Office of
17	Juvenile Affairs from any monies not otherwise appropriated from the
18	General Revenue Fund of the State Treasury for the fiscal year
19	ending June 30, 2018, the sum of One Hundred Thousand Dollars
20	(\$100,000.00) or so much thereof as may be necessary to perform the
21	duties imposed upon the Office of Juvenile Affairs by law.
22	SECTION 2. Appropriations made by this act, not including
23	appropriations made for capital outlay purposes, may be budgeted for
24	the fiscal year ending June 30, 2018 (hereafter FY-18), or may be

    Funds budgeted for FY-18 may be encumbered only through June 30,

    2018, and must be expended by November 15, 2018. Any funds

    lapse to the credit of the proper fund for the then current fiscal
    year. Funds budgeted for FY-19 may be encumbered only through June
