6 An Act relating to Oklahoma Public Employees  
7 Retirement System; amending 74 O.S. 2021, Section  
8 917, which relates to payment of vested benefits;  
9 updating statutory language; making language gender  
10 neutral; providing that payment under certain  
11 circumstances shall not reinstate membership in  
12 System; and providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 74 O.S. 2021, Section 917, is  
15 amended to read as follows:

16 Section 917. (1) Upon termination of employment with a  
17 participating employer, not followed by employment with such  
18 participating employer, or another participating employer, within  
19 four (4) calendar months, the member shall be paid an amount equal  
20 to the amount of money he or she has paid into the System upon the  
21 filing of the proper application with the System. Payment of these  
22 accumulated contributions may be made in less than four (4) calendar  
23 months only in the event that a member is not eligible to elect a  
24 vested benefit pursuant to this section and ~~said~~ the member is

1 terminally ill, as evidenced by a physician's certification that the  
2 member is not expected to live beyond four (4) months.

3 (2) If such member has completed eight (8) years of credited  
4 service at date of termination or if the member is a legislative  
5 session employee of the Legislature or if the employee is a session  
6 employee employed by the Legislative Service Bureau, four (4) years  
7 of credited service at date of termination, he or she may elect a  
8 vested benefit in lieu of receiving his or her accumulated  
9 contributions. The amount of the vested benefit shall commence at  
10 the normal retirement date and shall be paid monthly during the  
11 lifetime of the retirant with the last payment made on the last day  
12 of the month in which death occurs.

13 (3) Upon death before the normal or early retirement date of a  
14 member who has elected a vested benefit, his or her accumulated  
15 contributions shall be paid to his or her beneficiary unless the  
16 spouse of the deceased member elects monthly benefits as provided  
17 for in Section 918 of this title.

18 (4) Upon death after the normal or early retirement date of a  
19 retirant who elected a vested benefit without an option, the excess,  
20 if any, of his or her accumulated contributions over the sum of all  
21 payments of the vested benefit made to date of death shall be paid  
22 to his or her beneficiary.

23 (5) If a former employee, who meets the eligibility  
24 requirements for membership, returns to employment after the

1 expiration of four (4) calendar months following the termination of  
2 his or her employment and the employee has withdrawn his or her  
3 accumulated contributions, he or she may pay to the System the sum  
4 of the accumulated contributions he or she has withdrawn plus  
5 interest of not to exceed ten percent (10%), as determined by the  
6 Board, and shall receive the same benefits as if he or she had never  
7 withdrawn his or her contributions. No member shall be permitted to  
8 take advantage of the payback for restoration of creditable service  
9 more than one time. If a member, who has elected a vested benefit,  
10 or a reemployed member, who has not withdrawn the member's  
11 contributions, again becomes an employee of a participating  
12 employer, the period of absence shall not be counted as a break in  
13 service; however, the period of absence shall not be credited.

14 (6) Prior to January 1, 1991, members, who at the time of  
15 employment were ineligible for membership into the System due to  
16 their age, shall receive benefits for the period of ineligibility if  
17 the employer and employee contributions are paid to the System for  
18 that ineligible period. No interest shall be paid on a payback of  
19 this type. However, effective January 1, 1991, to receive benefits,  
20 the member shall pay the amount determined by the Board pursuant to  
21 Section 913.5 of this title.

22 (7) When any error in calculation or participation coverage to  
23 a prior or current employee exists, it shall be the responsibility  
24 of the participating employer which made the error to pay the amount

1 determined by the Board pursuant to Section 913.5 of this title.  
2 This obligation of the participating employer to pay the amount due  
3 pursuant to this section shall be considered a current obligation of  
4 the employer until the amount is paid in full, regardless of the  
5 dates of the periods of service. Payment made pursuant to this  
6 paragraph shall not reinstate the membership of a former member of  
7 the system who withdrew his or her employee contributions pursuant  
8 to paragraph (1) of this section.

9 (8) Upon application to the Board and payment as determined by  
10 the Board, a member of the System may receive service credit for  
11 those years of service that the member was eligible to receive  
12 service credit from the Teachers' Retirement System of Oklahoma. To  
13 receive the service credit, the member shall pay the amount  
14 determined by the Board pursuant to Section 913.5 of this title.

15 (9) Upon the death of a retired member, the benefit payment for  
16 the month in which the retired member died, if not previously paid,  
17 shall be made to the beneficiary of the member or to the member's  
18 estate if there is no beneficiary. Such benefit payment shall be  
19 made in an amount equal to a full monthly benefit payment regardless  
20 of the day of the month in which the retired member died.

21 (10) Subject to the provisions of Sections 918 and 918.1 of  
22 this title, if there are two or more beneficiaries designated by the  
23 member, upon the member's death, the System shall pay any applicable  
24 benefits to any of the beneficiaries that have completed all

1 required paperwork regardless of whether or not all beneficiaries  
2 have completed such paperwork.

3 SECTION 2. This act shall become effective November 1, 2023.
