7 An Act relating to state government; amending 74 O.S.  
8 2011, Section 324.20b, as amended by Section 848,  
9 Chapter 304, O.S.L. 2012 (74 O.S. Supp. 2018, Section  
10 324.20b), which relates to the State Fire Marshal;  
11 removing certain limit relating to the State Fire  
12 Marshal Revolving Fund; providing an effective date;  
13 and declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 74 O.S. 2011, Section 324.20b, as  
16 amended by Section 848, Chapter 304, O.S.L. 2012 (74 O.S. Supp.  
17 2018, Section 324.20b), is amended to read as follows:

18 Section 324.20b. There is hereby created in the State Treasury  
19 a revolving fund for the State Fire Marshal to be designated the  
20 "State Fire Marshal Revolving Fund". The fund shall be a continuing  
21 fund, not subject to fiscal year limitations, and shall consist of  
22 monies received from the sale of surplus property, fees and receipts  
23 collected pursuant to the Oklahoma Open Records Act, fines,  
24 forfeitures, fees, charges, receipts, donations, gifts, bequests,  
contributions, devises, interagency reimbursements, federal funds

1 unless otherwise provided by federal law or regulation, or any other  
2 source. ~~The fund shall consist of no more than Five Hundred Fifty~~  
3 ~~Thousand Dollars (\$550,000.00).~~ All monies accruing to the credit  
4 of the fund are hereby appropriated and may be budgeted and expended  
5 by the State Fire Marshal for authorized purposes. Expenditures  
6 from the fund shall be made upon warrants issued by the State  
7 Treasurer against claims filed as prescribed by law with the  
8 Director of the Office of Management and Enterprise Services for  
9 approval and payment.

10 SECTION 2. This act shall become effective July 1, 2019.

11 SECTION 3. It being immediately necessary for the preservation  
12 of the public peace, health or safety, an emergency is hereby  
13 declared to exist, by reason whereof this act shall take effect and  
14 be in full force from and after its passage and approval.
