emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law not to be

20 codified in the Oklahoma Statutes reads as follows:

21 There is hereby appropriated to the State Public Common School
22 Building Equalization Fund created in Section 32 of Article X of the
23 Oklahoma Constitution, from any monies not otherwise appropriated
24 from the Oklahoma Medical Marijuana Authority Revolving Fund (Fund

1 248) of the State Treasury, the sum of Forty-four Million One
2 Hundred Fifteen Thousand Five Hundred Three Dollars (\$44,115,503.00)
3 or so much thereof as may be necessary for the disbursement of
4 redbud school grants by the State Board of Education pursuant to
5 Section 3-104 Title 70 of the Oklahoma Statutes.

6 SECTION 2. It being immediately necessary for the preservation
7 of the public peace, health or safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval."
