7 An Act relating to the Department of Human Services;
8 amending 10 O.S. 2011, Section 405.3, as amended by
9 Section 8, Chapter 308, O.S.L. 2013 (10 O.S. Supp.
10 2014, Section 405.3), which relates to the Online
11 Child Care Restricted Registry; clarifying language;
12 modifying grounds for placement on registry to
13 include certain persons; providing certain
14 construction; and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 10 O.S. 2011, Section 405.3, as
17 amended by Section 8, Chapter 308, O.S.L. 2013 (10 O.S. Supp. 2014,
18 Section 405.3), is amended to read as follows:

19 Section 405.3. A. On or before July 1, 2010, the Department of
20 Human Services shall promulgate rules to establish and maintain the
21 Child Care Restricted Registry, accessible to the public through an
22 online database, to address:

23 1. A procedure for recording individuals on the restricted
24 registry resulting from:

- 25 a. a substantiated finding of abuse or neglect, as
26 defined in Section 1-1-105 of Title 10A of the

1 Oklahoma Statutes, by an individual when the abuse or
2 neglect occurred to children while in the care of a
3 child care facility licensed by the Department or by
4 an adult in a family child care home when the adult's
5 presence is incidental to the operation of the family
6 child care home,

7 b. a revocation or denial of a child care facility
8 license, and

9 c. a specified criminal history of an individual, as
10 defined by rules promulgated by the Department;

11 2. A procedure to provide notice and an opportunity for review
12 prior to recording an individual on the restricted registry;

13 3. Disclosure requirements for information on the restricted
14 registry; and

15 4. A procedure to prohibit licensure, ownership, employment,
16 unsupervised access to children, or residence in a child care
17 facility licensed by the Department of individuals recorded on the
18 restricted registry.

19 B. The Child Care Restricted Registry shall include, but not be
20 limited to:

21 1. The full name of the individual;

22 2. Information necessary to identify the individual; and

23 3. The date the individual was recorded on the restricted
24 registry.

1 C. Nothing in this section shall be construed as to permit the
2 placement of an operator of a child care facility on the Child Care
3 Restricted Registry unless the operator is the subject of a
4 substantiated finding of child abuse or neglect.

5 SECTION 2. This act shall become effective November 1, 2015.
