22 SECTION 1. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 1-208.2 of Title 63, unless  
24 there is created a duplication in numbering, reads as follows:

1        There is hereby created in the State Treasury a revolving fund  
2 for the State Department of Health to be designated the "Sexual  
3 Assault Survivor Services Revolving Fund". The fund shall be a  
4 continuing fund, not subject to fiscal year limitations, and shall  
5 consist of all monies received by the Department from funds provided  
6 by law. All monies accruing to the credit of the fund are hereby  
7 appropriated and may be budgeted and expended by the Department for  
8 the purpose of providing funds to county departments of health,  
9 district departments of health, cooperative departments of health,  
10 community-based rape crisis centers, and certified sexual assault  
11 programs facilitating SANE services for sexual assault nurse  
12 examiners for services provided to sexual assault survivors.  
13 Expenditures from the fund shall be made upon warrants issued by the  
14 State Treasurer against claims filed as prescribed by law with the  
15 Director of the Office of Management and Enterprise Services for  
16 approval and payment.

17        SECTION 2. This act shall become effective July 1, 2023.

18        SECTION 3. It being immediately necessary for the preservation  
19 of the public peace, health or safety, an emergency is hereby  
20 declared to exist, by reason whereof this act shall take effect and  
21 be in full force from and after its passage and approval."
