BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 18 O.S. 2021, Section 803, is  
amended to read as follows:

1 Section 803. A. As used in the Professional Entity Act, unless  
2 the context clearly indicates that a different meaning is intended:

3 1. "Associated act" means the Oklahoma General Corporation Act,  
4 in the case of a corporation; the ~~Oklahoma Revised Uniform Limited~~  
5 ~~Partnership Act~~ Uniform Limited Partnership Act of 2010, in the case  
6 of a limited partnership; or the Oklahoma Limited Liability Company  
7 Act, in the case of a limited liability company;

8 2. "Interest" means a share of stock in a corporation, a  
9 partnership interest in a limited partnership or a membership  
10 interest in a limited liability company;

11 3. "Owner" means a shareholder in the case of a corporation, a  
12 general or limited partner in the case of a limited partnership or a  
13 member in the case of a limited liability company;

14 4. "Manager" means a director or officer in the case of a  
15 corporation, a general partner in the case of a limited partnership  
16 or a manager in the case of a limited liability company;

17 5. "Professional entity" means a domestic or qualified foreign  
18 corporation, limited partnership or limited liability company formed  
19 for the purpose of rendering professional service or formed for the  
20 purpose of owning a professional entity rendering professional  
21 service;

22 6. "Professional service" means the personal service rendered  
23 by:  
24

- 1 a. a physician, surgeon or doctor of medicine pursuant to  
2 a license under Sections 481 through 524 of Title 59  
3 of the Oklahoma Statutes, and any subsequent laws  
4 regulating the practice of medicine,
- 5 b. an osteopathic physician or surgeon pursuant to a  
6 license under Sections 620 through 645 of Title 59 of  
7 the Oklahoma Statutes, and any subsequent laws  
8 regulating the practice of osteopathy,
- 9 c. a chiropractic physician pursuant to a license under  
10 Sections 161.1 through 161.20 of Title 59 of the  
11 Oklahoma Statutes, and any subsequent laws regulating  
12 the practice of chiropractic,
- 13 d. a podiatric physician pursuant to a license under  
14 Sections 135.1 through 160.2 of Title 59 of the  
15 Oklahoma Statutes, and any subsequent laws regulating  
16 the practice of podiatric medicine,
- 17 e. an optometrist pursuant to a license under Sections  
18 581 through 606 of Title 59 of the Oklahoma Statutes,  
19 and any subsequent laws regulating the practice of

18 are combined for professional entity purposes as follows:

19 a. any combination of the following professionals:

20 (1) a physician, surgeon or doctor of medicine  
21 pursuant to a license under Sections 481 through  
22 524 of Title 59 of the Oklahoma Statutes, and any  
23 subsequent laws regulating the practice of  
24 medicine,

- 1 (2) an osteopathic physician or surgeon pursuant to a  
2 license under Sections 620 through 645 of Title  
3 59 of the Oklahoma Statutes, and any subsequent  
4 laws relating to the practice of osteopathy,
- 5 (3) a dentist pursuant to a license under Sections  
6 328.1 through 328.53 of Title 59 of the Oklahoma  
7 Statutes, and any subsequent laws regulating the  
8 practice of dentistry,
- 9 (4) a chiropractic physician pursuant to a license  
10 under Sections 161.1 through 161.20 of Title 59  
11 of the Oklahoma Statutes, and any subsequent laws  
12 regulating the practice of chiropractic,
- 13 (5) a psychologist pursuant to a license under  
14 Sections 1351 through 1376 of Title 59 of the  
15 Oklahoma Statutes, and any subsequent laws

9 b. any combination of the following professions:

10 (1) an architect pursuant to a license under Sections  
11 46.1 through 46.41 of Title 59 of the Oklahoma  
12 Statutes, and any subsequent laws regulating the  
13 practice of architecture,

14 (2) a professional engineer pursuant to a license  
15 under Sections 475.1 through 475.22a of Title 59  
16 of the Oklahoma Statutes, and any subsequent laws  
17 relating to the practice of engineering, or

18 (3) a land surveyor pursuant to a license under  
19 Sections 475.1 through 475.22a of Title 59 of the  
20 Oklahoma Statutes, and any subsequent laws  
21 relating to the practice of land surveying;

22 8. "Regulating board" means the board which is charged with the  
23 licensing and regulation of the practice of the profession which the  
24 professional entity is organized to render;

1           9. "Individual", "incorporator" and "shareholder" each include  
2 the trustee of an express trust created by a person duly licensed or  
3 otherwise permitted to render a professional service who has the  
4 right to revoke the trust and who is serving as the trustee of the  
5 trust. Any certificate required by the Professional Entity Act to  
6 be issued to an individual incorporator or shareholder may be issued  
7 to the grantor on behalf of a trust. All references in the  
8 Professional Entity Act to death and incapacity of a shareholder  
9 shall include the death and incapacity of the grantor of a trust  
10 which own stock in a professional corporation;

11           10. "Incapacity" of a shareholder means a determination by a  
12 court of competent jurisdiction, or otherwise by two independent  
13 licensed physicians, that the shareholder is fully incapacitated or  
14 is partially incapacitated to the extent that the shareholder is not  
15 capable of rendering the professional service for which the  
16 professional corporation was organized; and

17           11. "Other personal representative" includes the successor  
18 trustee of an express trust owning stock in a professional  
19 corporation, which trust was created by a person duly licensed or  
20 otherwise permitted to render the professional service for which the  
21 professional corporation was organized who has the right to revoke  
22 the trust and who is the original trustee of the trust.

1 B. The definitions of the applicable associated act shall apply  
2 to the Professional Entity Act, unless the context clearly indicates  
3 that a different meaning is intended.

4 SECTION 2. AMENDATORY 18 O.S. 2021, Section 804, is  
5 amended to read as follows:

6 Section 804. A professional entity may be formed or qualified  
7 to render professional services by filing the appropriate instrument  
8 required by the associated act with the Secretary of State. The  
9 individual or individuals forming ~~the~~ a domestic professional entity  
10 or qualifying a foreign professional entity shall be managers of the  
11 professional entity and duly licensed or otherwise permitted in  
12 accordance with the provisions of this state's licensing laws for  
13 the profession and in good standing within the profession to be  
14 practiced through the professional entity. Such instrument shall  
15 meet the requirements of the applicable associated act, shall  
16 contain the profession or related professions to be practiced  
17 through the professional entity, and shall ~~also~~ contain one of the  
18 following:

19 1. ~~The profession or related professions to be practiced~~  
20 ~~through the professional entity; and~~

21 2. A certificate by the regulating board of the profession or  
22 related professions involved that each of the persons who ~~are to~~  
23 will become owners or managers of the domestic professional entity  
24 and who ~~are to~~ will engage in the practice of the profession or

1 related profession in this state is duly licensed or otherwise  
2 permitted in accordance with the provisions of this state's  
3 licensing laws for the profession or related profession to practice  
4 such profession; or

5 2. A certificate by the regulating board of the profession or  
6 related professions involved that the persons who will become the  
7 managers of the foreign professional entity and who will be  
8 responsible for the practice of the profession or related profession  
9 in this state are duly licensed or otherwise permitted in accordance  
10 with the provisions of this state's licensing laws for the  
11 profession or related profession to practice such profession.

12 SECTION 3. AMENDATORY 18 O.S. 2021, Section 807, is  
13 amended to read as follows:

14 Section 807. The name of every domestic professional entity  
15 shall end with one or more of the words or abbreviations permitted  
16 in the applicable associated acts; provided, that such words or  
17 abbreviations shall be modified by the word "professional" or some  
18 abbreviation of the combination, with or without punctuation,  
19 including, without limitation: "P.C.", "P.L.P." or "P.L.L.C.".

20 Provided further, each of the regulating boards may by rule adopt  
21 further requirements as to the names of professional entities  
22 organized to render professional services within the jurisdiction of  
23 such regulating board.

1 SECTION 4. AMENDATORY 18 O.S. 2021, Section 808, is  
2 amended to read as follows:

3 Section 808. The principal office of the professional business  
4 entity shall be designated by street address in the formation or  
5 qualification instrument and shall not be changed without amendment  
6 of the formation or qualification instrument.

7 SECTION 5. AMENDATORY 18 O.S. 2021, Section 809, is  
8 amended to read as follows:

9 Section 809. Except as provided in Section 815 of this title,  
10 no person shall hold an interest in a domestic professional entity  
11 including a domestic professional entity that owns a domestic  
12 professional entity rendering professional service who is not duly  
13 licensed or otherwise permitted in accordance with the provisions of  
14 this state's licensing laws for the profession or related profession  
15 to render the same professional services or related professional  
16 services as those for which the entity is organized. No person  
17 shall be a shareholder of a professional corporation who is not duly  
18 licensed or otherwise permitted to render the same professional  
19 services or related professional services as the services for which  
20 the corporation is organized. An owner of a qualified foreign  
21 professional entity need not be duly licensed if he or she is not  
22 rendering professional services in this state.

23 SECTION 6. AMENDATORY 18 O.S. 2021, Section 810, is  
24 amended to read as follows:

1       Section 810. ~~No person may be a~~ Every manager of a domestic  
2 professional entity ~~who is not a person~~ responsible for the  
3 professional services or related professional services rendered by  
4 the professional entity in this state shall be duly licensed or  
5 otherwise permitted in accordance with the provisions of this  
6 state's licensing laws for the profession or related profession to  
7 render the same professional services or related professional  
8 services as those for which the entity is formed. ~~No person may be~~  
9 ~~a shareholder of a professional corporation who is not an individual~~  
10 Every manager of a foreign professional entity responsible for the  
11 professional services or related professional services rendered by  
12 the professional entity in this state shall be duly licensed or  
13 otherwise permitted in accordance with the provisions of this  
14 state's licensing laws for the profession or related profession to  
15 render the same professional services or related professional  
16 services as those for which the ~~corporation~~ entity is ~~organized~~  
17 formed.

18       SECTION 7.       AMENDATORY       18 O.S. 2021, Section 811, is  
19 amended to read as follows:

20       Section 811. A domestic professional entity may render  
21 professional services in this state only through its owners,  
22 managers, employees and agents who are duly licensed or otherwise  
23 permitted in accordance with the provisions of this state's  
24 licensing laws to render professional services; ~~provided, however,~~



1 ~~this provision.~~ A foreign professional entity may render  
2 professional services in this state only through its owners,  
3 managers, employees, and agents who are duly licensed or otherwise  
4 permitted in accordance with the provisions of this state's  
5 licensing laws to render professional services in this state. The  
6 provisions of this section shall not be interpreted to include in  
7 the term "employee", as used herein, clerks, secretaries,  
8 bookkeepers, technicians and other assistants who are not usually  
9 and ordinarily considered by custom and practice to be rendering  
10 professional services to the public for which a license is required.

11 SECTION 8. AMENDATORY 18 O.S. 2021, Section 815, is  
12 amended to read as follows:

13 Section 815. A. 1. If the domestic professional entity is a  
14 corporation, the certificate of incorporation, bylaws or other  
15 agreement may provide for the purchase or redemption of the shares  
16 of any shareholder upon the death, incapacity, disqualification or  
17 ending of employment of such shareholder. In the absence of a  
18 provision in the certificate of incorporation, or the bylaws, or  
19 other agreement, the domestic professional corporation shall  
20 purchase the shares of a deceased shareholder, a shareholder who is  
21 incapacitated or who is no longer qualified to own shares in such  
22 corporation or a shareholder whose employment has ended, within  
23 ninety (90) days after such shareholder's death, incapacity ~~or,~~  
24 disqualification or ending of employment, as the case may be.

1           2. The price for such shares shall be the book value as of the  
2 end of the month immediately preceding such shareholder's death,  
3 incapacity, disqualification or ending of employment of the  
4 shareholder. Book value shall be determined from the books and  
5 records of the domestic professional corporation in accordance with  
6 the regular method of accounting used by the corporation. If the  
7 corporation shall fail to purchase the shares by the end of the  
8 ninety day period, then the executor or administrator or other  
9 personal representative of the deceased, incapacitated or  
10 disqualified shareholder may bring an action in the district court  
11 of the county in which the principal office or place of practice of  
12 the domestic professional corporation is located for the enforcement  
13 of this provision. If the plaintiff is successful in such action,  
14 he or she shall be entitled to recover the book value of the shares  
15 involved, a reasonable attorney's fee and costs. The domestic  
16 professional corporation shall repurchase such shares without regard  
17 to restrictions upon the repurchase of shares provided for in the  
18 Oklahoma General Corporation Act.

19           3. If there is only one shareholder of a domestic professional  
20 corporation, and the shareholder dies or becomes incapacitated, the  
21 executor or administrator or other personal representative of the  
22 shareholder shall have the authority to sell the shares of capital  
23 stock owned by the shareholder to a qualified purchaser, or to cause  
24 a dissolution of the domestic professional corporation as provided

1 by law. The vesting of ownership of shares of stock in a domestic  
2 professional corporation in the executor or administrator or other  
3 personal representative shall be solely for the purposes set forth  
4 above and shall not be deemed to contravene any other provisions of  
5 ~~this act~~ Section 801 et seq. of this title.

6 B. If the domestic professional entity is a limited partnership  
7 or a limited liability company, an owner's disqualification shall be  
8 deemed a withdrawal, and the domestic professional entity shall  
9 respond to the disqualification as it would any other withdrawal.

10 SECTION 9. AMENDATORY 18 O.S. 2021, Section 1004.1, is  
11 amended to read as follows:

12 Section 1004.1.

13 APPLICATION OF ACT TO NONSTOCK CORPORATIONS

14 A. Except as otherwise provided in subsections B and C of this  
15 section, the provisions of this chapter shall apply to nonstock  
16 corporations in the manner specified in paragraphs 1 through 4 of  
17 this subsection:

18 1. All references to shareholders of the corporation shall be  
19 deemed to refer to members of the corporation;

20 2. All references to the board of directors of the corporation  
21 shall be deemed to refer to the governing body of the corporation;

22 3. All references to directors or to members of the board of  
23 directors of the corporation shall be deemed to refer to members of  
24 the governing body of the corporation; and

1 4. All references to stock, capital stock, or shares thereof of  
2 a corporation authorized to issue capital stock shall be deemed to  
3 refer to memberships of a nonprofit nonstock corporation and to  
4 membership interests of any other nonstock corporation.

5 B. Subsection A of this section shall not apply to:

6 1. This subsection or to paragraph 4 of subsection A and  
7 paragraphs 1 and 2 of subsection B of Section 1006, subsection A of  
8 Section 1013, Sections 1027, 1035, 1060 and 1073, subsection B of

24 ~~Statutes~~ this title.

1 D. For purposes of the Oklahoma General Corporation Act:

2 1. A "charitable nonstock corporation" is any nonprofit  
3 nonstock corporation that is exempt from taxation under Section  
4 ~~501(e)(3)~~ 501(c)(3) of the United States Internal Revenue Code ~~†26~~  
5 ~~U.S.C. Section 501(e)(3)†~~, 26 U.S.C. Section 501(c)(3), or any  
6 successor provisions;

7 2. A "membership interest" is, unless otherwise provided in a  
8 nonstock corporation's certificate of incorporation, a member's  
9 share of the profits and losses of a nonstock corporation, or a  
10 member's right to receive distributions of the nonstock  
11 corporation's assets, or both;

12 3. A "nonprofit nonstock corporation" is a nonstock corporation  
13 that does not have membership interests;

14 4. A "nonstock corporation" is any corporation organized under  
15 ~~this act~~ the Oklahoma General Corporation Act that is not authorized  
16 to issue capital stock; and

17 5. The terms "not-for-profit" and "nonprofit" are synonymous.

21 CERTIFICATE OF INCORPORATION; CONTENTS

22 A. The certificate of incorporation shall set forth:

23 1. The name of the corporation which shall contain one of the  
24 words "association", "company", "corporation", "club", "foundation",

1 "fund", "incorporated", "institute", "society", "union",  
2 "syndicate", or "limited" or abbreviations thereof, with or without  
3 punctuation, or words or abbreviations thereof, with or without  
4 punctuation, of like import of foreign countries or jurisdictions;  
5 provided that such abbreviations are written in Roman characters or  
6 letters, and which shall be such as to distinguish it upon the  
7 records in the Office of the Secretary of State from:

- 8 a. names of other corporations, whether domestic or  
9 foreign, then existing or which existed at any time  
10 during the preceding three (3) years,
- 11 b. names of partnerships whether general or limited, or  
12 domestic or foreign, then in good standing or  
13 registered or which were in good standing or  
14 registered at any time during the preceding three (3)  
15 years,
- 16 c. names of limited liability companies, whether domestic  
17 or foreign, then in good standing or registered or  
18 which were in good standing or registered at any time  
19 during the preceding three (3) years,
- 20 d. trade names or fictitious names filed with the  
21 Secretary of State, or
- 22 e. corporate, limited liability company or limited  
23 partnership names reserved with the Secretary of  
24 State;

1        2. The address, including the street, number, city and postal  
2 code, of the corporation's registered office in this state, and the  
3 name of the corporation's registered agent at such address;

4        3. The nature of the business or purposes to be conducted or  
5 promoted. It shall be sufficient to state, either alone or with  
6 other businesses or purposes, that the purpose of the corporation is  
7 to engage in any lawful act or activity for which corporations may  
8 be organized under the general corporation law of ~~Oklahoma~~ this  
9 state, and by such statement all lawful acts and activities shall be  
10 within the purposes of the corporation, except for express  
11 limitations, if any;

12        4. If the corporation is to be authorized to issue only one  
13 class of stock, the total number of shares of stock which the  
14 corporation shall have authority to issue and the par value of each  
15 of such shares, or a statement that all such shares are to be  
16 without par value. If the corporation is to be authorized to issue  
17 more than one class of stock, the certificate of incorporation shall  
18 set forth the total number of shares of all classes of stock which  
19 the corporation shall have authority to issue and the number of  
20 shares of each class, and shall specify each class the shares of  
21 which are to be without par value and each class the shares of which  
22 are to have par value and the par value of the shares of each such  
23 class. The provisions of this paragraph shall not apply to  
24 corporations which are not organized for profit and which are not to

1 have authority to issue capital stock. In the case of such  
2 corporations, the fact that they are not to have authority to issue  
3 capital stock shall be stated in the certificate of incorporation.  
4 The provisions of this paragraph shall not apply to nonstock  
5 corporations. In the case of nonstock corporations, the fact that  
6 they are not authorized to issue capital stock shall be stated in  
7 the certificate of incorporation. The conditions of membership, or  
8 other criteria for identifying members, of nonstock corporations  
9 shall likewise be stated in the certificate of incorporation or the  
10 bylaws. Nonstock corporations shall have members, but the failure  
11 to have members shall not affect otherwise valid corporate acts or  
12 work a forfeiture or dissolution of the corporation. Nonstock  
13 corporations may provide for classes or groups of members having  
14 relative rights, powers and duties, and may make provision for the  
15 future creation of additional classes or groups of members having  
16 such relative rights, powers and duties as may from time to time be  
17 established, including rights, powers and duties senior to existing  
18 classes and groups of members. Except as otherwise provided in the  
19 Oklahoma General Corporation Act, nonstock corporations may also

18 names and mailing addresses of the persons who are to serve as  
19 directors until the first annual meeting of shareholders or until  
20 their successors are elected and qualify;

21 7. If the corporation is not for profit:

22 a. that the corporation does not afford pecuniary gain,  
23 incidentally or otherwise, to its members as such,  
24

- 1           b. the name and mailing address of each member of the  
2           governing body,  
3           c. the number of members of the governing body to be  
4           elected at the first meeting, and  
5           d. in the event the corporation is a church, the street  
6           address of the location of the church.

7           The restriction on affording pecuniary gain to members shall not  
8 prevent a not-for-profit corporation operating as a cooperative from  
9 rebating excess revenues to patrons who may also be members; and

10          8. If the corporation is a charitable nonstock and does not  
11 otherwise provide in its certificate of incorporation:

- 12           a. that the corporation is organized exclusively for  
13           charitable, religious, educational, and scientific  
14           purposes including, for such purposes, the making of  
15           distributions to organizations that qualify as exempt  
16           organizations under ~~section~~ Section 501(c)(3) of the  
17           Internal Revenue Code, or the corresponding section of  
18           any future federal tax code,  
19           b. that upon the dissolution of the corporation, its  
20           assets shall be distributed for one or more exempt  
21           purposes within the meaning of ~~section~~ Section  
22           501(c)(3) of the Internal Revenue Code, or the  
23           corresponding section of any future federal tax code,  
24           for a public purpose, and

1           c.    that the corporation complies with the requirements in  
2                    paragraph 7 of this subsection.

6 also contain any or all of the following matters:

14 in dissolution or of any receiver or receivers

13          convertible into such stock. No shareholder shall have any

17          certificate of incorporation. Preemptive rights, if granted, shall  
18          not extend to fractional shares;

19          4. Provisions requiring, for any corporate action, the vote of  
20          a larger portion of the stock or of any class or series thereof, or  
21          of any other securities having voting power, or a larger number of  
22          the directors, than is required by the provisions of the Oklahoma

1 5. A provision limiting the duration of the corporation's  
2 existence to a specified date; otherwise, the corporation shall have  
3 perpetual existence;

4 6. A provision imposing personal liability for the debts of the  
5 corporation on its shareholders to a specified extent and upon  
6 specified conditions; otherwise, the shareholders of a corporation  
7 shall not be personally liable for the payment of the corporation's  
8 debts, except as they may be liable by reason of their own conduct  
9 or acts; or

10 7. A provision eliminating or limiting the personal liability  
11 of a director or officer to the corporation or its shareholders for  
12 monetary damages for breach of fiduciary duty as a director or  
13 officer, provided that such provision shall not eliminate or limit  
14 the liability of ~~a director~~:

- 15 a. a director or officer for any breach of the director's  
16 or officer's duty of loyalty to the corporation or its  
17 shareholders,  
18 b. a director or officer for acts or omissions not in  
19 good faith or which involve intentional misconduct or  
20 a knowing violation of law,  
21 c. a director under Section 1053 of this title, ~~or~~  
22 d. a director or officer for any transaction from which  
23 the director or officer derived an improper personal  
24 benefit, or

1           e. an officer in any action by or in the right of the  
2                           corporation.

3           No such provision shall eliminate or limit the liability of a  
4 director or officer for any act or omission occurring before the  
5 date when such provision becomes effective. An amendment, repeal,  
6 or elimination of such provision shall not affect its application  
7 with respect to an act or omission by a director or officer  
8 occurring before the amendment, repeal, or elimination of the  
9 provision unless the provision provides otherwise at the time of the  
10 act or omission.

11           Any reference in this subsection to a director shall be deemed  
12 to refer to such other persons who, under a provision of the  
13 certificate of incorporation in accordance with subsection A of  
14 Section 1027 of this title, exercises or performs any of the powers  
15 or duties otherwise conferred or imposed upon the board of directors  
16 under this title.

17           C. It shall not be necessary to set forth in the certificate of  
18 incorporation any of the powers conferred on corporations by the  
19 provisions of the Oklahoma General Corporation Act.

20           D. Except for provisions included under paragraphs 1, 2, 5, 6  
21 and 7 of subsection A of this section and paragraphs 2, 5 and 7 of  
22 subsection B of this section, and provisions included under  
23 paragraph 4 of subsection A of this section specifying the classes,  
24 number of shares and par value of shares a corporation other than a



1 nonstock corporation is authorized to issue, any provision of the  
2 certificate of incorporation may be made dependent upon facts  
3 ascertainable outside the instrument, provided that the manner in  
4 which the facts shall operate upon the provision is clearly and  
5 explicitly set forth therein. As used in this subsection, the term  
6 "facts" includes, but is not limited to, the occurrence of any  
7 event, including a determination or action by any person or body,

15 organization meeting of the incorporator or incorporators, or of the  
16 board of directors if the initial directors were named in the  
17 certificate of incorporation, shall be held either within or without  
18 this state at the call of a majority of the incorporators or  
19 directors, as the case may be, for the purposes of adopting bylaws,  
20 electing directors if the meeting is of the incorporators, to serve  
21 or hold office until the first annual meeting of shareholders or  
22 until their successors are elected and qualify, electing officers if  
23 the meeting is of the directors, doing any other or further acts to

1 perfect the organization of the corporation, and transacting such  
2 other business as may come before the meeting.

3 B. The persons calling the meeting shall give to each other  
4 incorporator or director, as the case may be, at least two (2) days'  
5 notice thereof in writing or by electronic transmission by any usual  
6 means of communication, which notice shall state the time, place and  
7 purposes of the meeting as fixed by the persons calling it. Notice  
8 of the meeting need not be given to anyone who attends the meeting

11 incorporation, any action permitted to be taken at the organization  
12 meeting of the incorporators or directors, as the case may be, may  
13 be taken without a meeting if each incorporator or director, where  
14 there is more than one, or the sole incorporator or director where  
15 there is only one, consents thereto in writing or by electronic  
16 transmission. A consent may be documented, signed, and delivered in  
17 any manner permitted by Section 1014.3 of this title. Any person  
18 whether or not then an incorporator or director may provide, whether

19 EMERGENCY BYLAWS AND OTHER POWERS IN EMERGENCY

20 A. The board of directors of any corporation may adopt  
21 emergency bylaws, subject to repeal or amendment by action of the  
22 shareholders, which, notwithstanding any different provision in the  
23 Oklahoma General Corporation Act, in the certificate of  
24 incorporation, or bylaws, shall be operative during any emergency

1 resulting from an attack on the United States or on a locality in  
2 which the corporation conducts its business or customarily holds  
3 meetings of its board of directors or its shareholders, or during  
4 any nuclear or atomic disaster, or during the existence of any  
5 catastrophe, including but not limited to an epidemic or pandemic  
6 and a declaration of a national emergency by the United States  
7 government, or other similar emergency condition, ~~as a result of~~  
8 ~~which~~ irrespective of whether a quorum of the board of directors or  
9 a standing committee thereof ~~cannot~~ can readily be convened for  
10 action. The emergency bylaws contemplated by this section may be  
11 adopted by the board of directors or, if a quorum cannot be readily  
12 convened for a meeting, by a majority of the directors present. The  
13 emergency bylaws may make any provision that may be practical and  
14 necessary for the circumstances of the emergency, including  
15 provisions that:

16 1. A meeting of the board of directors or a committee thereof  
17 may be called by an officer or director in such manner and under  
18 such conditions as shall be prescribed in the emergency bylaws;

19 2. The director or directors in attendance at the meeting, or  
20 any greater number fixed by the emergency bylaws, shall constitute a  
21 quorum; and

22 3. The officers or other persons designated on a list approved  
23 by the board of directors before the emergency, all in such order of  
24 priority and subject to such conditions and for such period of time,

1 not longer than reasonably necessary after the termination of the  
2 emergency, as may be provided in the emergency bylaws or in the  
3 resolution approving the list, shall, to the extent required to  
4 provide a quorum at any meeting of the board of directors, be deemed  
5 directors for such meeting.

6 B. The board of directors, either before or during any such  
7 emergency, may provide, and from time to time modify, lines of  
8 succession in the event that during such emergency any or all  
9 officers or agents of the corporation shall for any reason be  
10 rendered incapable of discharging their duties.

11 C. The board of directors, either before or during any such  
12 emergency, may, effective in the emergency, change the head office  
13 or designate several alternative head offices or regional offices,  
14 or authorize the officers to do so.

15 D. No officer, director or employee acting in accordance with  
16 any emergency bylaws shall be liable except for willful misconduct.

17 E. To the extent not inconsistent with any emergency bylaws so  
18 adopted, the bylaws of the corporation shall remain in effect during  
19 any emergency and upon its termination the emergency bylaws shall  
20 cease to be operative.

21 F. Unless otherwise provided in emergency bylaws, notice of any  
22 meeting of the board of directors during such an emergency may be  
23 given only to such of the directors as it may be feasible to reach  
24

1 at the time and by such means as may be feasible at the time,  
2 including publication or radio.

3 G. To the extent required to constitute a quorum at any meeting  
4 of the board of directors during such an emergency, the officers of  
5 the corporation who are present shall, unless otherwise provided in  
6 emergency bylaws, be deemed, in order of rank and within the same  
7 rank in order of seniority, directors for such meeting.

8 H. Nothing contained in this section shall be deemed exclusive  
9 of any other provisions for emergency powers consistent with other  
10 sections of ~~this act~~ Section 1001 et seq. of this title which have  
11 been or may be adopted by corporations created pursuant to the  
12 provisions of ~~this act~~ Section 1001 et seq. of this title.

13 I. During any emergency condition of a type described in  
14 subsection A of this section, the board of directors or, if a quorum  
15 cannot be readily convened for a meeting, a majority of the  
16 directors present, may:

17 1. Take any action that it determines to be practical and  
18 necessary to address the circumstances of the emergency condition  
19 with respect to a meeting of shareholders of the corporation,  
20 notwithstanding anything to the contrary in this title or in the  
21 certificate of incorporation or bylaws including, but not limited to:

22 a. to postpone any such meeting to a later time or date  
23 with the record date for determining the shareholders  
24 entitled to notice of, and to vote at, such meeting

1 applying to the postponed meeting irrespective of the  
2 requirements of Section 1058 of this title, and

3 b. with respect to a corporation subject to the reporting  
4 requirements of Section 13 or Section 15(d) of the  
5 Securities Exchange Act of 1934, as amended, and the  
6 rules and regulations promulgated thereunder, to notify  
7 shareholders of any postponement or a change of the  
8 place of the meeting or a change to hold the meeting  
9 solely by means of remote communication solely by a  
10 document publicly filed by the corporation with the  
11 Securities and Exchange Commission under Sections 13,  
12 14, or 15(d) of such act and such rules and  
13 regulations; and

14 2. With respect to any dividend that has been declared as to  
15 which the record date has not occurred, change both the record date  
16 and payment date to a later date or dates if the changed payment date  
17 is not more than sixty (60) days after the changed record date;  
18 provided that, in either case, the corporation shall give notice of  
19 the change to shareholders as soon as practicable thereafter and in  
20 any event before the record date in effect. Such notice, in the case  
21 of a corporation subject to the reporting requirements of Section 13  
22 or Section 15(d) of the Securities Exchange Act of 1934, as amended,  
23 and the rules and regulations promulgated thereunder, may be given  
24 solely by a document publicly filed with the Securities and Exchange

1 Commission under Section 13, Section 14, or Section 15(d) of the  
2 Securities Exchange Act of 1934, as amended, and the rules and  
3 regulations. No person shall be liable, and no meeting of  
4 shareholders shall be postponed or voided, for the failure to make a  
5 shareholders list available under Section 1064 of this title if it  
6 was not practicable to allow inspection during an emergency

11 DOCUMENT FORM, SIGNATURE AND DELIVERY

12 A. Except as provided in subsection B of this section, without

16 1. Any act or transaction contemplated or governed by this  
17 title or the certificate of incorporation or bylaws may be provided  
18 for in a document, and an electronic transmission shall be deemed  
19 the equivalent of a written document. "Document" means (i) any  
20 tangible medium on which information is inscribed, and includes  
21 handwritten, typed, printed or similar instruments, and copies of  
22 such instruments and (ii) an electronic transmission;

23 2. Whenever ~~this act~~ Section 1001 et seq. of this title or the  
24 certificate of incorporation or bylaws requires or permits a



1 signature, the signature may be a manual, facsimile, conformed or  
2 electronic signature. "Electronic signature" means an electronic

22 threatened, pending, or completed action, suit, or proceeding,  
23 whether civil, criminal, administrative, or investigative, other  
24 than an action by or in the right of the corporation, by reason of



1 the fact that the person is or was a director, officer, employee, or  
2 agent of the corporation, or is or was serving at the request of the  
3 corporation as a director, officer, employee, or agent of another  
4 corporation, partnership, joint venture, trust, or other enterprise,  
5 against expenses, including attorney fees, judgments, fines, and  
6 amounts paid in settlement actually and reasonably incurred by the  
7 person in connection with the action, suit, or proceeding if the  
8 person acted in good faith and in a manner the person reasonably  
9 believed to be in or not opposed to the best interests of the  
10 corporation, and, with respect to any criminal action or proceeding,  
11 had no reasonable cause to believe the conduct was unlawful. The  
12 termination of any action, suit, or proceeding by judgment, order,  
13 settlement, conviction, or upon a plea of nolo contendere or its  
14 equivalent, shall not, of itself, create a presumption that the  
15 person did not act in good faith and in a manner which the person  
16 reasonably believed to be in or not opposed to the best interests of  
17 the corporation, and, with respect to any criminal action or  
18 proceeding, had reasonable cause to believe that the conduct was  
19 unlawful.

20 B. A corporation shall have the power to indemnify any person  
21 who was or is a party or is threatened to be made a party to any  
22 threatened, pending, or completed action or suit by or in the right  
23 of the corporation to procure a judgment in its favor by reason of  
24 the fact that the person is or was a director, officer, employee, or

1 agent of the corporation, or is or was serving at the request of the  
2 corporation as a director, officer, employee, or agent of another  
3 corporation, partnership, joint venture, trust, or other enterprise  
4 against expenses, including attorney fees, actually and reasonably  
5 incurred by the person in connection with the defense or settlement  
6 of an action or suit if the person acted in good faith and in a  
7 manner the person reasonably believed to be in or not opposed to the  
8 best interests of the corporation and except that no indemnification  
9 shall be made in respect of any claim, issue, or matter as to which  
10 the person shall have been adjudged to be liable to the corporation  
11 unless and only to the extent that the court in which the action or  
12 suit was brought shall determine upon application that, despite the  
13 adjudication of liability but in view of all the circumstances of  
14 the case, the person is fairly and reasonably entitled to indemnity  
15 for expenses which the court shall deem proper.

16 C. 1. To the extent that a present or former director or  
17 officer of a corporation has been successful on the merits or  
18 otherwise in defense of any action, suit, or proceeding referred to  
19 in subsection A or B of this section, or in defense of any claim,  
20 issue, or matter therein, the person shall be indemnified against  
21 expenses, including attorney fees, actually and reasonably incurred  
22 by the person in connection therewith.

23 2. The corporation may indemnify any other person who is not a  
24 present or former director or officer of the corporation against

1 expenses including attorney fees actually and reasonably incurred by  
2 the person to the extent he or she has been successful on the merits  
3 or otherwise in defense of any action, suit, or proceeding referred  
4 to in subsections A and B of this section, or in defense of any  
5 claim, issue, or matter therein.

6 D. Any indemnification under the provisions of subsection A or  
7 B of this section, unless ordered by a court, shall be made by the  
8 corporation only as authorized in the specific case upon a  
9 determination that indemnification of the present or former director  
10 or officer is proper in the circumstances because the person has met  
11 the applicable standard of conduct set forth in subsection A or B of  
12 this section. This determination shall be made, with respect to a  
13 person who is a director or officer of the corporation at the time  
14 of the determination:

15 1. By a majority vote of the directors who are not parties to  
16 the action, suit, or proceeding, even though less than a quorum;

17 2. By a committee of directors designated by a majority vote of  
18 directors, even though less than a quorum;

22 E. Expenses including attorney fees incurred by an officer or

3 director or officer to repay the amount if it shall ultimately be  
4 determined that the person is not entitled to be indemnified by the

6 Expenses including attorney fees incurred by former directors or  
7 officers or other employees and agents or persons serving at the  
8 request of the corporation as directors, officers, employees or  
9 agents of another corporation, partnership, joint venture, trust or  
10 other enterprise may be paid upon the terms and conditions, if any,  
11 as the corporation deems appropriate.

12 F. The indemnification and advancement of expenses provided by  
13 or granted pursuant to the other subsections of this section shall  
14 not be deemed exclusive of any other rights to which those seeking  
15 indemnification or advancement of expenses may be entitled under any  
16 bylaw, agreement, vote of shareholders or disinterested directors,  
17 or otherwise, both as to action in the person's official capacity

8                   MERGER OR CONSOLIDATION OF DOMESTIC CORPORATIONS

9       A. Any two or more domestic corporations may merge into a  
10 single surviving corporation, which may be any one of the

12 corporation formed by the consolidation, pursuant to an agreement of  
13 merger or consolidation, as the case may be, complying and approved  
14 in accordance with the provisions of this section.

5 4. In the case of a consolidation, that the certificate of  
6 incorporation of the resulting corporation shall be as is set forth  
7 in an attachment to the agreement;

8 5. The manner, if any, of converting the shares of each of the  
9 constituent corporations into shares or other securities of the  
10 corporation surviving or resulting from the merger or consolidation,  
11 or of canceling some or all of the shares, and, if any shares of any  
12 of the constituent corporations are not to remain outstanding, to be  
13 converted solely into shares or other securities of the surviving or  
14 resulting corporation or to be canceled, the cash, property, rights,  
15 or securities of any other corporation or entity which the holders  
16 of the shares are to receive in exchange for or upon conversion of

17 twenty (20) days after the date of mailing of such notice, demand in

23 1. The date of filing of the corporation's original certificate  
24 of incorporation; the name under which the corporation was

1 originally incorporated; the name of the corporation at the time its  
2 certificate of incorporation became forfeited or void pursuant to  
3 this title; and the new name under which the corporation is to be  
4 revived to the extent required by subsection F of this section;

5 2. The address of the corporation's registered office in this  
6 state, which shall be stated in accordance with subsection C of  
7 Section 1021 of this title, and the name of its registered agent at  
8 such address;

9 3. That the corporation desiring to be revived and so reviving  
10 its certificate of incorporation was organized pursuant to the laws  
11 of this state;

12 4. The date when the certificate of incorporation became  
13 forfeited or that the validity of any revival has been brought into  
14 question; and

15 5. That the certificate of revival is filed by authority of the  
16 board of directors or members of the governing body of the  
17 corporation as provided for in subsection H of this section.

18 E. Upon the filing of the certificate in accordance with the  
19 provisions of Section 1007 of this title, the corporation shall be  
20 revived with the same force and effect as if its certificate of  
21 incorporation had not become forfeited. Such revival shall validate  
22 all contracts, acts, matters and things made, done and performed  
23 within the scope of its certificate of incorporation by the  
24 corporation, its directors or members of its governing body,

1 officers, agents and shareholders or members during the time when  
2 its certificate of incorporation was forfeited, with the same force  
3 and effect and to all intents and purposes as if the certificate of  
4 incorporation had at all times remained in full force and effect.  
5 All real and personal property, rights and credits, which belonged  
6 to the corporation at the time its certificate of incorporation  
7 became forfeited and which were not disposed of prior to the time of  
8 its revival and all real and personal property, rights and credits  
9 acquired by the corporation after its certificate of incorporation  
10 became forfeited pursuant to this title shall be vested in the  
11 corporation, after its revival, as if its certificate of  
12 incorporation had at all times remained in full force and effect,  
13 and the corporation after its revival shall be as exclusively liable  
14 for all contracts, acts, matters and things made, done or performed  
15 in its name and on its behalf by its directors or members of its  
16 governing body, officers, agents and shareholders or members prior  
17 to its revival, as if its certificate of incorporation had at all  
18 times remained in full force and effect.

19 F. If, after three (3) years from the date upon which the  
20 certificate of incorporation became forfeited for nonpayment of  
21 taxes, the name of the corporation is unavailable upon the records  
22 of the Secretary of State, then in such case the corporation to be  
23 revived shall not be revived under the same name which it bore when  
24 its certificate of incorporation became forfeited, or expired but



1 shall be revived under some other name as set forth in the  
2 certificate to be filed pursuant to subsection C of this section.

3 G. Any corporation that revives its certificate of  
4 incorporation pursuant to the provisions of this section shall pay  
5 to this state the amounts provided in Sections 1201 through 1214 of  
6 Title 68 of the Oklahoma Statutes. No payment made pursuant to this  
7 subsection shall reduce the amount of franchise tax due pursuant to  
8 the provisions of Sections 1201 through 1214 of Title 68 of the  
9 Oklahoma Statutes for the year in which the revival is effected.

10 H. For purposes of this section, the board of directors or  
11 governing body of the corporation shall be comprised of the persons,  
12 who, but for the certificate of incorporation having become  
13 forfeited pursuant to this title, would be the duly elected or  
14 appointed directors or members of the governing body of the  
15 corporation. The requirement for authorization by the board of  
16 directors under subsection C of this section shall be satisfied if a  
17 majority of the directors or members of the governing body then in  
18 office, even though less than a quorum, or the sole director or  
19 member of the governing body then in office, authorizes the revival  
20 of the certificate of incorporation of the corporation and the  
21 filing of the certificate required by subsection C of this section.  
22 In any case where there shall be no directors of the corporation  
23 available to revive the certificate of incorporation of the  
24 corporation, the shareholders may elect a full board of directors,

1 as provided by the bylaws of the corporation, and the board so  
2 elected may then authorize the revival of the certificate of  
3 incorporation of the corporation and the filing of the certificate  
4 required by subsection C of this section. A special meeting of the  
5 shareholders for the purpose of electing directors may be called by  
6 any officer or shareholder upon notice given in accordance with the  
7 provisions of Section 1067 of this title. For purposes of this  
8 section, the bylaws shall be the bylaws of the corporation that, but  
9 for the certificate of incorporation having become forfeited, would  
10 be the duly adopted bylaws of the corporation.

11 I. After a revival of the certificate of incorporation of the  
12 corporation shall have been effected, the provisions of subsection C  
13 of Section 1056 of this title shall govern and the period of time  
14 during which the certificate of incorporation of the corporation was  
15 forfeited shall be included within the calculation of the thirty-day  
16 and thirteen-month periods to which subsection C of Section 1056 of  
17 this title refers. A special meeting of shareholders held in  
18 accordance with subsection H of this section shall be deemed an  
19 annual meeting of shareholders for purposes of subsection C of  
20 Section 1056 of this title.

21 J. Whenever it shall be desired to revive the certificate of  
22 incorporation of any nonstock corporation, the governing body shall  
23 perform all the acts necessary for the revival of the charter of the  
24 corporation which are performed by the board of directors in the

1 case of a corporation having capital stock. In addition, the  
2 members of any nonstock corporation who are entitled to vote for the  
3 election of members of its governing body and any other members  
4 entitled to vote for dissolution under the certificate of  
5 incorporation or the bylaws of such corporation, shall perform all  
6 the acts necessary for the revival of the certificate of  
7 incorporation of the corporation which are performed by the  
8 shareholders in the case of a corporation having capital stock. In  
9 all other respects, the procedure for the revival of the certificate  
10 of incorporation of a nonstock corporation shall conform, as nearly  
11 as may be applicable, to the procedure prescribed in this section  
12 for the revival of the certificate of incorporation of a corporation  
13 having capital stock; provided, however, subsection I of this  
14 section shall not apply to nonstock corporations.

15 SECTION 37. This act shall become effective November 1, 2023.
