6 An Act relating to voter registration; authorizing  
7 state membership in multistate voter list maintenance  
8 organizations; authorizing expenditure of funds for  
9 certain dues and fees; allowing certain data to be  
10 provided to certain organizations; requiring secure  
11 transmission of certain data; authorizing certain  
12 voter registration notification procedures; providing  
13 for codification; providing an effective date; and  
14 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 4-121 of Title 26, unless there  
18 is created a duplication in numbering, reads as follows:

19 A. The Secretary of the State Election Board may join the State  
20 of Oklahoma as a member in one or more multistate voter list  
21 maintenance organizations including, but not limited to, the  
22 Electronic Registration Information Center (ERIC) or its successor.  
23 The Secretary is authorized to expend funds as available for  
24 membership fees, dues and other expenses related to such membership.

25 B. Upon membership in an organization as provided in subsection  
26 A of this section, the Secretary of the State Election Board may

1 provide voter registration data to the organization and the  
2 Department of Public Safety may provide motor vehicle license data  
3 to the organization if such data is required to be provided as a  
4 condition of membership. The voter registration data and motor  
5 vehicle license data described in this subsection may include a  
6 person's name, address, date of birth, driver license or state  
7 identification number, last four digits of a social security number  
8 or any other data required by the organization. The transmission  
9 and storage of such data shall be done in a secure manner.

10 C. If a multistate voter list maintenance organization of which  
11 this state is a member identifies Oklahoma residents who are  
12 citizens of the United States eligible to vote but not yet  
13 registered, the Secretary of the State Election Board may notify  
14 such citizens about the procedure for becoming a registered voter in  
15 this state. The Secretary may delegate the contacting of such  
16 citizens to the secretary of the appropriate county election board.

17 **D. If a multistate voter list maintenance organization of which**  
18 **this state is a member provides United States Postal Service**  
19 **National Change of Address data regarding registered voters who have**  
20 **changed their address of residence within the state, the Secretary**  
21 **of the State Election Board may use the data pursuant to the**  
22 **provisions of Sections 4-118.1, 4-120.2 or 7-115.1 of Title 26 of**  
23 **the Oklahoma Statutes or the federal National Voter Registration**  
24 **Act.**

1 SECTION 2. This act shall become effective July 1, 2021.

2 SECTION 3. It being immediately necessary for the preservation  
3 of the public peace, health or safety, an emergency is hereby  
4 declared to exist, by reason whereof this act shall take effect and  
5 be in full force from and after its passage and approval.
