No charter provision, ordinance, rule, order, permit, policy, guideline or other governmental action of any political subdivision of this state, local government, city, county or any agency, authority, board, commission, department or officer shall:

14 1. Prevent, restrict or discourage any lender authorized and 15 licensed to make loans under Chapter 57 of Title 59 of the Oklahoma 16 Statutes from lending in compliance with the provisions of Chapter 17 57 of Title 59 of the Oklahoma Statutes;
