6 AS INTRODUCED

7 An Act relating to Oklahoma Personnel Act; amending
8 74 O.S. 2011, Section 840-5.5, as last amended by
9 Section 1, Chapter 365, O.S.L. 2019 (74 O.S. Supp.
10 2020, Section 840-5.5), which relates to unclassified
11 service; requiring all newly hired state employees to
12 be in the unclassified service except when required
13 by federal grant or funding to be in the classified
14 service; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 74 O.S. 2011, Section 840-5.5, as
17 last amended by Section 1, Chapter 365, O.S.L. 2019 (74 O.S. Supp.
18 2020, Section 840-5.5), is amended to read as follows:

19 Section 840-5.5. A. The following offices, positions, and
20 personnel shall be in the unclassified service and shall not be
21 placed under the classified service:

22 1. Persons chosen by popular vote or appointment to fill an
23 elective office, and their employees, except the employees of the
24 Corporation Commission, the State Department of Education and the
25 Department of Labor;

1 2. Members of boards and commissions, and heads of agencies;
2 also one principal assistant or deputy and one executive secretary
3 for each state agency;

4 3. All judges, elected or appointed, and their employees;

5 4. Persons employed with one-time, limited duration, federal or
6 other grant funding that is not continuing or indefinitely
7 renewable. The length of the unclassified employment shall not
8 exceed the period of time for which that specific federal funding is
9 provided;

10 5. All officers and employees of The Oklahoma State System of
11 Higher Education, State Board of Education and Oklahoma Department
12 of Career and Technology Education;

13 6. Persons employed in a professional or scientific capacity to
14 make or conduct a temporary and special inquiry, investigation, or
15 examination on behalf of the Legislature or a committee thereof or
16 by authority of the Governor. These appointments and authorizations
17 shall terminate on the first day of the regular legislative session
18 immediately following the appointment, if not terminated earlier.
19 However, nothing in this paragraph shall prevent the reauthorization
20 and reappointment of any such person. Any such appointment shall be
21 funded from the budget of the appointing authority;

22 7. Election officials and employees;

23 8. Temporary employees employed to work less than one thousand
24 (1,000) hours in any twelve-month period, and seasonal employees

1 employed by the Oklahoma Tourism and Recreation Department pursuant
2 to Section 2241 of this title who work less than one thousand six
3 hundred (1,600) hours in any twelve-month period;

4 9. Department of Public Safety employees occupying the
5 following offices or positions:

- 6 a. administrative aides to the Commissioner,
- 7 b. executive secretaries to the Commissioner,
- 8 c. the Governor's representative of the Oklahoma Highway
9 Safety Office who shall be appointed by the Governor,
- 10 d. Highway Patrol Colonel,
- 11 e. Highway Patrol Lieutenant Colonel,
- 12 f. Highway Patrol Major,
- 13 g. Director of Finance,
- 14 h. noncommissioned pilots,
- 15 i. Information Systems Administrator,
- 16 j. Law Enforcement Telecommunications System Specialist,
- 17 k. Director of Driver Compliance,
- 18 l. Director of Transportation Division,
- 19 m. Director of the Oklahoma Highway Safety Office,
- 20 n. Civil Rights Administrator,
- 21 o. Budget Analyst,
- 22 p. Comptroller,
- 23 q. Chaplain,
- 24 r. Helicopter Mechanic,

- s. Director of Safety Compliance,
- t. Human Resources Director,
- u. Administrator of Department Services, and
- v. a maximum of seven positions for the purpose of administering programs in the Oklahoma Highway Safety Office, within full-time employee limitations of the Department, employed with federal funding that is continuing or indefinitely renewable. The authorization for such positions shall be terminated if the federal funding for positions is discontinued;

provided, any person appointed to a position prescribed in subparagraph d, e or f of this paragraph shall have a right of return to the classified commissioned position without any loss of rights, privileges or benefits immediately upon completion of the duties in the unclassified commissioned position;

10. Professional trainees only during the prescribed length of their course of training or extension study;

11. Students who are employed on a part-time basis, which shall be seventy-five percent (75%) of a normal forty-hour work week or thirty (30) hours per week, or less, or on a full-time basis if the employment is pursuant to a cooperative education program such as that provided for under Title I IV-D of the Higher Education Act of 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly enrolled in:

- 1 a. an institution of higher learning within The Oklahoma
2 State System of Higher Education,
3 b. an institution of higher learning qualified to become
4 coordinated with The Oklahoma State System of Higher
5 Education. For purposes of this section, a student
6 shall be considered a regularly enrolled student if
7 the student is enrolled in a minimum of five (5) hours
8 of accredited graduate courses or a minimum of ten
9 (10) hours of accredited undergraduate courses;
10 provided, however, the student shall only be required
11 to be enrolled in a minimum of six (6) hours of
12 accredited undergraduate courses during the summer, or
13 c. high school students regularly enrolled in a high
14 school in Oklahoma and regularly attending classes
15 during such time of enrollment;

16 12. The spouses of personnel who are employed on a part-time
17 basis to assist or work as a relief for their spouses in the
18 Oklahoma Tourism and Recreation Department;

19 13. Service substitute attendants who are needed to replace
20 museum and site attendants who are unavoidably absent. Service
21 substitutes may work as part-time or full-time relief for absentees
22 for a period of not more than four (4) weeks per year in the
23 Oklahoma Historical Society sites and museums; such substitutes will
24

1 not count towards the agency's full-time-equivalent (FTE) employee
2 limit;

3 14. Employees of the Oklahoma House of Representatives, the
4 State Senate, or the Legislative Service Bureau;

5 15. Corporation Commission personnel occupying the following
6 offices and positions:

- 7 a. Administrative aides, and executive secretaries to the
8 Commissioners,
- 9 b. Directors of all the divisions, personnel managers and
10 comptrollers,
- 11 c. General Counsel,
- 12 d. Public Utility Division Chief Engineer,
- 13 e. Public Utility Division Chief Accountant,
- 14 f. Public Utility Division Chief Economist,
- 15 g. Public Utility Division Deputy Director,
- 16 h. Secretary of the Commission,
- 17 i. Deputy Conservation Director,
- 18 j. Manager of Pollution Abatement,

8 Director, or Educational Coordinator in any other state agency
9 having a primary responsibility to coordinate educational programs
10 operated for children in state institutions;

11 17. Department of Mental Health and Substance Abuse Services
12 personnel occupying the following offices and positions at each
13 facility:

- 14 a. Director of Facility,
15 b. Deputy Director for Administration,
16 c. Clinical Services Director,
17 d. Executive Secretary to Director, and
18 e. Directors or Heads of Departments or Services;

19 18. Office of Management and Enterprise Services personnel

21 30. The Oklahoma State Bureau of Investigation employees
22 occupying the following positions:

7 49. Acting incumbents employed pursuant to Section 209 of Title
8 44 or Section 48 of Title 72 of the Oklahoma Statutes who shall not
9 be included in any limitation on full-time equivalency imposed by
10 law on an agency. Permanent classified employees may request a
11 leave of absence from classified status and accept an unclassified
12 appointment and compensation as an acting incumbent with the same
13 agency; provided, the leave shall expire no later than two (2) years
14 from the date of the acting incumbent appointment. An appointing
15 authority may establish unclassified positions and appoint
16 unclassified employees to perform the duties of a permanent
17 classified employee who is on leave of absence from a classified
18 position to serve as an acting incumbent. All unclassified
19 appointments created pursuant to this paragraph shall expire no
20 later than two (2) years from the date of appointment. Classified
21 employees accepting unclassified appointments and compensation
22 pursuant to this paragraph shall be entitled to participate without
23 interruption in any benefit programs available to classified
24 employees, including retirement and insurance programs. Immediately

1 upon termination of an unclassified appointment pursuant to this
2 paragraph, an employee on assignment from the classified service
3 shall have a right to be restored to the classified service and
4 reinstated to the former job family level and compensation plus any
5 adjustments and increases in salary or benefits which the employee
6 would have received but for the leave of absence;

7 50. The Oklahoma Homeland Security Director and all other
8 positions assigned the responsibilities of working in the Oklahoma
9 Office of Homeland Security;

10 51. The following eighteen positions in the State Department of
11 Health:

- 12 a. one surveillance supervisor,
- 13 b. one surveillance project monitor,
- 14 c. two bilingual interviewers,
- 15 d. eight senior interviewers, and
- 16 e. six interviewers;

17 52. State Board of Licensure for Professional Engineers and
18 Land Surveyors personnel occupying the following offices and
19 positions:

- 20 a. one Director of Enforcement, and
- 21 b. two Board Investigators;

22 53. One Information Systems Data Management Analyst of the
23 State and Education Employees Group Insurance Board;

1 54. Office of Juvenile Affairs personnel occupying the
2 following offices and positions:

- 3 a. two Management Information Systems positions, and
- 4 b. employees hired for service at the Southwest Oklahoma
5 Juvenile Center in Manitou after June 1, 2020, as
6 provided in subsection C of Section 2-7-202 of Title
7 10A of the Oklahoma Statutes; and

8 55. Heads of agencies, principal assistants or deputies and
9 executive secretaries of an agency that is consolidated into another
10 agency.

11 B. If an agency has the authority to employ personnel in the
12 following offices and positions, the appointing authority shall have
13 the discretion to appoint personnel to the unclassified service:

- 14 1. Licensed medical doctors, osteopathic physicians, dentists,
15 psychologists, and nurses;
- 16 2. Certified public accountants;
- 17 3. Licensed attorneys;
- 18 4. Licensed veterinarians; and
- 19 5. Licensed pharmacists.

20 C. Effective July 1, 1996, authorization for unclassified
21 offices, positions, or personnel contained in a bill or joint
22 resolution shall terminate June 30 of the ensuing fiscal year after
23 the authorization unless the authorization is codified in the
24

1 Oklahoma Statutes or the termination is otherwise provided in the
2 legislation.

3 D. Notwithstanding any other sections of law, on the effective
4 date of this act, all newly hired state employees shall be in the
5 unclassified service and shall not be placed under the classified
6 service except for those positions required by a federal grant or
7 funding requirement.

8 E. The appointing authority of agencies participating in the
9 statewide information systems project may establish unclassified
10 positions and appoint unclassified employees to the project as
11 needed. Additional unclassified positions may be established, if
12 required, to appoint an unclassified employee to perform the duties
13 of a permanent classified employee who is temporarily absent from a
14 classified position as a result of assignment to this project. All
15 unclassified appointments under this authority shall expire no later
16 than December 31, 2007, and all unclassified positions established
17 to support the project shall be abolished. Both the positions and
18 appointments resulting from this authority shall be exempt from any
19 agency FTE limitations and any limits imposed on the number of
20 unclassified positions authorized. Permanent classified employees
21 may request a leave of absence from classified status and accept an
22 unclassified appointment and compensation with the same agency under
23 the provisions of this subsection; provided, the leave shall expire
24 no later than December 31, 2007. Employees accepting the

1 appointment and compensation shall be entitled to participate
2 without interruption in any benefit programs available to classified
3 employees, including retirement and insurance programs. Immediately
4 upon termination of an unclassified appointment pursuant to this
5 subsection, an employee on assignment from the classified service
6 shall have a right to be restored to the classified service and
7 reinstated to the former job family level and compensation plus any
8 adjustments and increases in salary or benefits which the employee
9 would have received but for the leave of absence.

10 SECTION 2. It being immediately necessary for the preservation
11 of the public peace, health or safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
