6 AS INTRODUCED

7 An Act relating to health insurance; creating
8 Shannon's Law; amending 36 O.S. 2011, Section 6060,
9 as amended by Section 1, Chapter 158, O.S.L. 2018 (36
10 O.S. Supp. 2018, Section 6060), which relates to
11 mammography screening; modifying definitions; adding
12 certain persons to coverage; modifying age at which
13 certain coverage begins; and providing an effective
14 date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law not to be
17 codified in the Oklahoma Statutes reads as follows:

18 This act shall be known and may be cited as "Shannon's Law".

19 SECTION 2. AMENDATORY 36 O.S. 2011, Section 6060, as
20 amended by Section 1, Chapter 158, O.S.L. 2018 (36 O.S. Supp. 2018,
21 Section 6060), is amended to read as follows:

22 Section 6060. A. For the purposes of this section,

23 1. "Health benefit plan" means any plan or arrangement ~~as~~
24 ~~defined in subsection C of Section 6060.4 of this title~~ that

- 1 a. provides benefits for medical or surgical expenses
2 incurred as a result of a health condition, accident
3 or sickness, and
- 4 b. is offered by any insurance company, group hospital
5 service corporation, the State and Education Employees
6 Group Insurance Board or health maintenance
7 organization that delivers or issues for delivery an
8 individual, group, blanket or franchise insurance
9 policy or insurance agreement, a group hospital
10 service contract or an evidence of coverage, or, to
11 the extent permitted by the Employee Retirement Income
12 Security Act of 1974, 29 U.S.C., Section 1001 et seq.,
13 by a multiple employer welfare arrangement as defined
14 in Section 3 of the Employee Retirement Income
15 Security Act of 1974, or any other analogous benefit
16 arrangement, whether the payment is fixed or by
17 indemnity;

18 2. ~~"Low-dose mammography~~ Mammography screening" means:

- 19 a. the x-ray examination of the breast using equipment
20 specifically dedicated for such purpose, with an
21 average radiation exposure delivery of less than one
22 rad mid-breast and with two views for each breast,
- 23 b. digital mammography, or
- 24 c. breast tomosynthesis;
- 25

1 3. "Breast tomosynthesis" means a radiologic mammography
2 procedure involving the acquisition of projection images over a
3 stationary breast to produce cross-sectional digital three-
4 dimensional images of the breast from which breast cancer screening
5 diagnoses may be made.

6 B. All health benefit plans shall include the coverage
7 specified by this section for ~~a low-dose~~ mammography screening for
8 the presence of occult breast cancer. Such coverage shall not:

9 1. Be subject to the policy deductible, co-payments and co-
10 insurance limits of the plan; or

11 2. Require that a female undergo a mammography screening at a
12 specified time as a condition of payment.

13 C. 1. A female with a prior history of breast cancer or who
14 has a first degree relative with a prior history of breast cancer
15 shall, upon the recommendation of a physician, be entitled pursuant
16 to the provisions of this section to coverage for mammography
17 screening, which may be provided by breast tomosynthesis.

18 2. Any female ~~thirty-five (35) through thirty-nine (39) years~~
19 of age ~~age~~ age thirty (30) or older shall be entitled pursuant to the
20 provisions of this section to coverage for ~~a low-dose~~ annual
21 mammography screening, which may be provided by breast tomosynthesis
22 ~~once every five (5) years.~~

~~2. Any female forty (40) years of age or older shall be entitled pursuant to the provisions of this section to coverage for an annual low-dose mammography screening.~~

SECTION 3. This act shall become effective November 1, 2019.
