16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. AMENDATORY 13 O.S. 2011, Section 176.7, as
18	amended by Section 1, Chapter 28, O.S.L. 2015 (13 O.S. Supp. 2020,
19	Section 176.7), is amended to read as follows:
20	Section 176.7. The Attorney General, upon application by a
21	district attorney, may make application to a judge of competent
22	jurisdiction for, and such judge may grant in conformity with the
23	Security of Communications Act, an order authorizing the
24	interception of wire, oral or electronic communications by any law

1	enforcement agency of this state or any political subdivision
2	thereof having responsibility for the investigation of the offense
3	as to which the application is made, when such interception may
4	provide evidence of acts of biochemical terrorism, terrorism,
5	terrorism hoax, and biochemical assault, as defined in Section
6	1268.1 of Title 21 of the Oklahoma Statutes, the commission of the
7	offense of murder, the cultivation or manufacture or distribution of
8	narcotic drugs or other controlled dangerous substances $_{ au}$ as defined
