6 AS INTRODUCED

7 An Act relating to hunting; amending 29 O.S. 2011,
8 Section 4-113, which relates to hunting and fishing
9 annual combination licenses; creating annual
10 landowner combination license; providing persons for
11 which the license can be assigned; restricting
12 validity of license to certain land; establishing
13 fee; providing limit for the amount of licenses
14 issued; authorizing the Department of Wildlife
15 Conservation to require verification; requiring the
16 Department to promulgate rules; and providing an
17 effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY 29 O.S. 2011, Section 4-113, is
20 amended to read as follows:

21 Section 4-113. A. Legal residents who are not the individuals
22 excepted from the license requirement as provided in subsection B of
23 Section 4-112 of this title may purchase an annual combination
24 hunting/fishing license from the Director or agents of the Director.

B. The fee for each combination hunting/fishing license issued
under this section shall be:

1 1. For legal residents eighteen (18) years of age and older for
2 a license that expires on December 31 of the year purchased - Forty-
3 one Dollars (\$41.00);

4 2. For residents eighteen (18) years of age and older for a
5 license that expires on June 30 of the fiscal year purchased -
6 Fifty-two Dollars (\$52.00);

7 3. For legal residents sixteen (16) or seventeen (17) years of
8 age for a license that expires on December 31 of the year purchased
9 - Thirteen Dollars (\$13.00); and

10 4. For legal residents sixteen (16) or seventeen (17) years of
11 age for a license that expires on June 30 of the fiscal year
12 purchased - Eighteen Dollars (\$18.00).

13 C. Legal residents and nonresidents may purchase an annual
14 combination hunting and fishing landowner license. The license
15 provided for in this subsection may be assigned to the landowner's
16 or tenant's siblings and lineal ascendants or descendants and their
17 spouses, whether or not an Oklahoma resident. The license shall
18 only be valid for the land that it is issued to. The license fee
19 shall be the same as the Oklahoma resident annual hunting license
20 fee in subsection B of this section. The total number of annual
21 combination hunting and fishing landowner licenses issued shall not
22 exceed one license for each eighty (80) acres owned by the landowner
23 or operated by the tenant. Evidence of ownership or tenancy,
24 sibling, lineal ascending or descending relations or spousal

1 relationship, if requested, shall be provided to the Department of
2 Wildlife Conservation. The Department shall promulgate rules to
3 enforce the provisions of this subsection.

4 D. Of the fees collected pursuant to the provisions of
5 paragraphs 1 and 2 of subsection B of this section, Five Dollars
6 (\$5.00) of the license fee shall be for the Oklahoma Wildlife Land
7 Stamp and shall be deposited in the Oklahoma Wildlife Land Fund
8 created pursuant to the provisions of Section 4-141 of this title.

9 SECTION 2. This act shall become effective November 1, 2019.
