22 WHEREAS, the Oklahoma Veterans Pilot Program has been created to
23 develop a 21st Century healthcare delivery system for the Oklahoma
24 veterans' community; and

1 WHEREAS, the healthcare delivery system will be part of a
2 private/public partnership designed to improve timely access to
3 services, the quality of care provided, improve efficiency and
4 create a cost savings to participating federal and state agencies;
5 and

6 WHEREAS, the healthcare services will be designed as one
7 seamless transitional system of care across Oklahoma; and

8 WHEREAS, the transitional system of care developed will be
9 tested and placed into action with appropriate monitoring and
10 outcome measures recorded; and

11 WHEREAS, the final healthcare product may be considered as a
12 national model after the testing and action period; and

13 WHEREAS, this initiative is being supported by professionals in
14 healthcare, the business and finance community, higher education
15 professionals, community leaders and veterans from around the great
16 state of Oklahoma.

17 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION
18 OF THE 56TH OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES
19 CONCURRING THEREIN:

21 Veterans Pilot Program.
