

House Bill 2347

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor Tina Kotek for Department of Land Conservation and Development)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: This bill lets DLCD aid tribes with planning and makes various technical changes to land use laws. (Flesch Readability Score: 70.1).

Authorizes the Department of Land Conservation and Development to provide planning assistance for housing production to federally recognized Indian tribes. Makes other technical changes to laws relating to land use planning.

14 **SECTION 1.** ORS 197A.030 is amended to read:

15 197A.030. The Department of Land Conservation and Development may provide technical as-
16 sistance and award grants to local governments **and federally recognized Indian tribes in this**
17 **state** to enable *[them]* **local governments** to implement the provisions of ORS chapter 197A and to
18 **enable local governments and tribes to** take other actions to incentivize the production of needed
19 housing within the jurisdiction of the local government **or tribe or on lands owned or managed**
20 **by a federally recognized Indian tribe.**

MANUFACTURED DWELLING DEVELOPMENT

24 **SECTION 2.** ORS 197.478 is amended to read:

25 197.478. (1) Notwithstanding any other provision in ORS chapter 197A, within an urban growth
26 boundary, a local government shall allow the siting of manufactured homes and prefabricated
27 structures on all land zoned to allow the development of *[single-family]* **single-unit** dwellings.

28 (2) This section does not apply to any area designated in an acknowledged comprehensive plan

1 or land use regulation as a historic district or residential land immediately adjacent to a historic
2 landmark.

3 (3) Manufactured homes and prefabricated structures allowed under this section are in addition
4 to manufactured dwellings or prefabricated structures allowed within designated manufactured
5 dwelling subdivisions.

6 (4) A local government may not subject manufactured homes or prefabricated structures within
7 an urban growth boundary, or the land upon which the homes or structures are sited, to any appli-
8 cable standard that would not apply to a *[detached,]* site-built *[single-family]* dwelling **of the same**
9 **type** on the same land, except:

10 (a) As necessary to comply with a protective measure adopted pursuant to a statewide land use
11 planning goal; or

12 (b) To require that the manufacturer certify that the manufactured home or prefabricated
13 structure has an exterior thermal envelope meeting performance standards which reduce levels
14 equivalent to the performance standards required of *[single-family]* **single-unit** dwellings constructed
15 under the Low-Rise Residential Dwelling Code as defined in ORS 455.010.

16 (5) Within any residential zone inside an urban growth boundary where a manufactured dwelling
17 park is otherwise allowed, a city or county may not adopt a minimum lot size for a manufactured
18 dwelling park that is larger than one acre.

19 (6) This section may not be construed as abrogating a recorded restrictive covenant.

22
23 **SECTION 3.** Section 3, chapter 102, Oregon Laws 2024, is amended to read:

24 **Sec. 3.** (1) As used in this section, “Metro urbanizable lands” means lands within the Metro
25 urban growth boundary that *[is]* **are** not within a city and *[is]* **are** not Metro urban unincorporated
26 land.

27 (2) In fulfilling a requirement to comply with this chapter, a local government may plan for the
28 appropriate urbanization of Metro urbanizable lands, by using methods including adjacent
29 urbanizable lands:

30 (a) In an intergovernmental agreement **related to the urbanization of such lands;**

31 (b) In a housing production strategy, housing coordination strategy or corrective action plan
32 under ORS 197A.100, 197A.365 or 197A.372; or

33 (c) To accommodate needed housing identified in an analysis of housing capacity under ORS
34 197A.335 or 197A.350.

35 (3) Except as may be explicitly delegated in an intergovernmental agreement, counties are solely
36 responsible for complying with this chapter with respect to Metro urban unincorporated lands that
37 are within their jurisdiction.

39 **COMPLETENESS REVIEW**

40
41 **SECTION 4.** ORS 215.427, as amended by section 7, chapter 102, Oregon Laws 2024, and section
42 8, chapter 110, Oregon Laws 2024, is amended to read:

43 215.427. (1) Except as provided in subsections (3), (5) and (10) of this section, for land within an
44 urban growth boundary and applications for mineral aggregate extraction, the governing body of a
45 county or its designee shall take final action on an application for a permit, limited land use deci-

1 sion or zone change, including resolution of all appeals under ORS 215.422, within 120 days after the
 2 application is deemed complete. The governing body of a county or its designee shall take final
 3 action on all other applications for a permit, limited land use decision or zone change, including
 4 resolution of all appeals under ORS 215.422, within 150 days after the application is deemed com-
 5 plete, except as provided in subsections (3), (5) and (10) of this section.

6 (2) If an application for a permit, limited land use decision or zone change is incomplete, the
 7 governing body or its designee shall notify the applicant in writing of exactly what information is
 8 missing within 30 days of receipt of the application and allow the applicant to submit the missing
 9 information. The application shall be deemed complete for the purpose of subsection (1) of this sec-
 10 tion and ORS 197A.470 upon receipt by the governing body or its designee of:

11 (a) All of the missing information;

12 (b) Some of the missing information and written notice from the applicant that no other infor-
 13 mation will be provided; or

14 (c) Written notice from the applicant that none of the missing information will be provided.

15 (3)(a) *[If the application was complete when first submitted or the applicant submits additional in-*
 16 *formation within 180 days of the date the application was first submitted,]* Approval or denial of *[the*
 17 *application]* **an application that is complete pursuant to subsection (2) of this section** must be
 18 based:

19 (A) Upon the standards and criteria that were applicable at the time the application was first
 20 submitted; or

21 (B) For an application relating to development of housing, upon the request of the applicant,
 22 those standards and criteria that are operative at the time of the request.

23 (b) If an applicant requests review under different standards as provided in paragraph (a)(B) of
 24 this subsection:

25 (A) For the purposes of this section, any applicable timelines for completeness review and final
 26 decisions restart as if a new application were submitted on the date of the request;

27 (B) For the purposes of this section and ORS 197A.470 the application is not deemed complete
 28 until:

29 (i) The county determines that additional information is not required under subsection (2) of this
 30 section; or

31 (ii) The applicant makes a submission under subsection (2) of this section in response to a
 32 county's request;

33 (C) A county may deny a request under paragraph (a)(B) of this subsection if:

34 (i) The county has issued a public notice of the application; or

35 (ii) A request under paragraph (a)(B) of this subsection was previously made; and

36 (D) The county may not require that the applicant:

37 (i) Pay a fee, except to cover additional costs incurred by the county to accommodate the re-
 38 quest;

39 (ii) Submit a new application or duplicative information, unless information resubmittal is re-
 40 quired because the request affects or changes information in other locations in the application or
 41 additional narrative is required to understand the request in context; or

42 (iii) Repeat redundant processes or hearings that are inapplicable to the change in standards
 43 or criteria.

44 (4) On the 181st day after first being submitted, the application is void if the applicant has been
 45 notified of the missing information as required under subsection (2) of this section and has not sub-

1 mitted:

2 (a) All of the missing information;

3 (b) Some of the missing information and written notice that no other information will be pro-
4 vided; or

5 (c) Written notice that none of the missing information will be provided.

6 (5) The period set in subsection (1) of this section or the 100-day period set in ORS 197A.470
7 may be extended for a specified period of time at the written request of the applicant. The total of
8 all extensions, except as provided in subsection (10) of this section for mediation, may not exceed
9 215 days.

10 (6) The period set in subsection (1) of this section applies:

11 (a) Only to decisions wholly within the authority and control of the governing body of the
12 county; and

13 (b) Unless the parties have agreed to mediation as described in subsection (10) of this section
14 or ORS 197.319 (2)(b).

15 (7) Notwithstanding subsection (6) of this section, the period set in subsection (1) of this section
16 and the 100-day period set in ORS 197A.470 do not apply to:

17 (a) A decision of the county making a change to an acknowledged comprehensive plan or a land
18 use regulation that is submitted to the Director of the Department of Land Conservation and De-
19 velopment under ORS 197.610; or

20 (b) A decision of a county involving an application for the development of residential structures
21 within an urban growth boundary, where the county has tentatively approved the application and
22 extends these periods by no more than seven days in order to assure the sufficiency of its final or-
23 der.

24 (8) Except when an applicant requests an extension under subsection (5) of this section, if the
25 governing body of the county or its designee does not take final action on an application for a
26 permit, limited land use decision or zone change within 120 days or 150 days, as applicable, after
27 the application is deemed complete, the county shall refund to the applicant either the unexpended
28 portion of any application fees or deposits previously paid or 50 percent of the total amount of such
29 fees or deposits, whichever is greater. The applicant is not liable for additional governmental fees
30 incurred subsequent to the payment of such fees or deposits. However, the applicant is responsible
31 for the costs of providing sufficient additional information to address relevant issues identified in
32 the consideration of the application.

33 (9) A county may not compel an applicant to waive the period set in subsection (1) of this sec-
34 tion or to waive the provisions of subsection (8) of this section or ORS 197A.470 or 215.429 as a
35 condition for taking any action on an application for a permit, limited land use decision or zone
36 change except when such applications are filed concurrently and considered jointly with a plan
37 amendment.

38 (10) The periods set forth in subsections (1) and (5) of this section and ORS 197A.470 may be
39 extended by up to 90 additional days, if the applicant and the county agree that a dispute concerning
40 the application will be mediated.

41 **SECTION 5.** ORS 227.178, as amended by section 8, chapter 102, Oregon Laws 2024, and section
42 9, chapter 110, Oregon Laws 2024, is amended to read:

43 227.178. (1) Except as provided in subsections (3), (5) and (11) of this section, the governing body
44 of a city or its designee shall take final action on an application for a permit, limited land use de-
45 cision or zone change, including resolution of all appeals under ORS 227.180, within 120 days after

1 the application is deemed complete.

2 (2) If an application for a permit, limited land use decision or zone change is incomplete, the
 3 governing body or its designee shall notify the applicant in writing of exactly what information is
 4 missing within 30 days of receipt of the application and allow the applicant to submit the missing
 5 information. The application shall be deemed complete for the purpose of subsection (1) of this sec-
 6 tion or ORS 197A.470 upon receipt by the governing body or its designee of:

7 (a) All of the missing information;

8 (b) Some of the missing information and written notice from the applicant that no other infor-
 9 mation will be provided; or

10 (c) Written notice from the applicant that none of the missing information will be provided.

11 (3)(a) *[If the application was complete when first submitted or the applicant submits the requested*
 12 *additional information within 180 days of the date the application was first submitted,]* Approval or
 13 denial of *[the application]* **an application that is complete pursuant to subsection (2) of this**
 14 **section** must be based:

15 (A) Upon the standards and criteria that were applicable at the time the application was first
 16 submitted; or

17 (B) For an application relating to development of housing, upon the request of the applicant,
 18 those standards and criteria that are operative at the time of the request.

19 (b) If an applicant requests review under different standards as provided in paragraph (a)(B) of
 20 this subsection:

1 (5) The 120-day period set in subsection (1) of this section or the 100-day period set in ORS
 2 197A.470 may be extended for a specified period of time at the written request of the applicant. The
 3 total of all extensions, except as provided in subsection (11) of this section for mediation, may not
 4 exceed 245 days.

5 (6) The 120-day period set in subsection (1) of this section applies:

6 (a) Only to decisions wholly within the authority and control of the governing body of the city;
 7 and

8 (b) Unless the parties have agreed to mediation as described in subsection (11) of this section
 9 or ORS 197.319 (2)(b).

10 (7) Notwithstanding subsection (6) of this section, the 120-day period set in subsection (1) of this
 11 section and the 100-day period set in ORS 197A.470 do not apply to:

12 (a) A decision of the city making a change to an acknowledged comprehensive plan or a land
 13 use regulation that is submitted to the Director of the Department of Land Conservation and De-
 14 velopment under ORS 197.610; or

15 (b) A decision of a city involving an application for the development of residential structures
 16 within an urban growth boundary, where the city has tentatively approved the application and ex-
 17 tends these periods by no more than seven days in order to assure the sufficiency of its final order.

18 (8) Except when an applicant requests an extension under subsection (5) of this section, if the
 19 governing body of the city or its designee does not take final action on an application for a permit,
 20 limited land use decision or zone change within 120 days after the application is deemed complete,
 21 the city shall refund to the applicant, subject to the provisions of subsection (9) of this section, ei-
 22 ther the unexpended portion of any application fees or deposits previously paid or 50 percent of the
 23 total amount of such fees or deposits, whichever is greater. The applicant is not liable for additional
 24 governmental fees incurred subsequent to the payment of such fees or deposits. However, the ap-
 25 plicant is responsible for the costs of providing sufficient additional information to address relevant
 26 issues identified in the consideration of the application.

27 (9)(a) To obtain a refund under subsection (8) of this section, the applicant may either:

28 (A) Submit a written request for payment, either by mail or in person, to the city or its designee;
 29 or

30 (B) Include the amount claimed in a mandamus petition filed under ORS 227.179. The court shall
 31 award an amount owed under this section in its final order on the petition.

32 (b) Within seven calendar days of receiving a request for a refund, the city or its designee shall
 33 determine the amount of any refund owed. Payment, or notice that no payment is due, shall be made
 34 to the applicant within 30 calendar days of receiving the request. Any amount due and not paid
 35 within 30 calendar days of receipt of the request shall be subject to interest charges at the rate of
 36 one percent per month, or a portion thereof.

37 (c) If payment due under paragraph (b) of this subsection is not paid within 120 days after the
 38 city or its designee receives the refund request, the applicant may file an action for recovery of the
 39 unpaid refund. In an action brought by a person under this paragraph, the court shall award to a
 40 prevailing applicant, in addition to the relief provided in this section, reasonable attorney fees and
 41 costs at trial and on appeal. If the city or its designee prevails, the court shall award reasonable
 42 attorney fees and costs at trial and on appeal if the court finds the petition to be frivolous.

43 (10) A city may not compel an applicant to waive the 120-day period set in subsection (1) of this
 44 section or to waive the provisions of subsection (8) of this section or ORS 197A.470 or 227.179 as a
 45 condition for taking any action on an application for a permit, limited land use decision or zone

1 change except when such applications are filed concurrently and considered jointly with a plan
2 amendment.

3 (11) The periods set forth in subsections (1) and (5) of this section and ORS 197A.470 may be
4 extended by up to 90 additional days, if the applicant and the city agree that a dispute concerning
5 the application will be mediated.

7 **APPLICATION AMENDMENTS FOR NEEDED HOUSING**

8
9 **SECTION 6. ORS 197.522 is added to and made a part of ORS chapter 197A.**

10 **SECTION 7.** ORS 197.522, as amended by section 31, chapter 102, Oregon Laws 2024, is
11 amended to read:

12 197.522. (1) As used in this section:

13 [(a) "Needed housing" has the meaning given that term in ORS 197A.018.]

14 [(b)] (a) "Partition" has the meaning given that term in ORS 92.010.

15 [(c)] (b) "Permit" means a permit as defined in ORS 215.402 and a permit as defined in ORS
16 227.160.

17 [(d)] (c) "Subdivision" has the meaning given that term in ORS 92.010.

18 (2) A local government shall approve an application for a permit, authorization or other ap-
19 proval necessary for the subdivision or partitioning of, or construction on, any land for needed
20 housing that is consistent with the comprehensive plan and applicable land use regulations.

21 (3) If an application **described in subsection (2) of this section** is inconsistent with the com-
22 prehensive plan and applicable land use regulations, the local government, prior to making a final
23 decision on the application, shall allow the applicant to offer an amendment or to propose conditions
24 of approval that would make the application consistent with the plan and applicable regulations. If
25 an applicant seeks to amend the application or propose conditions of approval:

26 (a) A county may extend the time limitation under ORS 215.427 for final action by the governing
27 body of a county on an application for needed housing and may set forth a new time limitation for
28 final action on the consideration of future amendments or proposals.

29 (b) A city may extend the time limitation under ORS 227.178 for final action by the governing
30 body of a city on an application for needed housing and may set forth a new time limitation for final
31 action on the consideration of future amendments or proposals.

32 (4) A local government shall deny an application that is inconsistent with the comprehensive
33 plan and applicable land use regulations and that cannot be made consistent through amendments
34 to the application or the imposition of reasonable conditions of approval.

36 **DEADLINE FOR CITY REPORT ON HOUSING**

37
38 **SECTION 8.** ORS 197A.110 is amended to read:

39 197A.110. (1) [No later than February 1 of] Each year, **by a date established by the Depart-**
40 **ment of Land Conservation and Development**, each city with a population of 10,000 or greater
41 shall submit to the [Department of Land Conservation and Development] **department** a report for the
42 immediately preceding calendar year setting forth:

43 (a) The number of residential units permitted and the number produced, segmented by:

44 (A) [Single-family homes] **Single-unit dwellings.**

45 (B) Accessory dwelling units.

1 (C) Units of middle housing.

2 (D) [*Multifamily residential units*] **Multiunit housing**, not including middle housing.

3 (E) Units with accessibility features or of an accessibility category as recognized by a building
4 code established under ORS chapter 455.

5 (b) For each segment under paragraph (a) of this subsection, the number of units that were
6 subject to a recorded agreement that runs with the land and that requires affordability for an es-
7 tablished income level for a defined period, but that would not be included in the inventory of pub-
8 licly supported housing described in ORS 456.601 (3)(a).

9 (2) The Department of Land Conservation and Development, in consultation with the Housing
10 and Community Services Department, shall develop a format by which data required under this
11 section must be submitted. The Department of Land Conservation and Development shall provide a
12 copy of any form or notice of the format to each city required to provide a report.

13 (3) The Department of Land Conservation and Development shall provide a copy of the data
14 received under this section to the Oregon Department of Administrative Services and the Housing
15 and Community Services Department [*by July 1 of*] each year.

17 **SINGLE-UNIT AND MULTIUNIT TERMINOLOGY**

18
19 **SECTION 9.** ORS 93.277 is amended to read:

20 93.277. A provision in a recorded instrument affecting real property is not enforceable if:

21 (1) The provision would allow the development of a [*single-family*] **single-unit** dwelling on the
22 real property but would prohibit the development of, or the partitioning or subdividing of lands un-
23 der ORS 92.031 for:

24 (a) Middle housing, as defined in ORS 197A.420; or

25 (b) An accessory dwelling unit allowed under ORS 197A.425 (1); and

26 (2) The instrument was executed on or after January 1, 2021.

27 **SECTION 10.** ORS 195.300 is amended to read:

28 195.300. As used in this section and ORS 195.301 and 195.305 to 195.336 and sections 5 to 11,
29 chapter 424, Oregon Laws 2007, and sections 2 to 9 and 17, chapter 855, Oregon Laws 2009, and
30 sections 2 to 7, chapter 8, Oregon Laws 2010:

31 (1) “Acquisition date” means the date described in ORS 195.328.

32 (2) “Claim” means a written demand for compensation filed under:

33 (a) ORS 195.305, as in effect immediately before December 6, 2007; or

34 (b) ORS 195.305 and 195.310 to 195.314, as in effect on and after December 6, 2007.

35 (3) “Enacted” means enacted, adopted or amended.

36 (4) “Fair market value” means the value of property as determined under ORS 195.332.

37 (5) “Farming practice” has the meaning given that term in ORS 30.930.

38 (6) “Federal law” means:

39 (a) A statute, regulation, order, decree or policy enacted by a federal entity or by a state entity
40 acting under authority delegated by the federal government;

41 (b) A requirement contained in a plan or rule enacted by a compact entity; or

42 (c) A requirement contained in a permit issued by a federal or state agency pursuant to a federal
43 statute or regulation.

44 (7) “File” means to submit a document to a public entity.

45 (8) “Forest practice” has the meaning given that term in ORS 527.620.

1 (9) "Ground water restricted area" means an area designated as a critical ground water area
 2 or as a ground water limited area by the Water Resources Department or Water Resources Com-
 3 mission before December 6, 2007.

4 (10) "High-value farmland" means:

5 (a) High-value farmland as described in ORS 215.710 that is land in an exclusive farm use zone
 6 or a mixed farm and forest zone, except that the dates specified in ORS 215.710 (2), (4) and (6) are
 7 December 6, 2007.

8 (b) Land west of U.S. Highway 101 that is composed predominantly of the following soils in Class
 9 III or IV or composed predominantly of a combination of the soils described in ORS 215.710 (1) and
 10 the following soils:

11 (A) Subclassification IIIw, specifically Ettersburg Silt Loam and Croftland Silty Clay Loam;

12 (B) Subclassification IIIe, specifically Klooqueth Silty Clay Loam and Winchuck Silt Loam; and

13 (C) Subclassification IVw, specifically Huffling Silty Clay Loam.

14 (c) Land that is in an exclusive farm use zone or a mixed farm and forest zone and that on June
 15 28, 2007, is:

16 (A) Within the place of use for a permit, certificate or decree for the use of water for irrigation
 17 issued by the Water Resources Department;

18 (B) Within the boundaries of a district, as defined in ORS 540.505; or

19 (C) Within the boundaries of a diking district formed under ORS chapter 551.

20 (d) Land that contains not less than five acres planted in wine grapes.

21 (e) Land that is in an exclusive farm use zone and that is at an elevation between 200 and 1,000
 22 feet above mean sea level, with an aspect between 67.5 and 292.5 degrees and a slope between zero
 23 and 15 percent, and that is located within:

24 (A) The Southern Oregon viticultural area as described in 27 C.F.R. 9.179;

25 (B) The Umpqua Valley viticultural area as described in 27 C.F.R. 9.89; or

26 (C) The Willamette Valley viticultural area as described in 27 C.F.R. 9.90.

27 (f) Land that is in an exclusive farm use zone and that is no more than 3,000 feet above mean
 28 sea level, with an aspect between 67.5 and 292.5 degrees and a slope between zero and 15 percent,
 29 and that is located within:

30 (A) The portion of the Columbia Gorge viticultural area as described in 27 C.F.R. 9.178 that is
 31 within the State of Oregon;

33 (C) The portion of the Columbia Valley viticultural area as described in 27 C.F.R. 9.74 that is
 34 within the State of Oregon;

35 (D) The portion of the Walla Walla Valley viticultural area as described in 27 C.F.R. 9.91 that
 36 is within the State of Oregon; or

37 (E) The portion of the Snake River Valley viticultural area as described in 27 C.F.R. 9.208 that
 38 is within the State of Oregon.

39 (11) "High-value forestland" means land:

40 (a) That is in a forest zone or a mixed farm and forest zone, that is located in western Oregon
 41 and composed predominantly of soils capable of producing more than 120 cubic feet per acre per
 42 year of wood fiber and that is capable of producing more than 5,000 cubic feet per year of com-
 43 mercial tree species; or

44 (b) That is in a forest zone or a mixed farm and forest zone, that is located in eastern Oregon
 45 and composed predominantly of soils capable of producing more than 85 cubic feet per acre per year

1 of wood fiber and that is capable of producing more than 4,000 cubic feet per year of commercial
 2 tree species.

3 (12) "Home site approval" means approval of the subdivision or partition of property or approval
 4 of the establishment of a dwelling on property.

12 (b) A provision in ORS 227.030 to 227.300, 227.350, 227.400, 227.450 or 227.500 or in ORS chapter
 13 215 that restricts the residential use of private real property;

14 (c) A provision of a city comprehensive plan, zoning ordinance or land division ordinance that
 15 restricts the residential use of private real property zoned for residential use;

16 (d) A provision of a county comprehensive plan, zoning ordinance or land division ordinance that
 17 restricts the residential use of private real property;

18 (e) A provision, enacted or adopted on or after January 1, 2010, of:

19 (A) The Oregon Forest Practices Act;

20 (B) An administrative rule of the State Board of Forestry; or

21 (C) Any other law enacted, or rule adopted, solely for the purpose of regulating a forest prac-
 22 tice;

23 (f) ORS 561.191, a provision of ORS 568.900 to 568.933 or an administrative rule of the State
 24 Department of Agriculture that implements ORS 561.191 or 568.900 to 568.933;

25 (g) An administrative rule or goal of the Land Conservation and Development Commission; or

26 (h) A provision of a Metro functional plan that restricts the residential use of private real
 27 property.

28 (15) "Lawfully established unit of land" has the meaning given that term in ORS 92.010.

29 (16) "Lot" has the meaning given that term in ORS 92.010.

30 (17) "Measure 37 permit" means a final decision by Metro, a city or a county to authorize the
 31 development, subdivision or partition or other use of property pursuant to a waiver.

32 (18) "Owner" means:

33 (a) The owner of fee title to the property as shown in the deed records of the county where the
 34 property is located;

35 (b) The purchaser under a land sale contract, if there is a recorded land sale contract in force
 36 for the property; or

37 (c) If the property is owned by the trustee of a revocable trust, the settlor of a revocable trust,
 38 except that when the trust becomes irrevocable only the trustee is the owner.

39 (19) "Parcel" has the meaning given that term in ORS 92.010.

40 (20) "Property" means the private real property described in a claim and contiguous private real
 41 property that is owned by the same owner, whether or not the contiguous property is described in
 42 another claim, and that is not property owned by the federal government, an Indian tribe or a public
 43 body, as defined in ORS 192.311.

44 (21) "Protection of public health and safety" means a law, rule, ordinance, order, policy, permit
 45 or other governmental authorization that restricts a use of property in order to reduce the risk or

 15 of a recreational vehicle, or impose any limit on the length of occupancy of a recreational vehicle

17 propriate entitlements to prepare the land for development.

18 (5) “Government assisted housing” means housing that is financed in whole or part by either a
19 federal or state housing agency or a housing authority as defined in ORS 456.005, or housing that

20 (3) At the time that a city is required to inventory its buildable lands under ORS 197A.270 (2),
 21 197A.280 (2) or 197A.335 (1), the city shall determine its needed housing under this section.

22 (4) In determining needed housing the city must demonstrate that the projected housing types,

24 (a) Attainable for the allocated housing need by income, including consideration of publicly

 31 urban reserves subject to ORS 197.610 to 197.625 and 197.626.

32 (b) Alternatively, Metro and a county or a city and a county may enter into a written agreement
 33 pursuant to ORS 190.003 to 190.130, 195.025 or 197.652 to 197.658 to designate urban reserves. A
 34 process and criteria developed pursuant to this paragraph are an alternative to a process or criteria
 35 adopted pursuant to paragraph (a) of this subsection.

29 (b) Cities that meet factors established by **the** Land Conservation and Development Commission
30 in consideration of the city's size, rate of population growth or proximity to another city with a
31 population of 25,000 or greater or to Metro.

32 (2) A local government shall determine its needed housing under ORS 197A.018 and inventory
33 its buildable lands and determine the lands' housing capacity under this section:

34 (a) At periodic review under ORS 197.628 to 197.651;

35 (b) As scheduled by the commission at least once each eight years; or

36 (c) At any other legislative review of the comprehensive plan that concerns the urban growth
37 boundary and requires the application of a statewide planning goal related to buildable lands for
38 residential use.

39 (3) For the purpose of determining housing capacity and inventory of buildable lands under
40 subsection (2) of this section:

41 (a) "Buildable lands" includes:

42 (A) Vacant lands planned or zoned for residential use;

12 housing capacity must be based on data related to land within the urban growth boundary that has

40 (2) For the purpose of estimating housing needs, as described in ORS 197A.350 (3)(b), Metro shall
 41 adopt findings and perform an analysis that estimates each of the following factors:

42 (a) Projected needed housing units over the next 20 years;

43 (b) Current housing underproduction;

44 (c) Housing units needed for people experiencing homelessness; and

45 (d) Housing units projected to be converted into vacation homes or second homes during the

1 next 20 years.

2 (3) Metro shall make the estimate described in subsection (2) of this section using a shorter time
 3 period than since the last review under ORS 197A.350 (2)(a)(B) if Metro finds that the shorter time
 4 period will provide more accurate and reliable data related to housing need. The shorter time period
 5 may not be less than three years.

6 (4) Metro shall use data from a wider geographic area or use a time period longer than the time
 7 period described in subsection (2) of this section if the analysis of a wider geographic area or the
 8 use of a longer time period will provide more accurate, complete and reliable data relating to trends
 9 affecting housing need than an analysis performed pursuant to subsection (2) of this section. Metro
 10 must clearly describe the geographic area, time frame and source of data used in an estimate per-
 11 formed under this subsection.

12 (5) Subsection (1)(a) and (d) of this section does not apply to a city with a population of less than
 13 2,500.

14 (6) Metro may take an exception under ORS 197.732 to the definition of “needed housing” in
 15 subsection (1) of this section in the same manner that an exception may be taken under the goals.

16 **SECTION 21.** ORS 197A.350 is amended to read:

17 197A.350. (1) This section applies only to Metro.

18 (2)(a) Metro shall demonstrate that its regional framework plan provides sufficient buildable
 19 lands within the urban growth boundary established pursuant to statewide planning goals to ac-
 20 commodate estimated housing needs for 20 years:

21 (A) At periodic review under ORS 197.628 to 197.651;

22 (B) As scheduled by the Land Conservation and Development Commission at least once each six
 23 years; or

24 (C) At any other legislative review of the regional framework plan that concerns the urban
 25 growth boundary and requires the application of a statewide planning goal relating to buildable
 26 lands for residential use.

27 (b) The 20-year period shall commence on the date initially scheduled for completion of the re-
 28 view under paragraph (a) of this subsection.

29 (3) In performing the duties under subsection (2) of this section, Metro shall:

30 (a) Inventory the supply of buildable lands within the urban growth boundary and determine the
 31 housing capacity of the buildable lands; and

32 (b) Conduct an analysis of existing and projected housing need by type and density range, in
 33 accordance with all factors under ORS 197A.348 and statewide planning goals and rules relating to
 34 housing, to determine the number of units and amount of land needed for each needed housing type
 35 for the next 20 years.

36 (4)(a) For the purpose of the inventory described in subsection (3)(a) of this section, “buildable
 37 lands” includes:

38 (A) Vacant lands planned or zoned for residential use;

39 (B) Partially vacant lands planned or zoned for residential use;

40 (C) Lands that may be used for a mix of residential and employment uses under the existing
 41 planning or zoning; and

42 (D) Lands that may be used for residential infill or redevelopment.

43 (b) For the purpose of the inventory and determination of housing capacity described in sub-
 44 section (3)(a) of this section, Metro must demonstrate consideration of:

45 (A) The extent that residential development is prohibited or restricted by local regulation and

1 ordinance, state law and rule or federal statute and regulation;

2 (B) A written long term contract or easement for radio, telecommunications or electrical facili-
3 ties, if the written contract or easement is provided to Metro;

4 (C) The presence of a [*single family*] **single-unit** dwelling or other structure on a lot or parcel;
5 and

6 (D) Factors that influence available housing supply, including short-term rentals, second homes
7 and vacation homes.

8 (c) Except for land that may be used for residential infill or redevelopment, Metro shall create
9 a map or document that may be used to verify and identify specific lots or parcels that have been
10 determined to be buildable lands.

11 (5)(a) Except as provided in paragraphs (b) and (c) of this subsection, the determination of
12 housing capacity pursuant to subsection (3)(a) of this section must be based on data relating to land
13 within the urban growth boundary that has been collected since the last review under subsection
14 (2)(a)(B) of this section. The data shall include:

15 (A) The number, density and average mix of housing types of urban residential development that
16 have actually occurred;

17 (B) Trends in density and average mix of housing types of urban residential development;

18 (C) Market factors that may substantially impact future urban residential development; and

19 (D) The number, density and average mix of housing types that have occurred on the buildable
20 lands described in subsection (4)(a) of this section.

21 (b) Metro shall make the determination described in paragraph (a) of this subsection using a
22 shorter time period than the time period described in paragraph (a) of this subsection if Metro finds
23 that the shorter time period will provide more accurate and reliable data related to housing capac-
24 ity. The shorter time period may not be less than three years.

25 (c) Metro shall use data from a wider geographic area or use a time period longer than the time
26 period described in paragraph (a) of this subsection if the analysis of a wider geographic area or the
27 use of a longer time period will provide more accurate, complete and reliable data relating to trends
28 affecting housing need than an analysis performed pursuant to paragraph (a) of this subsection.
29 Metro must clearly describe the geographic area, time frame and source of data used in a determi-
30 nation performed under this paragraph.

31 (6) If the housing need determined pursuant to subsection (3)(b) of this section is greater than
32 the housing capacity determined pursuant to subsection (3)(a) of this section, Metro shall take one
33 or both of the following actions to accommodate the additional housing need:

34 (a) Amend its urban growth boundary to include sufficient buildable lands to accommodate
35 housing needs for the next 20 years. As part of this process, Metro shall consider the effects of
36 measures taken pursuant to paragraph (b) of this subsection. The amendment shall include sufficient
37 land reasonably necessary to accommodate the siting of new public school facilities. The need and
38 inclusion of lands for new public school facilities shall be a coordinated process between the affected
39 public school districts and Metro that has the authority to approve the urban growth boundary.

40 (b) Amend its regional framework plan, functional plan or land use regulations to include new
41 measures that demonstrably increase the likelihood that residential development will occur at den-
42 sities sufficient to accommodate housing needs for the next 20 years without expansion of the urban
43 growth boundary. If Metro takes this action, Metro shall adopt findings regarding the density ex-
44 pectations assumed to result from measures adopted under this paragraph based upon the factors
45 listed in ORS 197A.348 (2) and data in subsection (5)(a) of this section. The density expectations may

19 (9) In establishing that actions and measures adopted under subsections (6) and (7) of this sec-
 20 tion demonstrably increase the likelihood of higher density residential development, Metro shall at
 21 a minimum ensure that land zoned for needed housing is in locations appropriate for the housing
 22 types identified under subsection (3) of this section, is zoned at density ranges that are likely to be
 23 achieved by the housing market using the analysis in subsection (3) of this section and is in areas
 24 where sufficient urban services are planned to enable the higher density development to occur over
 25 the 20-year period. Actions or measures, or both, may include those actions listed in ORS 197A.100
 26 (3).

27 **SECTION 22.** ORS 197A.370 is amended to read:

28 197A.370. (1) A metropolitan service district organized under ORS chapter 268 shall compile and
 29 report to the Department of Land Conservation and Development on performance measures as de-
 30 scribed in this section at least once every two years. The information shall be reported in a manner
 31 prescribed by the department.

32 (2) Performance measures subject to subsection (1) of this section shall be adopted by a metro-
 33 politan service district and shall include but are not limited to measures that analyze the following:

34 (a) The rate of conversion of vacant land to improved land;

35 (b) The density and price ranges of residential development, including both [*single family and*
 36 *multifamily residential units*] **single-unit and multiunit housing**;

37 (c) The level of job creation within individual cities and the urban areas of a county inside the
 38 metropolitan service district;

39 (d) The number of residential units added to small sites assumed to be developed in the metro-
 40 politan service district's inventory of available lands but which can be further developed, and the
 41 conversion of existing spaces into more compact units with or without the demolition of existing
 42 buildings;

43 (e) The amount of environmentally sensitive land that is protected and the amount of environ-
 44 mentally sensitive land that is developed;

45 (f) The sales price of vacant land;

- 1 (g) Residential vacancy rates;
- 2 (h) Public access to open spaces; and
- 3 (i) Transportation measures including mobility, accessibility and air quality indicators.

4 **SECTION 23.** ORS 197A.395 is amended to read:

5 197A.395. (1) A local government may not prohibit from all residential zones attached or de-
 6 tached [*single-family housing, multifamily housing*] **single-unit or multiunit housing** for both owner
 7 and renter occupancy, manufactured homes or prefabricated structures. A city or county may not
 8 prohibit government assisted housing or impose additional approval standards on government as-
 9 sisted housing that are not applied to similar but unassisted housing.

10 (2)(a) A [*single-family*] **single-unit** dwelling for a farmworker and the farmworker’s immediate
 11 family is a permitted use in any residential or commercial zone that allows [*single-family*] **single-**
 12 **unit** dwellings as a permitted use.

13 (b) A city or county may not impose a zoning requirement on the establishment and maintenance
 14 of a [*single-family*] **single-unit** dwelling for a farmworker and the farmworker’s immediate family in
 15 a residential or commercial zone described in paragraph (a) of this subsection that is more restric-
 16 tive than a zoning requirement imposed on other [*single-family*] **single-unit** dwellings in the same

18 (3)(a) [*Multifamily*] **Multiunit** housing for farmworkers and farmworkers’ immediate families is
 19 a permitted use in any residential or commercial zone that allows [*multifamily*] **multiunit** housing
 20 generally as a permitted use.

21 (b) A city or county may not impose a zoning requirement on the establishment and maintenance
 22 of [*multifamily*] **multiunit** housing for farmworkers and farmworkers’ immediate families in a resi-
 23 dential or commercial zone described in paragraph (a) of this subsection that is more restrictive
 24 than a zoning requirement imposed on other [*multifamily*] **multiunit** housing in the same zone.

25 (4) A city or county may not prohibit a property owner or developer from maintaining a real
 26 estate sales office in a subdivision or planned community containing more than 50 lots or dwelling
 27 units for the sale of lots or dwelling units that remain available for sale to the public.

28 **SECTION 24.** ORS 197A.420 is amended to read:

29 197A.420. (1) As used in this section:

30 (a) “City” or “city with a population of 25,000 or greater” includes, regardless of size, any city
 31 within Tillamook County and the communities of Barview/Twin Rocks/Watseco, Cloverdale, Hebo,
 32 Neahkahnie, Neskowin, Netarts, Oceanside and Pacific City/Woods.

33 (b) “Cottage clusters” means groupings of no fewer than four detached housing units per acre
 34 with a footprint of less than 900 square feet each and that include a common courtyard.

35 (c) “Middle housing” means:

- 36 (A) Duplexes;
- 37 (B) Triplexes;
- 38 (C) Quadplexes;
- 39 (D) Cottage clusters; and
- 40 (E) Townhouses.

41 (d) “Townhouses” means a dwelling unit constructed in a row of two or more attached units,
 42 where each dwelling unit is located on an individual lot or parcel and shares at least one common
 43 wall with an adjacent unit.

44 (2) Except as provided in subsection (4) of this section, each city with a population of 25,000 or
 45 greater and each county or city within a metropolitan service district shall allow the development

1 of:

2 (a) All middle housing types in areas zoned for residential use that allow for the development
3 of detached [*single-family*] **single-unit** dwellings; and

4 (b) A duplex on each lot or parcel zoned for residential use that allows for the development of
5 detached [*single-family*] **single-unit** dwellings.

6 (3) Except as provided in subsection (4) of this section, each city not within a metropolitan
7 service district with a population of 2,500 or greater and less than 25,000 shall allow the develop-
8 ment of a duplex on each lot or parcel zoned for residential use that allows for the development of
9 detached [*single-family*] **single-unit** dwellings. Nothing in this subsection prohibits a local govern-
10 ment from allowing middle housing types in addition to duplexes.

11 (4)(a) Except within Tillamook County, this section does not apply to:

12 (A) Cities with a population of 1,000 or fewer, except inside of Tillamook County;

13 (B) Lands not within an urban growth boundary;

14 (C) Lands that are not incorporated and also lack sufficient urban services, as defined in ORS
15 195.065; or

16 (D) Lands that are not incorporated and are zoned under an interim zoning designation that
17 maintains the land's potential for planned urban development.

18 (b) This section does not apply to lands that are not zoned for residential use, including lands
19 zoned primarily for commercial, industrial, agricultural or public uses.

29 (7) A local government that amends its comprehensive plan or land use regulations relating to
30 allowing additional middle housing is not required to consider whether the amendments significantly
31 affect an existing or planned transportation facility.

32 **SECTION 25.** ORS 197A.425 is amended to read:

33 197A.425. (1)(a) A city with a population greater than 2,500 or a county with a population
34 greater than 15,000 shall allow in areas within the urban growth boundary that are zoned for de-
35 tached [*single-family*] **single-unit** dwellings the development of at least one accessory dwelling unit
36 for each detached [*single-family*] **single-unit** dwelling, subject to reasonable local regulations relat-
37 ing to siting and design.

38 (b) As used in this subsection:

39 (A) "Accessory dwelling unit" means an interior, attached or detached residential structure that
40 is used in connection with or that is accessory to a [*single-family*] **single-unit** dwelling.

41 (B) "Reasonable local regulations relating to siting and design" does not include owner-
42 occupancy requirements of either the primary or accessory structure or requirements to construct
43 additional off-street parking.

44 (2) Subsection (1) of this section does not prohibit local governments from regulating vacation
45 occupancies, as defined in ORS 90.100, to require owner-occupancy or off-street parking.

1 **SECTION 26.** ORS 197A.430 is amended to read:

2 197A.430. (1) As used in this section, “single room occupancy” means a residential development
3 with no fewer than four attached units that are independently rented and lockable and provide liv-
4 ing and sleeping space for the exclusive use of an occupant, but require that the occupant share
5 sanitary or food preparation facilities with other units in the occupancy.

6 (2) Within an urban growth boundary, each local government shall allow the development of a
7 single room occupancy:

8 (a) With up to six units on each lot or parcel zoned to allow for the development of a detached
9 [*single-family*] **single-unit** dwelling; and

10 (b) With the number of units consistent with the density standards of a lot or parcel zoned to
11 allow for the development of residential dwellings with five or more units.

12 **SECTION 27.** ORS 197A.465 is amended to read:

14 (a) “Affordable housing” means housing that is affordable to households with incomes equal to
15 or higher than 80 percent of the median family income for the county in which the housing is built.

16 (b) “[*Multifamily structure*] **Multiunit housing**” means a structure that contains three or more
17 housing units sharing at least one wall, floor or ceiling surface in common with another unit within
18 the same structure.

19 (2) Except as provided in subsection (3) of this section, a metropolitan service district may not
20 adopt a land use regulation or functional plan provision, or impose as a condition for approving a

25 (3) The provisions of subsection (2) of this section do not limit the authority of a metropolitan

27 (a) Adopt or enforce a use regulation, provision or requirement creating or implementing an
28 incentive, contract commitment, density bonus or other voluntary regulation, provision or require-
29 ment designed to increase the supply of moderate or lower cost housing units; or

30 (b) Enter into an affordable housing covenant as provided in ORS 456.270 to 456.295.

31 (4) Notwithstanding ORS 91.225, a city or county may adopt a land use regulation or functional
32 plan provision, or impose as a condition for approving a permit under ORS 215.427 or 227.178 a re-
33 quirement, that has the effect of establishing the sales or rental price for [*a new multifamily struc-*
34 *ture*] **new multiunit housing**, or that requires [*a new multifamily structure*] **new multiunit housing**
35 to be designated for sale or rent as affordable housing.

36 (5) A regulation, provision or requirement adopted or imposed under subsection (4) of this sec-
37 tion:

38 (a) May not require more than 20 percent of **multiunit** housing units [*within a multifamily*
39 *structure*] to be sold or rented as affordable housing.

40 (b) May apply only to [*multifamily structures*] **multiunit housing** containing at least 20 housing
41 units.

42 (c) Must provide developers the option to pay an in-lieu fee, in an amount determined by the city
43 or county, in exchange for providing the requisite number of housing units within the [*multifamily*
44 *structure*] **multiunit housing** to be sold or rented at below-market rates.

45 (d) Must require the city or county to offer a developer of [*multifamily structures*] **multiunit**

1 **housing**, other than a developer that elects to pay an in-lieu fee pursuant to paragraph (c) of this
 2 subsection, at least one of the following incentives:

3 (A) Whole or partial fee waivers or reductions.

4 (B) Whole or partial waivers of system development charges or impact fees set by the city or
 5 county.

6 (C) Finance-based incentives.

7 (D) Full or partial exemption from ad valorem property taxes on the terms described in this
 8 subparagraph. For purposes of any statute granting a full or partial exemption from ad valorem
 9 property taxes that uses a definition of “low income” to mean income at or below 60 percent of the
 10 area median income and for which the [*multifamily structure*] **multiunit housing** is otherwise eligi-
 11 ble, the city or county shall allow the [*multifamily structure*] **multiunit housing** of the developer to
 12 qualify using a definition of “low income” to mean income at or below 80 percent of the area median
 13 income.

14 (e) Does not apply to a CCRC, as defined in ORS 101.020, that executes and records a covenant
 15 with the applicable city or county in which the CCRC agrees to operate all units within its structure
 16 as a CCRC. Units within a CCRC that are offered or converted into residential units that are for
 17 sale or rent and are not subject to ORS chapter 101 must comply with regulations, provisions or
 18 requirements adopted by the city or county that are consistent with those applicable to [*a new*
 19 *multifamily structure*] **new multiunit housing** under subsection (3) or (4) of this section.

20 (6) A regulation, provision or requirement adopted or imposed under subsection (4) of this sec-
 21 tion may offer developers one or more of the following incentives:

22 (a) Density adjustments.

23 (b) Expedited service for local permitting processes.

24 (c) Modification of height, floor area or other site-specific requirements.

25 (d) Other incentives as determined by the city or county.

26 (7) Subsection (4) of this section does not restrict the authority of a city or county to offer de-
 27 velopers voluntary incentives, including incentives to:

28 (a) Increase the number of affordable housing units in a development.

29 (b) Decrease the sale or rental price of affordable housing units in a development.

30 (c) Build affordable housing units that are affordable to households with incomes equal to or
 31 lower than 80 percent of the median family income for the county in which the housing is built.

32 (8)(a) A city or county that adopts or imposes a regulation, provision or requirement described
 33 in subsection (4) of this section may not apply the regulation, provision or requirement to any
 34 [*multifamily structure*] **multiunit housing** for which an application for a permit, as defined in ORS
 35 215.402 or 227.160, has been submitted as provided in ORS 215.416 or 227.178 (3), or, if such a permit
 36 is not required, a building permit application has been submitted to the city or county prior to the

38 (b) If [*a multifamily structure*] **multiunit housing** described in paragraph (a) of this subsection

44 (9)(a) A city or county that adopts or imposes a regulation, provision or requirement under
 45 subsection (4) of this section shall adopt and apply only clear and objective standards, conditions

1 and procedures regulating the development of affordable housing units within its jurisdiction. The
 2 standards, conditions and procedures may not have the effect, either individually or cumulatively,
 3 of discouraging development of affordable housing units through unreasonable cost or delay.

4 (b) Paragraph (a) of this subsection does not apply to:

5 (A) An application or permit for residential development in an area identified in a formally
 6 adopted central city plan, or a regional center as defined by Metro, in a city with a population of
 7 500,000 or more.

8 (B) An application or permit for residential development in historic areas designated for pro-
 9 tection under a land use planning goal protecting historic areas.

10 (c) In addition to an approval process for affordable housing based on clear and objective stan-
 11 dards, conditions and procedures as provided in paragraph (a) of this subsection, a city or county
 12 may adopt and apply an alternative approval process for applications and permits for residential
 13 development based on approval criteria regulating, in whole or in part, appearance or aesthetics
 14 that are not clear and objective if:

15 (A) The developer retains the option of proceeding under the approval process that meets the
 16 requirements of paragraph (a) of this subsection;

17 (B) The approval criteria for the alternative approval process comply with applicable statewide

27 **SECTION 28.** ORS 197A.470 is amended to read:

28 197A.470. (1) As used in this section:

29 (a) “Affordable housing” means housing that is affordable to households with incomes equal to
 30 or less than 60 percent of the median family income for the county in which the development is built
 31 or for the state, whichever is greater, that is subject to an affordable housing covenant, as provided
 32 in ORS 456.270 to 456.295, that maintains the affordability for a period of not less than 60 years from
 33 the date of the certificate of occupancy.

34 (b) “[*Multifamily residential building*] **Multiunit housing**” means a building in which three or
 35 more residential units each have space for eating, living and sleeping and permanent provisions for
 36 cooking and sanitation.

37 (2) Notwithstanding ORS 215.427 (1) or 227.178 (1), a city with a population greater than 5,000
 38 or a county with a population greater than 25,000 shall take final action on an application qualifying
 39 under subsection (3) of this section, including resolution of all local appeals under ORS 215.422 or
 40 227.180, within 100 days after the application is deemed complete.

41 (3) An application qualifies for final action within the timeline described in subsection (2) of this
 42 section if:

43 (a) The application is submitted to the city or the county under ORS 215.416 or 227.175;

44 (b) The application is for development of [*a multifamily residential building*] **multiunit housing**
 45 containing five or more residential units within the urban growth boundary; and

1 (c) At least 50 percent of the residential units included in the development will be sold or rented
2 as affordable housing.

3 (4) A city or a county shall take final action within the time allowed under ORS 215.427 or
4 227.178 on any application for a permit, limited land use decision or zone change that does not
5 qualify for review and decision under subsection (3) of this section, including resolution of all ap-
6 peals under ORS 215.422 or 227.180, as provided by ORS 215.427 and 215.435 or by ORS 227.178 and
7 227.181.

8 (5) With respect to property within an urban growth boundary owned by a nonprofit corporation
9 organized as a religious corporation, a local government:

10 (a) May apply only restrictions or conditions of approval to the development of affordable
11 housing that are, notwithstanding ORS 197A.400 (2) or statewide land use planning goals relating
12 to protections for historic areas:

13 (A) Clear and objective as described in ORS 197A.400 (1); or

14 (B) Discretionary standards related to health, safety, habitability or infrastructure.

15 (b) Shall approve the development of affordable housing on property not zoned for housing if:

16 (A) The property is not zoned for industrial uses; and

17 (B) The property is contiguous to property zoned to allow residential uses.

18 (6) Affordable housing allowed under subsection (5)(b) of this section may be subject only to the
19 restrictions applicable to the contiguously zoned residential property as limited by subsection (5)(a)
20 of this section and without requiring that the property be rezoned for residential uses. If there is
21 more than one contiguous residential property, the zoning of the property with the greatest density
22 applies.

23 **SECTION 29.** ORS 215.203 is amended to read:

24 215.203. (1) Zoning ordinances may be adopted to zone designated areas of land within the
25 county as exclusive farm use zones. Land within such zones shall be used exclusively for farm use
26 except as otherwise provided in ORS 215.213, 215.283 or 215.284. Farm use zones shall be established
27 only when such zoning is consistent with the comprehensive plan.

28 (2)(a) As used in this section, "farm use" means the current employment of land for the primary
29 purpose of obtaining a profit in money by raising, harvesting and selling crops or the feeding,
30 breeding, management and sale of, or the produce of, livestock, poultry, fur-bearing animals or
31 honeybees or for dairying and the sale of dairy products or any other agricultural or horticultural
32 use or animal husbandry or any combination thereof. "Farm use" includes the preparation, storage
33 and disposal by marketing or otherwise of the products or by-products raised on such land for hu-
34 man or animal use. "Farm use" also includes the current employment of land for the primary pur-
35 pose of obtaining a profit in money by stabling or training equines including but not limited to
36 providing riding lessons, training clinics and schooling shows. "Farm use" also includes the propa-
37 gation, cultivation, maintenance and harvesting of aquatic, bird and animal species that are under
38 the jurisdiction of the State Fish and Wildlife Commission, to the extent allowed by the rules
39 adopted by the commission. "Farm use" includes the on-site construction and maintenance of
40 equipment and facilities used for the activities described in this subsection. "Farm use" does not
41 include the use of land subject to the provisions of ORS chapter 321, except land used exclusively
42 for growing cultured Christmas trees or land described in ORS 321.267 (3) or 321.824 (3).

43 (b) As used in this subsection, "current employment" of land for farm use includes:

44 (A) Farmland, the operation or use of which is subject to any farm-related government program;

45 (B) Land lying fallow for one year as a normal and regular requirement of good agricultural

1 husbandry;

2 (C) Land planted in orchards or other perennials, other than land specified in subparagraph (D)
 3 of this paragraph, prior to maturity;

4 (D) Land not in an exclusive farm use zone which has not been eligible for assessment at special
 5 farm use value in the year prior to planting the current crop and has been planted in orchards,
 6 cultured Christmas trees or vineyards for at least three years;

7 (E) Wasteland, in an exclusive farm use zone, dry or covered with water, neither economically
 8 tillable nor grazeable, lying in or adjacent to and in common ownership with a farm use land and
 9 which is not currently being used for any economic farm use;

10 (F) Except for land under a [*single family*] **single-unit** dwelling, land under buildings supporting
 11 accepted farm practices, including the processing facilities allowed by ORS 215.255 and the pro-
 12 cessing of farm crops into biofuel as commercial activities in conjunction with farm use under ORS
 13 215.213 (2)(c) and 215.283 (2)(a);

14 (G) Water impoundments lying in or adjacent to and in common ownership with farm use land;

15 (H) Any land constituting a woodlot, not to exceed 20 acres, contiguous to and owned by the
 16 owner of land specially valued for farm use even if the land constituting the woodlot is not utilized
 17 in conjunction with farm use;

18 (I) Land lying idle for no more than one year where the absence of farming activity is due to
 19 the illness of the farmer or member of the farmer's immediate family. For purposes of this paragraph,
 20 illness includes injury or infirmity whether or not such illness results in death;

21 (J) Any land described under ORS 321.267 (3) or 321.824 (3); and

22 (K) Land used for the processing of farm crops into biofuel, as defined in ORS 315.141, if:

23 (i) Only the crops of the landowner are being processed;

24 (ii) The biofuel from all of the crops purchased for processing into biofuel is used on the farm
 25 of the landowner; or

26 (iii) The landowner is custom processing crops into biofuel from other landowners in the area
 27 for their use or sale.

28 (c) As used in this subsection, "accepted farm practice" means a mode of operation that is
 29 common to farms of a similar nature, necessary for the operation of such farms to obtain a profit
 30 in money, and customarily utilized in conjunction with farm use.

31 (d) As used in this subsection, "cultured Christmas trees" means trees:

32 (A) Grown on lands used exclusively for that purpose, capable of preparation by intensive cul-
 33 tivation methods such as plowing or turning over the soil;

34 (B) Of a marketable species;

35 (C) Managed to meet U.S. No. 2 or better standards for Christmas trees as specified by the
 36 Agriculture Marketing Services of the United States Department of Agriculture; and

37 (D) Evidencing periodic maintenance practices of shearing for Douglas fir and pine species, weed
 38 and brush control and one or more of the following practices: Basal pruning, fertilizing, insect and
 39 disease control, stump culture, soil cultivation or irrigation.

40 **SECTION 30.** ORS 215.213 is amended to read:

41 215.213. (1) In counties that have adopted marginal lands provisions under ORS 197.247 (1991
 42 Edition), the following uses may be established in any area zoned for exclusive farm use:

43 (a) Churches and cemeteries in conjunction with churches.

44 (b) The propagation or harvesting of a forest product.

45 (c) Utility facilities necessary for public service, including wetland waste treatment systems but

1 not including commercial facilities for the purpose of generating electrical power for public use by
2 sale or transmission towers over 200 feet in height. A utility facility necessary for public service
3 may be established as provided in:

4 (A) ORS 215.275; or

5 (B) If the utility facility is an associated transmission line, as defined in ORS 215.274 and
6 469.300.

7 (d) A dwelling on real property used for farm use if the dwelling is occupied by a relative of the
8 farm operator or the farm operator's spouse, which means a child, parent, stepparent, grandchild,
9 grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if the farm
10 operator does or will require the assistance of the relative in the management of the farm use and
11 the dwelling is located on the same lot or parcel as the dwelling of the farm operator.
12 Notwithstanding ORS 92.010 to 92.192 or the minimum lot or parcel size requirements under ORS
13 215.780, if the owner of a dwelling described in this paragraph obtains construction financing or
14 other financing secured by the dwelling and the secured party forecloses on the dwelling, the se-
15 cured party may also foreclose on the homesite, as defined in ORS 308A.250, and the foreclosure
16 shall operate as a partition of the homesite to create a new parcel.

17 (e) Nonresidential buildings customarily provided in conjunction with farm use.

18 (f) Subject to ORS 215.279, primary or accessory dwellings customarily provided in conjunction
19 with farm use. For a primary dwelling, the dwelling must be on a lot or parcel that is managed as
20 part of a farm operation and is not smaller than the minimum lot size in a farm zone with a minimum
21 lot size acknowledged under ORS 197.251.

22 (g) Operations for the exploration for and production of geothermal resources as defined by ORS
23 522.005 and oil and gas as defined by ORS 520.005, including the placement and operation of
24 compressors, separators and other customary production equipment for an individual well adjacent
25 to the wellhead. Any activities or construction relating to such operations shall not be a basis for
26 an exception under ORS 197.732 (2)(a) or (b).

27 (h) Operations for the exploration for minerals as defined by ORS 517.750. Any activities or
28 construction relating to such operations shall not be a basis for an exception under ORS 197.732
29 (2)(a) or (b).

30 (i) One manufactured dwelling or recreational vehicle, or the temporary residential use of an
31 existing building, in conjunction with an existing dwelling as a temporary use for the term of a
32 hardship suffered by the existing resident or a relative of the resident. Within three months of the
33 end of the hardship, the manufactured dwelling or recreational vehicle shall be removed or demol-
34 ished or, in the case of an existing building, the building shall be removed, demolished or returned
35 to an allowed nonresidential use. The governing body or its designee shall provide for periodic re-
36 view of the hardship claimed under this paragraph. A temporary residence approved under this
37 paragraph is not eligible for replacement under paragraph (q) of this subsection.

38 (j) Climbing and passing lanes within the right of way existing as of July 1, 1987.

39 (k) Reconstruction or modification of public roads and highways, including the placement of
40 utility facilities overhead and in the subsurface of public roads and highways along the public right
41 of way, but not including the addition of travel lanes, where no removal or displacement of buildings
42 would occur, or no new land parcels result.

43 (L) Temporary public road and highway detours that will be abandoned and restored to original
44 condition or use at such time as no longer needed.

45 (m) Minor betterment of existing public road and highway related facilities, such as maintenance

1 yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and contiguous
 2 public-owned property utilized to support the operation and maintenance of public roads and high-
 3 ways.

4 (n) A replacement dwelling to be used in conjunction with farm use if the existing dwelling has
 5 been listed in a county inventory as historic property as defined in ORS 358.480.

6 (o) Creation, restoration or enhancement of wetlands.

7 (p) A winery, as described in ORS 215.452 or 215.453.

8 (q) Alteration, restoration or replacement of a lawfully established dwelling, as described in ORS
 9 215.291.

10 (r) Farm stands if:

11 (A) The structures are designed and used for the sale of farm crops or livestock grown on the
 12 farm operation, or grown on the farm operation and other farm operations in the local agricultural
 13 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm
 14 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-
 15 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;
 16 and

17 (B) The farm stand does not include structures designed for occupancy as a residence or for
 18 activity other than the sale of farm crops or livestock and does not include structures for banquets,
 19 public gatherings or public entertainment.

20 (s) An armed forces reserve center, if the center is within one-half mile of a community college.
 21 For purposes of this paragraph, "armed forces reserve center" includes an armory or National
 22 Guard support facility.

23 (t) A site for the takeoff and landing of model aircraft, including such buildings or facilities as
 24 may reasonably be necessary. Buildings or facilities shall not be more than 500 square feet in floor
 25 area or placed on a permanent foundation unless the building or facility preexisted the use approved
 26 under this paragraph. The site shall not include an aggregate surface or hard surface area unless
 27 the surface preexisted the use approved under this paragraph. An owner of property used for the
 28 purpose authorized in this paragraph may charge a person operating the use on the property rent
 29 for the property. An operator may charge users of the property a fee that does not exceed the
 30 operator's cost to maintain the property, buildings and facilities. As used in this paragraph, "model
 31 aircraft" means a small-scale version of an airplane, glider, helicopter, dirigible or balloon that is
 32 used or intended to be used for flight and is controlled by radio, lines or design by a person on the
 33 ground.

34 (u) A facility for the processing of farm products as described in ORS 215.255.

35 (v) Fire service facilities providing rural fire protection services.

36 (w) Irrigation reservoirs, canals, delivery lines and those structures and accessory operational
 37 facilities, not including parks or other recreational structures and facilities, associated with a dis-
 38 trict as defined in ORS 540.505.

39 (x) Utility facility service lines. Utility facility service lines are utility lines and accessory fa-
 40 cilities or structures that end at the point where the utility service is received by the customer and
 41 that are located on one or more of the following:

42 (A) A public right of way;

43 (B) Land immediately adjacent to a public right of way, provided the written consent of all ad-
 44 jacent property owners has been obtained; or

45 (C) The property to be served by the utility.

1 (y) Subject to the issuance of a license, permit or other approval by the Department of Envi-
2 ronmental Quality under ORS 454.695, 459.205, 468B.050, 468B.053 or 468B.055, or in compliance with
3 rules adopted under ORS 468B.095, and as provided in ORS 215.246 to 215.251, the land application
4 of reclaimed water, agricultural or industrial process water or biosolids, or the onsite treatment of
5 septage prior to the land application of biosolids, for agricultural, horticultural or silvicultural pro-
6 duction, or for irrigation in connection with a use allowed in an exclusive farm use zone under this
7 chapter. For the purposes of this paragraph, onsite treatment of septage prior to the land application
8 of biosolids is limited to treatment using treatment facilities that are portable, temporary and
9 transportable by truck trailer, as defined in ORS 801.580, during a period of time within which land
10 application of biosolids is authorized under the license, permit or other approval.

11 (z) Dog training classes or testing trials, which may be conducted outdoors or in farm buildings
12 in existence on January 1, 2019, when:

13 (A) The number of dogs participating in training does not exceed 10 dogs per training class and
14 the number of training classes to be held on-site does not exceed six per day; and

15 (B) The number of dogs participating in a testing trial does not exceed 60 and the number of
16 testing trials to be conducted on-site is limited to four or fewer trials per calendar year.

17 (aa) A cider business, as described in ORS 215.451.

18 (bb) A farm brewery, as described in ORS 215.449.

19 (2) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
20 the following uses may be established in any area zoned for exclusive farm use subject to ORS
21 215.296:

22 (a) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest
23 product on a lot or parcel that is managed as part of a farm operation or woodlot if the farm op-
24 eration or woodlot:

25 (A) Consists of 20 or more acres; and

26 (B) Is not smaller than the average farm or woodlot in the county producing at least \$2,500 in
27 annual gross income from the crops, livestock or forest products to be raised on the farm operation
28 or woodlot.

29 (b) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest
30 product on a lot or parcel that is managed as part of a farm operation or woodlot smaller than re-
31 quired under paragraph (a) of this subsection, if the lot or parcel:

32 (A) Has produced at least \$20,000 in annual gross farm income in two consecutive calendar
33 years out of the three calendar years before the year in which the application for the dwelling was
34 made or is planted in perennials capable of producing upon harvest an average of at least \$20,000
35 in annual gross farm income; or

36 (B) Is a woodlot capable of producing an average over the growth cycle of \$20,000 in gross an-
37 nual income.

38 (c) Commercial activities that are in conjunction with farm use, including the processing of farm
39 crops into biofuel not permitted under ORS 215.203 (2)(b)(K) or 215.255.

40 (d) Operations conducted for:

41 (A) Mining and processing of geothermal resources as defined by ORS 522.005 and oil and gas
42 as defined by ORS 520.005, not otherwise permitted under subsection (1)(g) of this section;

43 (B) Mining, crushing or stockpiling of aggregate and other mineral and other subsurface re-
44 sources subject to ORS 215.298;

45 (C) Processing, as defined by ORS 517.750, of aggregate into asphalt or portland cement; and

1 (D) Processing of other mineral resources and other subsurface resources.

2 (e) Community centers owned by a governmental agency or a nonprofit community organization
 3 and operated primarily by and for residents of the local rural community, hunting and fishing pre-
 4 serves, public and private parks, playgrounds and campgrounds. Subject to the approval of the
 5 county governing body or its designee, a private campground may provide yurts for overnight
 6 camping. No more than one-third or a maximum of 10 campsites, whichever is smaller, may include
 7 a yurt. The yurt shall be located on the ground or on a wood floor with no permanent foundation.
 8 Upon request of a county governing body, the Land Conservation and Development Commission may
 9 provide by rule for an increase in the number of yurts allowed on all or a portion of the
 10 campgrounds in a county if the commission determines that the increase will comply with the stan-
 11 dards described in ORS 215.296 (1). A public park or campground may be established as provided
 12 under ORS 195.120. As used in this paragraph, “yurt” means a round, domed shelter of cloth or
 13 canvas on a collapsible frame with no plumbing, sewage disposal hookup or internal cooking appli-
 14 ance.

15 (f) Golf courses on land determined not to be high-value farmland as defined in ORS 195.300.

16 (g) Commercial utility facilities for the purpose of generating power for public use by sale. If the
 17 area zoned for exclusive farm use is high-value farmland, a photovoltaic solar power generation fa-
 18 cility may be established as a commercial utility facility as provided in ORS 215.447. A renewable
 19 energy facility as defined in ORS 215.446 may be established as a commercial utility facility.

20 (h) Personal-use airports for airplanes and helicopter pads, including associated hangar, main-
 21 tenance and service facilities. A personal-use airport as used in this section means an airstrip re-
 22 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional
 23 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-
 24 erations. No aircraft may be based on a personal-use airport other than those owned or controlled
 25 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be
 26 granted through waiver action by the Oregon Department of Aviation in specific instances. A
 27 personal-use airport lawfully existing as of September 13, 1975, shall continue to be permitted sub-
 28 ject to any applicable rules of the Oregon Department of Aviation.

29 (i) A facility for the primary processing of forest products, provided that such facility is found
 30 to not seriously interfere with accepted farming practices and is compatible with farm uses de-
 31 scribed in ORS 215.203 (2). Such a facility may be approved for a one-year period which is
 32 renewable. These facilities are intended to be only portable or temporary in nature. The primary
 33 processing of a forest product, as used in this section, means the use of a portable chipper or stud
 34 mill or other similar methods of initial treatment of a forest product in order to enable its shipment
 35 to market. Forest products, as used in this section, means timber grown upon a parcel of land or
 36 contiguous land where the primary processing facility is located.

37 (j) A site for the disposal of solid waste approved by the governing body of a city or county or
 38 both and for which a permit has been granted under ORS 459.245 by the Department of Environ-
 39 mental Quality together with equipment, facilities or buildings necessary for its operation.

40 (k)(A) Commercial dog boarding kennels; or

41 (B) Dog training classes or testing trials that cannot be established under subsection (1)(z) of
 42 this section.

43 (L) Residential homes as defined in ORS 197.660, in existing dwellings.

44 (m) The propagation, cultivation, maintenance and harvesting of aquatic species that are not
 45 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species

1 shall not include any species under quarantine by the State Department of Agriculture or the United
 2 States Department of Agriculture. The county shall provide notice of all applications under this
 3 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the
 4 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-
 5 tive decision or initial public hearing on the application.

6 (n) Home occupations as provided in ORS 215.448.

7 (o) Transmission towers over 200 feet in height.

8 (p) Construction of additional passing and travel lanes requiring the acquisition of right of way
 9 but not resulting in the creation of new land parcels.

10 (q) Reconstruction or modification of public roads and highways involving the removal or dis-
 11 placement of buildings but not resulting in the creation of new land parcels.

12 (r) Improvement of public road and highway related facilities such as maintenance yards, weigh
 13 stations and rest areas, where additional property or right of way is required but not resulting in
 14 the creation of new land parcels.

15 (s) A destination resort that is approved consistent with the requirements of any statewide
 16 planning goal relating to the siting of a destination resort.

17 (t) Room and board arrangements for a maximum of five unrelated persons in existing resi-
 18 dences.

19 (u) A living history museum related to resource based activities owned and operated by a gov-
 20 ernmental agency or a local historical society, together with limited commercial activities and fa-
 21 cilities that are directly related to the use and enjoyment of the museum and located within
 22 authentic buildings of the depicted historic period or the museum administration building, if areas
 23 other than an exclusive farm use zone cannot accommodate the museum and related activities or if
 24 the museum administration buildings and parking lot are located within one quarter mile of the
 25 metropolitan urban growth boundary. As used in this paragraph:

26 (A) "Living history museum" means a facility designed to depict and interpret everyday life and
 27 culture of some specific historic period using authentic buildings, tools, equipment and people to
 28 simulate past activities and events; and

29 (B) "Local historical society" means the local historical society, recognized as such by the
 30 county governing body and organized under ORS chapter 65.

31 (v) Operations for the extraction and bottling of water.

32 (w) An aerial fireworks display business that has been in continuous operation at its current
 33 location within an exclusive farm use zone since December 31, 1986, and possesses a wholesaler's
 34 permit to sell or provide fireworks.

35 (x) A landscape contracting business, as defined in ORS 671.520, or a business providing land-
 36 scape architecture services, as described in ORS 671.318, if the business is pursued in conjunction
 37 with the growing and marketing of nursery stock on the land that constitutes farm use.

38 (y) Public or private schools for kindergarten through grade 12, including all buildings essential
 39 to the operation of a school, primarily for residents of the rural area in which the school is located.

40 (z) Equine and equine-affiliated therapeutic and counseling activities, provided:

41 (A) The activities are conducted in existing buildings that were lawfully constructed on the
 42 property before January 1, 2019, or in new buildings that are accessory, incidental and subordinate
 43 to the farm use on the tract; and

44 (B) All individuals conducting therapeutic or counseling activities are acting within the proper
 45 scope of any licenses required by the state.

1 (aa) Child care facilities, preschool recorded programs or school-age recorded programs that are:

2 (A) Authorized under ORS 329A.250 to 329A.450;

3 (B) Primarily for the children of residents and workers of the rural area in which the facility
4 or program is located; and

5 (C) Colocated with a community center or a public or private school allowed under this sub-
6 section.

7 (3) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
8 a [*single-family*] **single-unit** residential dwelling not provided in conjunction with farm use may be
9 established on a lot or parcel with soils predominantly in capability classes IV through VIII as de-
10 termined by the Agricultural Capability Classification System in use by the United States Depart-
11 ment of Agriculture Soil Conservation Service on October 15, 1983. A proposed dwelling is subject
12 to approval of the governing body or its designee in any area zoned for exclusive farm use upon
13 written findings showing all of the following:

14 (a) The dwelling or activities associated with the dwelling will not force a significant change in
15 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use.

16 (b) The dwelling is situated upon generally unsuitable land for the production of farm crops and
17 livestock, considering the terrain, adverse soil or land conditions, drainage and flooding, location
18 and size of the tract. A lot or parcel shall not be considered unsuitable solely because of its size
19 or location if it can reasonably be put to farm use in conjunction with other land.

20 (c) Complies with such other conditions as the governing body or its designee considers neces-
21 sary.

22 (4) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
23 one [*single-family*] **single-unit** dwelling, not provided in conjunction with farm use, may be estab-
24 lished in any area zoned for exclusive farm use on a lot or parcel described in subsection (7) of this
25 section that is not larger than three acres upon written findings showing:

26 (a) The dwelling or activities associated with the dwelling will not force a significant change in
27 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use;

28 (b) If the lot or parcel is located within the Willamette River Greenway, a floodplain or a
29 geological hazard area, the dwelling complies with conditions imposed by local ordinances relating
30 specifically to the Willamette River Greenway, floodplains or geological hazard areas, whichever is
31 applicable; and

32 (c) The dwelling complies with other conditions considered necessary by the governing body or
33 its designee.

34 (5) Upon receipt of an application for a permit under subsection (4) of this section, the governing
35 body shall notify:

36 (a) Owners of land that is within 250 feet of the lot or parcel on which the dwelling will be es-
37 tablished; and

38 (b) Persons who have requested notice of such applications and who have paid a reasonable fee
39 imposed by the county to cover the cost of such notice.

40 (6) The notice required in subsection (5) of this section shall specify that persons have 15 days
41 following the date of postmark of the notice to file a written objection on the grounds only that the
42 dwelling or activities associated with it would force a significant change in or significantly increase
43 the cost of accepted farming practices on nearby lands devoted to farm use. If no objection is re-
44 ceived, the governing body or its designee shall approve or disapprove the application. If an ob-
45 jection is received, the governing body shall set the matter for hearing in the manner prescribed in

1 ORS 215.402 to 215.438. The governing body may charge the reasonable costs of the notice required

4 (7) Subsection (4) of this section applies to a lot or parcel lawfully created between January 1,
 5 1948, and July 1, 1983. For the purposes of this section:

6 (a) Only one lot or parcel exists if:

7 (A) A lot or parcel described in this section is contiguous to one or more lots or parcels de-
 8 scribed in this section; and

9 (B) On July 1, 1983, greater than possessory interests are held in those contiguous lots, parcels
 10 or lots and parcels by the same person, spouses or a single partnership or business entity, separately
 11 or in tenancy in common.

12 (b) "Contiguous" means lots, parcels or lots and parcels that have a common boundary, including
 13 but not limited to, lots, parcels or lots and parcels separated only by a public road.

14 (8) A person who sells or otherwise transfers real property in an exclusive farm use zone may
 15 retain a life estate in a dwelling on that property and in a tract of land under and around the
 16 dwelling.

17 (9) No final approval of a nonfarm use under this section shall be given unless any additional

19 (10) Roads, highways and other transportation facilities and improvements not allowed under

 21 body or its designee, in areas zoned for exclusive farm use subject to:

 23 goal with which the facility or improvement does not comply; or

26 (11) The following agri-tourism and other commercial events or activities that are related to and
 27 supportive of agriculture may be established in any area zoned for exclusive farm use:

28 (a) A county may authorize a single agri-tourism or other commercial event or activity on a
 29 tract in a calendar year by an authorization that is personal to the applicant and is not transferred
 30 by, or transferable with, a conveyance of the tract, if the agri-tourism or other commercial event
 31 or activity meets any local standards that apply and:

32 (A) The agri-tourism or other commercial event or activity is incidental and subordinate to ex-
 33 isting farm use on the tract;

34 (B) The duration of the agri-tourism or other commercial event or activity does not exceed 72
 35 consecutive hours;

36 (C) The maximum attendance at the agri-tourism or other commercial event or activity does not
 37 exceed 500 people;

38 (D) The maximum number of motor vehicles parked at the site of the agri-tourism or other
 39 commercial event or activity does not exceed 250 vehicles;

40 (E) The agri-tourism or other commercial event or activity complies with ORS 215.296;

41 (F) The agri-tourism or other commercial event or activity occurs outdoors, in temporary
 42 structures, or in existing permitted structures, subject to health and fire and life safety require-
 43 ments; and

44 (G) The agri-tourism or other commercial event or activity complies with conditions established
 45 for:

- 1 (i) Planned hours of operation;
- 2 (ii) Access, egress and parking;
- 3 (iii) A traffic management plan that identifies the projected number of vehicles and any antic-
- 4 ipated use of public roads; and
- 5 (iv) Sanitation and solid waste.
- 6 (b) In the alternative to paragraphs (a) and (c) of this subsection, a county may authorize,
- 7 through an expedited, single-event license, a single agri-tourism or other commercial event or ac-
- 8 tivity on a tract in a calendar year by an expedited, single-event license that is personal to the ap-
- 9 plicant and is not transferred by, or transferable with, a conveyance of the tract. A decision
- 10 concerning an expedited, single-event license is not a land use decision, as defined in ORS 197.015.
- 11 To approve an expedited, single-event license, the governing body of a county or its designee must
- 12 determine that the proposed agri-tourism or other commercial event or activity meets any local

- 27 local standards that apply, and the agri-tourism or other commercial events or activities:

4 erty owner is sited on the property;

5 (c) There are no other dwelling units on the property and no portion of the [*single-family*]
6 **single-unit** dwelling is rented as a residential tenancy;

7 (d) The property owner will not allow the use of the recreational vehicle space or recreational
8 vehicle for vacation occupancy, as defined in ORS 90.100, or other short-term uses;

9 (e) The recreational vehicle is owned or leased by the tenant; and

10 (f) The property owner will provide essential services to the recreational vehicle space, as de-
11 scribed in ORS 90.100 (15)(b).

12 (3) A county may require that an owner of a lot or parcel who sites a recreational vehicle under
13 this section:

14 (a) Register the use with the county.

15 (b) Enter into a written residential rental agreement with the tenant of the recreational vehicle.

16 (c) Limit the amount of payments that the property owner may accept from the tenant under
17 ORS 90.140 to those reasonably necessary to cover the owner's costs or losses.

18 (d) Require that the recreational vehicle comply with any reasonable appearance, repair, in-

42 will be a well using water under ORS 537.545 (1)(b) or (d), no portion of the lot or parcel is within
43 an area in which new or existing ground water uses under ORS 537.545 (1)(b) or (d) have been re-
44 stricted by the Water Resources Commission;

45 (i) No portion of the lot or parcel is within a designated area of critical state concern;

1 (j) The lot or parcel is served by a fire protection service provider with professionals who have

(b) A local government may not enact or enforce a land use regulation prohibiting the use of a residential dwelling, located in an area zoned for residential or commercial use, as a family child care home.

(c) A local government may not impose land use regulations, special fees or conditions on the establishment or maintenance of a family child care home more restrictive than those imposed on other residential dwellings in the same zone.

(3) Notwithstanding subsection (2)(c) of this section, a county may impose reasonable conditions on the establishment of a family child care home in an area zoned for farm use.

(4)(a) A child care center is a permitted use in all areas zoned for commercial or industrial use, except areas specifically designated by the local government for heavy industrial use.

(b) A local government may not impose land use regulations, special fees or conditions on the establishment or maintenance of a child care center in an area zoned for commercial or industrial use that are more restrictive than those imposed for other uses in the same zone.

(5) Notwithstanding subsection (4) of this section, a local government may impose reasonable conditions upon the establishment or maintenance of a child care center in an area zoned for industrial uses.

(6) As used in this section, “reasonable conditions” includes, but is not limited to, siting restrictions for properties designated on the Department of Environmental Quality’s statewide list of contaminated properties as having known or suspected releases of hazardous substances.

SECTION 45. ORS 418.960 is amended to read:

(1) Each city and county may adopt a procedure which will provide opportunities for the siting of child-caring facilities within its jurisdiction including the siting of such facilities in [*single-family*] **single-unit** residential zones.
