

# A-Engrossed House Bill 3187

Ordered by the House April 24  
Including House Amendments dated April 24

Sponsored by Representative KOMP

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Extends terms of office of members of Commission for the Blind.  
*[Declares emergency, effective on passage.]*

## A BILL FOR AN ACT

1  
2 Relating to the Commission for the Blind; creating new provisions; and amending ORS 346.130.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 346.130 is amended to read:

5 346.130. (1) The Commission for the Blind shall be appointed by the Governor and shall consist  
6 of **the following** seven members:

7 (a) Four members who are qualified persons within the legal definition of persons who are blind;  
8 and

9 (b) Three members appointed from among the areas of employers, labor, optometry,  
10 ophthalmology, and education of persons who are blind. However, no more than one appointee shall  
11 represent the same area during the same term. To the greatest extent possible, appointments from  
12 the five areas shall be made on a rotating basis.

13 (2) The term of office of a member of the commission is *[two]* **four** years. Vacancy in the office  
14 of a member shall be filled by the Governor for the unexpired term. Any member who is absent from  
15 three consecutive commission meetings or more than one-third of the scheduled meetings in one year  
16 shall be removed from office and the Governor shall fill the vacancy for the unexpired term. A  
17 person may not serve on the commission for more than three consecutive terms *[of one year or more*  
18 *in length]*. **A person who serves two years or more of a term shall be considered to have**  
19 **served a full term.**

20 (3) All appointments of members of the commission by the Governor are subject to confirmation  
21 by the Senate in the manner provided in ORS 171.562 and 171.565.

22 (4) The commission shall hold meetings at least once every two months and such additional  
23 meetings as it may deem necessary.

24 (5) Each member is entitled to compensation and expenses as provided in ORS 292.495.

25 **SECTION 2.** **Notwithstanding ORS 346.130 (2), a person may serve on the Commission for**  
26 **the Blind for more than three consecutive terms if:**

27 (1) **The person is serving a term on the effective date of this 2015 Act or had served a**  
28 **term prior to the effective date of this 2015 Act; and**

**(2) The person does not serve on the commission for more than 12 consecutive years.**
