

HOUSE AMENDMENTS TO HOUSE BILL 3464

1 On page 1 of the printed bill, delete lines 4 through 30.

2 On page 2, delete lines 1 through 7 and insert:

3 **“SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 414.**

4 **“SECTION 2. (1) The Oregon Health Authority shall prescribe by rule appropriate time**
5 **frames within which a pregnant medical assistance recipient who needs general or specialty**
6 **dental care must have the opportunity to be seen, or referred for, and provided:**

7 **“(a) Emergency dental services;**

8 **“(b) Urgent dental services; and**

9 **“(c) Routine dental services.**

10 **“(2) The time frames prescribed by the authority for recipients whose medical assistance**
11 **is reimbursed on a fee-for-service basis shall be consistent with the time frames for recipi-**
12 **ents enrolled in coordinated care organizations and dental care organizations.**

13 **“(3) The authority shall adopt a procedure to ensure that a pregnant medical assistance**
14 **recipient who is not enrolled in a coordinated care organization or a dental care organization**
15 **has the opportunity to receive a dental screening within 30 days after the recipient reports**
16 **to the authority that she is pregnant.**

17 **“SECTION 3. (1) The Oregon Health Authority shall adopt procedures to ensure that the**
18 **authority collects and processes the information necessary to determine if the requirements**
19 **of section 2 of this 2015 Act are met.**

20 **“(2) No later than December 1, 2016, the authority shall report to the Legislative As-**
21 **sembly, in the manner provided by ORS 192.245, on:**

22 **“(a) Whether the wait times for pregnant women to be seen, or referred for, and provided**
23 **dental care are in accordance with the rules prescribed by the authority under section 2 of**
24 **this 2015 Act; and**

25 **“(b) The effectiveness of the procedure adopted by the authority under section 2 of this**
26 **2015 Act to ensure that a pregnant medical assistance recipient who is not enrolled in a co-**
27 **ordinated care organization or a dental care organization has the opportunity to receive a**
28 **dental screening within 30 days after the recipient reports to the authority that she is**
29 **pregnant.**

30 **“SECTION 4. (1) Section 2 of this 2015 Act becomes operative on January 1, 2016.**

31 **“(2) The Oregon Health Authority shall take any action before the operative date speci-**
32 **fied in subsection (1) of this section that is necessary for the authority to implement the**
33 **requirements of section 2 of this 2015 Act on and after the operative date specified in sub-**
34 **section (1) of this section.”.**

35 In line 8, delete “2” and insert “5” and delete “1” and insert “3” and delete “December 31,
