SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Oregon Health Authority to adopt rules prescribing time frames within which pregnant medical assistance recipient receives dental services [*and to adopt procedure to ensure that pregnant medical assistance recipient who is not enrolled in managed care organization receives dental screening within specified time frame*]. Requires authority to collect data and report to Legislative Assembly on [*implementation of requirements*] **compliance with rules**. Sunsets January 2, 2017.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to health care; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2015 Act is added to and made a part of ORS chapter 414.**

5 **SECTION 2. (1) The Oregon Health Authority shall prescribe by rule appropriate time**
6 **frames within which a pregnant medical assistance recipient whose medical assistance is**
7 **reimbursed on a fee-for-service basis and who needs general or specialty dental care must**
8 **have the opportunity to be seen, or referred for, and provided:**

9 (a) **Emergency dental services;**

10 (b) **Urgent dental services; and**

11 (c) **Routine dental services.**

12 (2) **The time frames prescribed by the authority for recipients whose medical assistance**
13 **is reimbursed on a fee-for-service basis shall be consistent with the time frames for pregnant**
14 **recipients enrolled in coordinated care organizations and dental care organizations.**

15 **SECTION 3. (1) The Oregon Health Authority shall adopt procedures to ensure that the**
16 **authority collects and processes the information necessary to determine if the requirements**
17 **of section 2 of this 2015 Act are met.**

18 (2) **No later than December 1, 2016, the authority shall report to the Legislative Assem-**
19 **ply, in the manner provided by ORS 192.245, on whether the wait times for pregnant women**
20 **to be seen, or referred for, and provided dental care are in accordance with the rules pre-**
21 **scribed by the authority under section 2 of this 2015 Act.**

22 **SECTION 4. (1) Section 2 of this 2015 Act becomes operative on January 1, 2016.**

23 (2) **The Oregon Health Authority shall take any action before the operative date specified**
24 **in subsection (1) of this section that is necessary for the authority to implement the re-**
25 **quirements of section 2 of this 2015 Act on and after the operative date specified in sub-**

2 **SECTION 5. Section 3 of this 2015 Act is repealed on January 2, 2017.**

3 **SECTION 6. This 2015 Act being necessary for the immediate preservation of the public**
4 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**
5 **on its passage.**
