## B-Engrossed Senate Bill 1013

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes future dangerousness as factor for jury to determine when deciding on sentence of death. Requires state to prove beyond reasonable doubt that defendant should receive death sentence.

Redefines crime of aggravated murder. Reclassifies current manners of committing aggravated murder as murder in the first degree. Renames crime of murder to murder in the second degree. Specifies penalties.

Provides that attempted aggravated murder constitutes Class A felony.

Takes effect on 91st day following adjournment sine die.

14 **(a) Intimidate, injure or coerce a civilian population;**

15 **(b) Influence the policy of a government by intimidation or coercion; or**

16 **(c) Affect the conduct of a government through destruction of property, murder, kid-**  
17 **napping or aircraft piracy; or**

18 **(2) Murder in the second degree, as defined in ORS 163.115, that is:**

19 **(a)(A) Committed while the defendant was confined in a state, county or municipal penal**  
20 **or correctional facility or was otherwise in custody; and**

21 **(B) Committed after the defendant was previously convicted in any jurisdiction of any**  
22 **homicide, the elements of which constitute the crime of aggravated murder under this sec-**  
23 **tion or murder in the first degree under section 3 of this 2019 Act;**

32 (L) The murder was committed after the defendant had escaped from a state, county or  
33 municipal penal or correctional facility and before the defendant had been returned to the  
34 custody of the facility.

35 (2)(a) Except as otherwise provided in ORS 163.155 and paragraph (b) of this subsection,  
36 the court shall sentence a person convicted of murder in the first degree, who was at least  
37 15 years of age at the time of committing the murder, to life imprisonment. The court shall  
38 order that the defendant be confined for a minimum of 30 years without possibility of parole,  
39 release to post-prison supervision, release on work release or any form of temporary leave  
40 or employment at a forest or work camp.

41 (b) The court may sentence the person to life imprisonment without the possibility of  
42 parole if the person was at least 18 years of age at the time of committing the murder. The  
43 court shall state on the record the reasons for imposing the sentence. A person sentenced  
44 to life imprisonment without the possibility of release or parole under this paragraph shall  
45 not have that sentence suspended, deferred or commuted by any judicial officer, and the

1 State Board of Parole and Post-Prison Supervision may not parole the prisoner nor reduce  
2 the period of confinement in any manner whatsoever. The Department of Corrections or any  
3 executive official may not permit the prisoner to participate in any sort of release or  
4 furlough program.

5 (3)(a) For a person sentenced to life imprisonment, at any time after completion of the  
6 minimum period of confinement described in subsection (2)(a) of this section, the State Board  
7 of Parole and Post-Prison Supervision, upon the petition of a prisoner so confined, shall hold  
8 a hearing to determine if the prisoner is likely to be rehabilitated within a reasonable period  
9 of time. The sole issue is whether the prisoner is likely to be rehabilitated within a reason-  
10 able period of time. At the hearing the prisoner has:

11 (A) The burden of proving by a preponderance of the evidence the likelihood of rehabili-  
12 tation within a reasonable period of time;

13 (B) The right, if the prisoner is without sufficient funds to employ an attorney, to be  
14 represented by legal counsel, appointed by the board, at board expense; and

15 (C) The right to a subpoena upon a showing of the general relevance and reasonable  
16 scope of the evidence sought, provided that any subpoena issued on behalf of the prisoner  
17 must be issued by the State Board of Parole and Post-Prison Supervision pursuant to rules  
18 adopted by the board.

19 (b) If, upon hearing all of the evidence, the board, upon a unanimous vote of three board  
20 members or, if the chairperson requires all voting members to participate, a unanimous vote  
21 of all voting members, finds that the prisoner is capable of rehabilitation and that the terms  
22 of the prisoner's confinement should be changed to life imprisonment with the possibility of  
23 parole, release to post-prison supervision or work release, it shall enter an order to that ef-  
24 fect and the order shall convert the terms of the prisoner's confinement to life imprisonment  
25 with the possibility of parole, release to post-prison supervision or work release and may set  
26 a release date. Otherwise, the board shall deny the relief sought in the petition.

27 (c) If the board denies the relief sought in the petition, the board shall determine the  
28 date of the subsequent hearing, and the prisoner may petition for an interim hearing, in ac-  
29 cordance with ORS 144.285.

30 (d) The board's final order shall be accompanied by findings of fact and conclusions of  
31 law. The findings of fact shall consist of a concise statement of the underlying facts sup-  
32 porting the findings as to each contested issue of fact and as to each ultimate fact required  
33 to support the board's order.

29 fendant be confined for a minimum of 30 years without possibility of parole[,] **or** release to post-  
30 prison supervision **except as provided in section 25, chapter \_\_\_\_\_, Oregon Laws 2019**  
31 **(Enrolled Senate Bill 1008), and without the possibility of** release on work release or any form  
32 of temporary leave or employment at a forest or work camp.

33 (b) The court may sentence the person to life imprisonment without the possibility of parole if  
34 the person was at least 18 years of age at the time of committing the murder. The court shall state  
35 on the record the reasons for imposing the sentence. A person sentenced to life imprisonment  
36 without the possibility of release or parole under this paragraph shall not have that sentence sus-  
37 pended, deferred or commuted by any judicial officer, and the State Board of Parole and Post-Prison  
38 Supervision may not parole the prisoner nor reduce the period of confinement in any manner what-  
39 soever. The Department of Corrections or any executive official may not permit the prisoner to  
40 participate in any sort of release or furlough program.

41 (3)(a) For a person sentenced to life imprisonment, at any time after completion of the minimum  
42 period of confinement described in subsection (2)(a) of this section, the State Board of Parole and  
43 Post-Prison Supervision, upon the petition of a prisoner so confined, shall hold a hearing to deter-  
44 mine if the prisoner is likely to be rehabilitated within a reasonable period of time. The sole issue

15 to post-prison supervision or work release and may set a release date. Otherwise, the board shall  
16 deny the relief sought in the petition.

10 under 18 years of age, who is serving a sentence of imprisonment for the offense or offenses, is eli-

27 opportunity to be released on parole or post-prison supervision.

28 (4) The board may require the person, before holding a hearing described in this section, to be  
29 examined by a psychiatrist or psychologist with expertise in adolescent development. Within 60 days  
30 of the evaluation, the examining psychiatrist or psychologist shall file a written report of the  
31 findings and conclusions of the examination with the board. A certified copy of the report shall be  
32 provided to the person and the person’s attorney.

36 also consider the following circumstances, if relevant to the specific person and offense:

37 (a) The age and immaturity of the person at the time of the offense.

38 (b) Whether and to what extent an adult was involved in the offense.

39 (c) The person’s family and community circumstances at the time of the offense, including any  
40 history of abuse, trauma and involvement in the juvenile dependency system.

41 (d) The person’s subsequent emotional growth and increased maturity during the person’s  
42 imprisonment.

43 (e) The person’s participation in rehabilitative and educational programs while in custody if  
44 such programs have been made available to the person and use of self-study for self-improvement.

45 (f) A mental health diagnosis.

1 (g) Any other mitigating factors or circumstances presented by the person.

2 (6) Under no circumstances may the board consider the age of the person as an aggravating  
3 factor.

4 (7) If the board finds that, based on the consideration of the age and immaturity of the person  
5 at the time of the offense and the person's behavior thereafter, the person has demonstrated matu-  
6 rity and rehabilitation, the board shall release the person as follows:

7 (a) For a person sentenced under ORS 163.105, 163.115 or 163.155 **or section 3 of this 2019**  
8 **Act**, the board shall set a release date that is not more than 60 days from the date of the hearing  
9 and, notwithstanding section 28, chapter 790, Oregon Laws 1989, the person shall be released on  
10 parole in accordance with ORS 144.125, 144.260 and 144.270.

11 (b) A person sentenced to a term of imprisonment under a provision of law other than ORS  
12 163.105, 163.115 or 163.155 **or section 3 of this 2019 Act** shall be released on post-prison supervision  
13 in accordance with ORS 144.096 and 144.098 within 60 days of the date of the hearing.

14 (8) Unless the context requires otherwise, the provisions of ORS 144.260 to 144.380 apply to a  
15 person released on parole under subsection (7)(a) of this section.

16 (9) If the board determines that the person has not demonstrated maturity and rehabilitation  
17 under subsection (7) of this section, the board may postpone a subsequent hearing to a date that is  
18 at least two years but no more than 10 years from the date of the hearing.

19 (10) The person may waive a hearing under this section. Notwithstanding waiver of the hearing,  
20 the board shall hold a hearing under this section upon the person's written request.

21 (11) The board shall provide notice of the hearing to:

22 (a) The district attorney of the county in which the person was convicted; and

23 (b) The victim of any offense for which the person is serving a sentence, if the victim requests  
24 to be notified and furnishes the board with a current address.

25 (12) A person has the right to counsel, including counsel appointed at board expense, at a  
26 hearing under this section.

27 (13) The board may adopt rules to carry out the provisions of this section.

44 *[(a) Murder under ORS 163.115 or section 3 of this 2019 Act or any aggravated form thereof;]*

45 *[(b)] (A) A Class A or Class B felony;*

2 [(A)] (i) Escape in the second degree under ORS 162.155;

3 [(B)] (ii) Assault in the third degree under ORS 163.165;

4 [(C)] (iii) Coercion under ORS 163.275 (1)(a);

43 (a) When it is committed intentionally, except that it is an affirmative defense that, at the time  
44 of the homicide, the defendant was under the influence of an extreme emotional disturbance;

45 (b) When it is committed by a person, acting either alone or with one or more persons, who

1 commits or attempts to commit any of the following crimes and in the course of and in furtherance  
2 of the crime the person is committing or attempting to commit, or during the immediate flight  
3 therefrom, the person, or another participant if there be any, causes the death of a person other  
4 than one of the participants:

5 (A) Arson in the first degree as defined in ORS 164.325;

6 (B) Criminal mischief in the first degree by means of an explosive as defined in ORS 164.365;

7 (C) Burglary in the first degree as defined in ORS 164.225;

8 (D) Escape in the first degree as defined in ORS 162.165;

9 (E) Kidnapping in the second degree as defined in ORS 163.225;

10 (F) Kidnapping in the first degree as defined in ORS 163.235;

11 (G) Robbery in the first degree as defined in ORS 164.415;

12 (H) Any felony sexual offense in the first degree defined in this chapter;

13 (I) Compelling prostitution as defined in ORS 167.017; or

14 (J) Assault in the first degree, as defined in ORS 163.185, and the victim is under 14 years of  
15 age, or assault in the second degree, as defined in ORS 163.175 (1)(a) or (b), and the victim is under  
16 14 years of age; or

17 (c) By abuse when a person, recklessly under circumstances manifesting extreme indifference to  
18 the value of human life, causes the death of a child under 14 years of age or a dependent person,  
19 as defined in ORS 163.205, and:

20 (A) The person has previously engaged in a pattern or practice of assault or torture of the vic-  
21 tim or another child under 14 years of age or a dependent person; or

39 163.150. (1)(a) Upon a finding that the defendant is guilty of aggravated murder, the court, ex-  
40 cept as otherwise provided in subsection (3) of this section, shall conduct a separate sentencing  
41 proceeding to determine whether the defendant shall be sentenced to life imprisonment, as described  
42 in ORS 163.105 (1)(c), life imprisonment without the possibility of release or parole, as described in

29 (b) Notwithstanding paragraph (a) of this subsection, of a crime described in ORS 163.465,  
30 163.467, 163.700, 163.701, 164.055, 164.125 or 164.377, the date of conviction for which was within the  
31 five years immediately preceding employment in any capacity of an individual, other than a mental  
32 health or substance abuse treatment provider, having contact with a recipient of support services,  
33 a resident of a residential facility or a resident of an adult foster home, when the recipient or resi-  
34 dent is 65 years of age or older;

2 (j) Fails to provide evidence of workers' compensation coverage as described in ORS 671.565.

3 (k) Violates a voluntary compliance agreement entered into under ORS 336.184 and 646.605 to  
4 646.652.

5 (L) Performs work for which a permit is required under the state building code without obtain-  
6 ing the required permit, if the work results in the filing of a claim with the board.

7 (m) Violates a rule or order of the board.

8 (n) Refuses to comply with a subpoena issued by the board.

9 (o) Fails to pay in full any amount owed to a claimant under a final order of the board or an  
10 arbitration award, or under a judgment rendered in this or any other state.

11 (p) Does not make payment, including any interest due, for labor or materials contracted for by  
12 the person pursuant to a contract for a public improvement within 90 days after the date the person  
13 receives payment from a public contracting agency or, if the person is a subcontractor, from the  
14 contractor.

15 (q) Engages in conduct as a landscape construction professional or landscape contracting busi-  
16 ness that is dishonest or fraudulent or that the board finds injurious to the welfare of the public.

17 (r) Fails to comply with the requirements of ORS 652.120.

18 (s) Is convicted of a crime under ORS 163.115, 163.185, 163.225, 163.235, 163.355, 163.365, 163.375,  
19 163.385, 163.395, 163.405, 163.408, 163.411, 163.415, 163.425, 163.427, 164.055, 164.075, 164.325 or  
20 164.415 **or section 3 of this 2019 Act**, provided that the facts supporting the conviction and all in-  
21 tervening circumstances make the determination to suspend, revoke or refuse to issue or renew the  
22 license consistent with ORS 670.280.

23 (2) The board may suspend or refuse to renew the license of a landscape construction profes-  
24 sional or landscape contracting business without prior hearing if, after investigating and setting  
25 forth in writing the facts supporting the action, the board determines that continued activity by the  
26 landscape construction professional or landscape contracting business poses an imminent threat of  
27 serious harm to the public welfare. Facts sufficient to support a suspension or refusal to renew un-  
28 der this subsection include, but are not limited to:

29 (a) The lack of a surety bond, letter of credit or deposit required under ORS 671.690;

30 (b) The lack of public liability, personal injury or property damage insurance required under  
31 ORS 671.565;

32 (c) The lack of workers' compensation insurance that is required of the licensee under ORS

41 (3) A person whose license is suspended or refused renewal under subsection (2) of this section

43 new. Except as provided in this subsection, the board shall give a contested case hearing requested  
44 under this subsection priority over other hearings and schedule the hearing for the earliest practi-  
45 cable date. If a citation is issued to the person and the order of suspension or refusal to renew will
