

# Senate Bill 572

Sponsored by Senator WAGNER, Representative ALONSO LEON (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies protective proceedings to permit vulnerable youth guardianships for adults between 18 and 21 years of age who are eligible for special immigrant status and who are unable to be reunified with parent due to abuse, neglect or abandonment that occurred before adult attained 18 years of age. Creates exceptions to certain protective proceeding procedural requirements in vulnerable youth guardianships. Exempts vulnerable youth guardianships from court fees.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

2 Relating to vulnerable youth; amending ORS 125.005, 125.025, 125.055, 125.060, 125.065, 125.080,

4 fective date.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 125.005 is amended to read:

7 125.005. As used in this chapter:

8 (1) "Conservator" means a person appointed as a conservator under the provisions of this  
9 chapter.

10 (2) "Fiduciary" means a guardian or conservator appointed under the provisions of this chapter  
11 or any other person appointed by a court to assume duties with respect to a protected person under  
12 the provisions of this chapter.

13 (3) "Financially incapable" means a condition in which a person is unable to manage financial  
14 resources of the person effectively for reasons including, but not limited to, mental illness, mental  
15 retardation, physical illness or disability, chronic use of drugs or controlled substances, chronic  
16 intoxication, confinement, detention by a foreign power or disappearance. "Manage financial re-  
17 sources" means those actions necessary to obtain, administer and dispose of real and personal  
18 property, intangible property, business property, benefits and income.

19 (4) "Guardian" means a person appointed as a guardian under the provisions of this chapter.

20 (5) "Incapacitated" means a condition in which a person's ability to receive and evaluate infor-  
21 mation effectively or to communicate decisions is impaired to such an extent that the person pres-  
22 ently lacks the capacity to meet the essential requirements for the person's physical health or  
23 safety. "Meeting the essential requirements for physical health and safety" means those actions  
24 necessary to provide the health care, food, shelter, clothing, personal hygiene and other care with-  
25 out which serious physical injury or illness is likely to occur.

26 (6) "Minor" means any person who has not attained 18 years of age.

27 (7) "Protected person" means a person for whom a protective order has been entered.

28 (8) "Protective order" means an order of a court appointing a fiduciary or any other order of  
29 the court entered for the purpose of protecting the person or estate of a respondent or protected

1 person.

2 (9) “Protective proceeding” means a proceeding under this chapter.

3 (10) “Respondent” means a person for whom entry of a protective order is sought in a petition  
4 filed under ORS 125.055.

5 (11) “Visitor” means a person appointed by the court under ORS 125.150 for the purpose of  
6 interviewing and evaluating a respondent or protected person.

7 **(12) “Vulnerable youth” means a person who:**

8 **(a) Is at least 18 years of age but has not attained 21 years of age;**

9 **(b) Is eligible for classification under 8 U.S.C. 1101(a)(27)(J); and**

10 **(c) Cannot be reunified with one or more of the person’s parents due to abuse, neglect  
11 or abandonment, that occurred when the person was a minor.**

12 **SECTION 2.** ORS 125.025 is amended to read:

13 125.025. (1) Subject to ORS 125.800 to 125.852 for adults as defined in ORS 125.802, a court  
14 having jurisdiction over a protective proceeding shall exercise continuing authority over the pro-  
15 ceeding. Subject to the provisions of ORS 125.800 to 125.852 and this chapter, the court may act  
16 upon the petition or motion of any person or upon its own authority at any time and in any manner  
17 it deems appropriate to determine the condition and welfare of the respondent or protected person  
18 and to inquire into the proper performance of the duties of a fiduciary appointed under the pro-  
19 visions of this chapter.

20 (2) A court having jurisdiction over a protective proceeding in which the respondent or pro-  
21 tected person is a minor shall consider and apply all relevant provisions of the Indian Child Welfare  
22 Act codified at 25 U.S.C. sections 1901 et seq.

23 (3) A court having jurisdiction over a protective proceeding may:

24 (a) Compel the attendance of any person, including respondents, protected persons, fiduciaries  
25 and any other person who may have knowledge about the person or estate of a respondent or pro-  
26 tected person. The court may require those persons to respond to inquiries and produce documents  
27 that are subject to discovery under ORCP 36.

28 (b) Appoint counsel for a respondent or protected person.

29 (c) Appoint investigators, visitors and experts to aid the court in the court’s investigation.

30 (d) Exercise jurisdiction over any transaction entered into by a fiduciary to determine if a con-  
31 flict of interest existed and enter an appropriate judgment with respect to the transaction.

32 (e) Surcharge a surety for any loss caused by failure of a fiduciary to perform a fiduciary duty  
33 or any other duty imposed by this chapter, including a surcharge for attorney fees incurred by a  
34 respondent or protected person by reason of the failure.

35 (f) Require immediate delivery of a protected person or property of the protected person, in-  
36 cluding records, accounts and documents relating to that property, to the court or to a place it  
37 designates.

38 (g) Require the fiduciary to produce any and all records that might provide information about  
39 the treatment or condition of the protected person or property of the protected person.

40 (h) Remove a fiduciary whenever that removal is in the best interests of the protected person.

41 (i) Appoint a successor fiduciary when a fiduciary has died, resigned or been removed.

42 (j) Require a respondent or protected person to submit to a physical or mental examination  
43 pursuant to ORCP 44.

44 (k) Make provisions for parenting time or visitation or order support for any minor who is a  
45 respondent or protected person in a protective proceeding.

1 (L) Impose any conditions and limitations upon the fiduciary that the court considers appropri-  
 2 ate, including limitations on the duration of the appointment. Any conditions or limitations imposed  
 3 on the fiduciary must be reflected in the letters of appointment.

4 (m) Appoint protected person special advocates pursuant to ORS 125.120.

5 **(n) In a guardianship proceeding involving a vulnerable youth, allow a person whose at-**  
 6 **tendance the court compels under paragraph (a) of this subsection to attend by telephone,**  
 7 **video or other remote technology.**

8 (4) When a person files a petition or motion for a support order under subsection (3)(k) of this  
 9 section:

10 (a) The person shall state in the petition or motion, to the extent known:

11 (A) Whether there is pending in this state or any other jurisdiction any type of support pro-  
 12 ceeding involving the minor, including a proceeding brought under ORS 25.287, 25.501 to 25.556,  
 13 107.085, 107.135, 107.431, 108.110, 109.100, 109.103, 109.165, 419B.400 or 419C.590 or ORS chapter 110;  
 14 and

15 (B) Whether there exists in this state or any other jurisdiction a support order, as defined in  
 16 ORS 110.503, involving the minor.

17 (b) The person shall include with the petition or motion a certificate regarding any pending  
 18 support proceeding and any existing support order. The person shall use a certificate that is in a  
 19 form established by court rule and include information required by court rule and paragraph (a) of  
 20 this subsection.

21 (5) When the court acts upon its own authority to order support under subsection (3)(k) of this  
 22 section, at least 21 days before the hearing the court shall notify the Administrator of the Division  
 23 of Child Support of the Department of Justice, or the branch office providing support services to the  
 24 county where the hearing will be held, of the hearing. Before the hearing the administrator shall  
 25 inform the court, to the extent known:

26 (a) Whether there is pending in this state or any other jurisdiction any type of support pro-  
 27 ceeding involving the minor, including a proceeding brought under ORS 25.287, 25.501 to 25.556,  
 28 107.085, 107.135, 107.431, 108.110, 109.100, 109.103, 109.165, 419B.400 or 419C.590 or ORS chapter 110;  
 29 and

30 (b) Whether there exists in this state or any other jurisdiction a support order, as defined in  
 31 ORS 110.503, involving the minor.

32 (6) The Judicial Department and the Department of Justice may enter into an agreement re-  
 33 garding how the courts give the notice required under subsection (5) of this section to the Depart-  
 34 ment of Justice and how the Department of Justice gives the information described in subsection  
 35 (5)(a) and (b) **of this section** to the courts.

36 (7) If the court finds that a conservator should be appointed, the court may exercise all the  
 37 powers over the estate and affairs of the protected person that the protected person could exercise  
 38 if present and not under disability, except the power to make a will. The court shall exercise those  
 39 powers for the benefit of the protected person and members of the household of the protected per-  
 40 son.

41 (8) The powers of the court in protective proceedings may be exercised by the court directly or  
 42 through a fiduciary.

43 **SECTION 3.** ORS 125.055 is amended to read:

44 125.055. (1) A petition in a protective proceeding that seeks the appointment of a fiduciary must  
 45 designate the type of fiduciary that the petitioner seeks to have appointed. If the petition does not

1 request the appointment of a fiduciary, or if the petition requests both the appointment of a  
 2 fiduciary and some other protective order, the petition must contain a statement of the nature of the  
 3 protective order requested. The caption of the petition must reflect the type of fiduciary whose ap-  
 4 pointment is requested or, if the appointment of a fiduciary is not requested, the nature of the pro-  
 5 tective order requested. An original and duplicate copy of the petition must be filed with the court.

6 (2) A petition in a protective proceeding must contain the following information to the extent  
 7 that the petitioner is aware of the information or to the extent that the petitioner is able to acquire  
 8 the information with reasonable effort:

9 (a) The name, age, residence address and current location of the respondent.

10 (b) The interest of the petitioner.

11 (c) The name, age and address of the petitioner and any person nominated as fiduciary in the  
 12 petition and the relationship of the person nominated to the respondent.

13 (d) A statement as to whether the person nominated as fiduciary:

14 (A) Has been convicted of a crime;

15 (B) Has filed for or received protection under the bankruptcy laws;

16 (C) Has caused any loss resulting in a surcharge under ORS 125.025 (3)(e) or a similar statute  
 17 of another jurisdiction;

18 (D) Has been removed as a fiduciary under ORS 125.225; or

19 (E) Has had a license revoked or canceled that was required by the laws of any state for the  
 20 practice of a profession or occupation.

21 (e) If an event listed in paragraph (d) of this subsection has occurred, a statement of the cir-  
 22 cumstances surrounding the event.

23 (f) If the person nominated as fiduciary is not the petitioner, a statement indicating that the  
 24 person nominated is willing and able to serve.

25 (g) The name and address of any fiduciary that has been appointed for the respondent by a court  
 26 of any state, any trustee for a trust established by or for the respondent, any person appointed as  
 27 a health care representative under the provisions of ORS 127.505 to 127.660 and any person acting  
 28 as attorney-in-fact for the respondent under a power of attorney.

29 (h) The name and address of the respondent's treating physician and any other person who is  
 30 providing care to the respondent.

31 (i) The factual information that:

32 **(A) Except as provided in subparagraph (B) of this paragraph,** supports the request for the  
 33 appointment of a fiduciary or entry of other protective order, less restrictive alternatives to the  
 34 appointment of a fiduciary that have been considered and why the alternatives are inadequate and  
 35 the names and addresses of all persons who have information that would support a finding that an  
 36 adult respondent is incapacitated or financially incapable.

37 **(B) If the petition seeks appointment of a guardian for a vulnerable youth, supports a**  
 38 **finding that the proposed protected person is a vulnerable youth.**

39 (j) A statement that indicates whether the person nominated as fiduciary intends to place the  
 40 respondent in a mental health treatment facility, a nursing home or other residential facility.

41 (k) A general description of the estate of the respondent and the respondent's sources of income  
 42 and the amount of that income.

43 (L) A statement indicating whether the person nominated as fiduciary is a public or private  
 44 agency or organization that provides services to the respondent or an employee of a public or pri-  
 45 vate agency or organization that provides services to the respondent.

1 (m) A statement that indicates whether the petitioner is petitioning for plenary authority or  
2 specified limited authority for the person nominated as fiduciary.

3 (3) In addition to the requirements of subsection (2) of this section:

4 (a) If a petition seeks appointment of a guardian, the petition must contain a statement on  
5 whether the guardian will exercise any control over the estate of the respondent. If the guardian  
6 will exercise any control over the estate of the respondent, the petition must contain a statement  
7 of the monthly income of the respondent, the sources of the respondent's income, and the amount  
8 of any moneys that the guardian will be holding for the respondent at the time of the appointment.

9 (b) **Except as provided in paragraph (c) of this subsection**, if the petition seeks the ap-  
10 pointment of a guardian for an adult respondent, of a guardian for a minor respondent who is more  
11 than 16 years of age, in cases where the court determines there is the likelihood that a petition  
12 seeking appointment of a guardian for the respondent as an adult will be filed before the date that  
13 the respondent attains majority, in accordance with subsection (6)(a) of this section, or as an adult,  
14 or of a temporary fiduciary who will exercise the powers of a guardian for an adult respondent, the  
15 petition must contain a statement notifying the court that a visitor must be appointed.

16 (c) **If the petition seeks appointment of a guardian for a vulnerable youth, the petition**  
17 **must include:**

18 (A) **A statement that the court in its discretion may appoint a visitor; and**

19 (B) **Except as provided in subsection (6)(b) of this section, a declaration signed by the**  
20 **vulnerable youth consenting to the appointment of the proposed guardian.**

21 (4) In addition to the requirements of subsection (2) of this section, if a petition seeks appoint-  
22 ment of a conservator or a temporary fiduciary who will exercise the powers of a conservator or if  
23 a petition seeks a protective order relating to the estate of the respondent, the petition must contain  
24 the petitioner's estimate of the value of the estate.

25 (5) A petitioner may join parties in a petition in the manner provided by ORCP 28 for the joining  
26 of defendants.

27 (6)(a) A parent or guardian of a minor may file a petition that seeks the appointment of a  
28 guardian for the minor as an adult, to become effective on the date that the minor attains majority,  
29 at any time within 90 days before the date that the minor attains majority or at any other time  
30 determined by the court to be necessary and appropriate to ensure the ongoing protection, safety  
31 and welfare of the minor upon attaining majority.

32 (b) **If a petition for the appointment of a guardian for a vulnerable youth is filed when**  
33 **the respondent is a minor, the declaration of consent to appointment required under sub-**  
34 **section (3)(c) of this section must be filed no later than 10 days after the respondent attains**  
35 **the age of majority.**

36 (7) The court shall review a petition seeking appointment of a guardian and shall dismiss the  
37 proceeding without prejudice, or require that the petition be amended, if the court determines that  
38 the petition does not meet the requirements of this section.

39 **SECTION 4.** ORS 125.060 is amended to read:

40 125.060. (1) The notices required by this section must be given to all persons whose identities  
41 and addresses can be ascertained in the exercise of reasonable diligence by the person required to  
42 give the notice.

43 (2) Notice of the filing of a petition for the appointment of a fiduciary or entry of other pro-  
44 tective order must be given by the petitioner to the following persons:

45 (a) The respondent, if the respondent has attained 14 years of age **unless the petition is for**

1 **the appointment of a guardian for a vulnerable youth who has attained 18 years of age and**  
2 **the respondent's declaration consenting to the appointment has been filed with the court.**

3 (b) The spouse, parents and adult children of the respondent.

4 (c) If the respondent does not have a spouse, parent or adult child, the person or persons most  
5 closely related to the respondent.

6 (d) Any person who is cohabiting with the respondent and who is interested in the affairs or  
7 welfare of the respondent.

8 (e) Any person who has been nominated as fiduciary or appointed to act as fiduciary for the  
9 respondent by a court of any state, any trustee for a trust established by or for the respondent, any  
10 person appointed as a health care representative under the provisions of ORS 127.505 to 127.660 and  
11 any person acting as attorney-in-fact for the respondent under a power of attorney.

12 (f) If the respondent is a minor, the person who has exercised principal responsibility for the  
13 care and custody of the respondent during the 60-day period before the filing of the petition.

14 (g) If the respondent is a minor and has no living parents, any person nominated to act as  
15 fiduciary for the minor in a will or other written instrument prepared by a parent of the minor.

16 (h) If the respondent is receiving moneys paid or payable by the United States through the De-  
17 partment of Veterans Affairs, a representative of the United States Department of Veterans Affairs  
18 regional office that has responsibility for the payments to the protected person.

19 (i) If the respondent is receiving moneys paid or payable for public assistance provided under  
20 ORS chapter 411 by the State of Oregon through the Department of Human Services, a represen-  
21 tative of the department.

22 (j) If the respondent is receiving moneys paid or payable for medical assistance provided under  
23 ORS chapter 414 by the State of Oregon through the Oregon Health Authority, a representative of  
24 the authority.

25 (k) If the respondent is committed to the legal and physical custody of the Department of Cor-  
26 rections, the Attorney General and the superintendent or other officer in charge of the facility in  
27 which the respondent is confined.

28 (L) If the respondent is a foreign national, the consulate for the respondent's country.

29 (m) Any other person that the court requires.

30 (3) Notice of a motion for the termination of the protective proceedings, for removal of a  
31 fiduciary, for modification of the powers or authority of a fiduciary, for approval of a fiduciary's  
32 actions or for protective orders in addition to those sought in the petition must be given by the  
33 person making the motion to the following persons:

34 (a) The protected person, if the protected person has attained 14 years of age.

35 (b) Any person who has filed a request for notice in the proceedings.

36 (c) Except for a fiduciary who is making a motion, any fiduciary who has been appointed for the  
37 protected person.

38 (d) If the protected person is receiving moneys paid or payable by the United States through the  
39 Department of Veterans Affairs, a representative of the United States Department of Veterans Af-  
40 fairs regional office that has responsibility for the payments to the protected person.

41 (e) If the protected person is committed to the legal and physical custody of the Department of  
42 Corrections, the Attorney General and the superintendent or other officer in charge of the facility  
43 in which the protected person is confined.

44 (f) **If the protected person is a vulnerable youth, the consulate of the vulnerable youth's**  
45 **country of nationality or, if unknown, the consulate of the vulnerable youth's last country**

1 **of residence prior to the United States of America.**

2 [(f)] (g) Any other person that the court requires.

3 (4) A request for notice under subsection (3)(b) of this section must be in writing and include  
 4 the name, address and phone number of the person requesting notice. A copy of the request must  
 5 be mailed by the person making the request to the petitioner or to the fiduciary if a fiduciary has  
 6 been appointed. The original request must be filed with the court. The person filing the request must  
 7 pay the fee specified by ORS 21.135.

8 (5) A person who files a request for notice in the proceedings in the manner provided by sub-  
 9 subsection (4) of this section is entitled to receive notice from the fiduciary of any motion specified in  
 10 subsection (3) of this section and of any other matter to which a person listed in subsection (2) of  
 11 this section is entitled to receive notice under a specific provision of this chapter.

12 (6) If the Department of Human Services is nominated as guardian for the purpose of consenting  
 13 to the adoption of a minor, the notice provided for in this section must also be given to the minor's  
 14 brothers, sisters, aunts, uncles and grandparents.

15 (7) In addition to the requirements of subsection (2) of this section, notice of the filing of a pe-  
 16 tition for the appointment of a guardian for a person who is alleged to be incapacitated must be  
 17 given by the petitioner to the following persons:

18 (a) Any attorney who is representing the respondent in any capacity.

19 (b) If the respondent is a resident of a nursing home or residential facility, or if the person  
 20 nominated to act as fiduciary intends to place the respondent in a nursing home or residential fa-  
 21 cility, the office of the Long Term Care Ombudsman.

22 (c) If the respondent is a resident of a mental health treatment facility or a residential facility  
 23 for individuals with developmental disabilities, or if the person nominated to act as fiduciary intends  
 24 to place the respondent in such a facility, the system described in ORS 192.517 (1).

25 (8) In addition to the requirements of subsection (3) of this section, in a protective proceeding  
 26 in which a guardian has been appointed, notice of the motions specified in subsection (3) of this  
 27 section, and the address, telephone number and other contact information of the protected person,  
 28 must be given by the person making the motion to the following persons:

29 (a) Any attorney who represented the protected person at any time during the protective pro-  
 30 ceeding.

31 (b) If the protected person is a resident of a nursing home or residential facility, or if the motion  
 32 seeks authority to place the protected person in a nursing home or residential facility, the office of  
 33 the Long Term Care Ombudsman.

34 (c) If the protected person is a resident of a mental health treatment facility or a residential  
 35 facility for individuals with developmental disabilities, or if the motion seeks authority to place the  
 36 protected person in such a facility, the system described in ORS 192.517 (1).

37 (9) A respondent or protected person may not waive the notice required under this section.

38 (10) The requirement that notice be served on an attorney for a respondent or protected person  
 39 under subsection (7)(a) or (8)(a) of this section does not impose any responsibility on the attorney  
 40 receiving the notice to represent the respondent or protected person in the protective proceeding.

41 **SECTION 5.** ORS 125.065 is amended to read:

42 125.065. (1) **Except as provided in ORS 125.060**, notice of the filing of a petition must be per-  
 43 sonally served on any respondent who has attained 14 years of age. Notice of a petition must be  
 44 personally served on the parents of a respondent if the petition is based on the fact that the re-  
 45 spondent is a minor. The notice may not be served on the respondent by the visitor appointed by

1 the court. The notice shall be written in language reasonably understandable by the respondent. The  
 2 notice must be printed in type size equal to at least 12-point type.

3 (2) Except as provided in subsection (1) of this section, the notices required under ORS 125.060  
 4 may be mailed to the last-known address of the person. If the address or identity of any person is  
 5 not known and cannot be ascertained with reasonable diligence, notice of the filing of a petition  
 6 may be given by publishing at least once a week for three consecutive weeks a copy of the notice  
 7 in a newspaper having general circulation in the county where the hearing is to be held. The last  
 8 publication of the notice must be at least 15 days before the final date for the filing of objections.

9 (3) The date of personal service or mailing under this section must be at least 15 days before  
 10 the final date for the filing of objections to the petition or motion. If the proceedings are subject to  
 11 the Uniform Child Custody Jurisdiction and Enforcement Act provided for in ORS 109.701 to 109.834,  
 12 the date of service or mailing must be at least 21 days before the final date for the filing of ob-  
 13 jections to the petition or motion.

14 (4) The court for good cause shown may provide for a different method or time of giving notice  
 15 under this section.

16 (5) Proof of the giving of notice must be filed in the proceeding before the court enters any order  
 17 on a petition or motion.

18 **SECTION 6.** ORS 125.080 is amended to read:

19 125.080. (1) The court may require that a hearing be held on any petition or motion in a pro-  
 20 tective proceeding.

21 (2) A hearing must be held on a petition or motion if an objection is filed to the petition or  
 22 motion and the objection is not withdrawn before the time scheduled for the hearing.

23 (3) A hearing must be held on a motion to modify a guardian’s powers under ORS 125.323.

24 (4) The respondent or protected person may appear at a hearing in person or by counsel.

25 **(5) If the hearing is regarding a petition for appointment of a guardian for a vulnerable**  
 26 **youth or a petition involving a vulnerable youth guardianship, the court:**

27 **(a) May allow the respondent or protected person, proposed guardian, guardian or any**  
 28 **other witness to appear by telephone, video or other remote technology;**

29 **(b)(A) May take testimony from or confer with the respondent or protected person and**  
 30 **may exclude from the conference others if the court finds that doing so would be in the best**  
 31 **interests of the respondent or protected person; and**

32 **(B) Notwithstanding subparagraph (A) of this paragraph, shall permit any attorney for**  
 33 **the respondent or protected person to attend the conference and the conference must be**  
 34 **reported;**

35 **(c) May not inquire into the nationality or current immigration status of the proposed**  
 36 **guardian, guardian or any other witness; and**

37 **(d) May not inquire about any prior immigration status of the respondent or protected**  
 38 **person or about the manner or place in which the respondent or protected person entered**  
 39 **the United States of America.**

40 [(5)] (6) If the court requires that a hearing be held on a petition, or a hearing is otherwise re-  
 41 quired under this section, the court may appoint counsel for the respondent unless the respondent  
 42 is already represented by counsel.

43 **SECTION 7.** ORS 125.085 is amended to read:

44 125.085. (1) The court may remove a fiduciary on the motion of any person who is entitled to file  
 45 an objection to a petition under the provisions of ORS 125.075, on a motion of the Long Term Care

1 Ombudsman or upon the court's own motion.

2 (2) On motion of the fiduciary, the court may accept the resignation of the fiduciary and make  
3 any other order that may be appropriate, including appointment of a successor fiduciary.

4 (3) **Except as provided in subsection (5) of this section**, upon motion by any person who is  
5 entitled to file an objection to a petition under the provisions of ORS 125.075, on a motion of the  
6 Long Term Care Ombudsman or upon the court's own motion, the court may order a modification  
7 of the powers or authority of the fiduciary or termination of the protective proceedings.

8 (4)(a) When the Long Term Care Ombudsman files a motion under this section, the ombudsman  
9 shall disclose to the court only:

10 (A) Such information as is allowed under ORS 441.407; and

11 (B) The minimum amount of protected information about the resident who is the subject of the  
12 motion that the ombudsman believes in good faith is reasonably necessary to prevent or lessen a  
13 serious and imminent threat to the health or safety of a resident of a long term care facility, resi-  
14 dential facility or adult foster home.

15 (b) Any protected information disclosed by the ombudsman under this subsection shall remain  
16 confidential and must be identified and marked by the ombudsman as confidential and protected in-  
17 formation that is subject to the requirements of this subsection.

18 (c) Protected information disclosed under this subsection is subject to inspection only by the  
19 parties to the proceeding and their attorneys as provided in paragraph (d) of this subsection. Pro-  
20 tected information disclosed under this subsection is not subject to inspection by members of the  
21 public except pursuant to a court order entered after a showing of good cause.

22 (d) The court may enter an order allowing inspection of protected information subject to dis-  
23 closure under this subsection upon the filing of a written request for inspection and the payment  
24 of any fees or costs charged to copy the protected information.

25 (e) Notwithstanding ORS 125.155 (4), to the extent that the report of a visitor appointed by the  
26 court under ORS 125.150 contains protected information that is subject to the requirements of this  
27 subsection, the report in its entirety shall be considered subject to the requirements of this sub-  
28 section and may be disclosed only as provided in paragraphs (c) and (d) of this subsection.

29 **(5) If the guardianship is for a vulnerable youth:**

30 (a) **The court may modify the guardianship upon motion of the protected person or upon**  
31 **the court's own motion. The motion seeking to modify the guardianship must be supported**  
32 **by a declaration setting forth the facts. The motion and supporting declaration must be**  
33 **served on the guardian and, if appropriate, any proposed guardian.**

34 (b) **A guardian may seek to have the guardianship modified at any time by filing a motion**  
35 **with the court that is supported by a declaration establishing that a substantial change has**  
36 **occurred in the circumstances of the protected person or the guardian and that the re-**  
37 **quested modification would serve the best interests of the protected person.**

38 **SECTION 8.** ORS 125.090 is amended to read:

39 125.090. (1) A protected person is entitled to the same rights and procedures provided in the  
40 original proceedings when a motion to terminate the protective proceeding is filed and a fiduciary  
41 opposes the motion. The fiduciary has the burden of proving by clear and convincing evidence that  
42 a protected person continues to be incapacitated or financially incapable if a motion to terminate  
43 a protective proceeding is filed and the fiduciary opposes the motion. A visitor must be appointed  
44 if a motion for termination of a guardianship is filed and objections are filed to the motion. A visitor  
45 may be appointed if a motion for termination of a conservatorship is filed.

1 (2) The court may terminate protective proceedings upon motion after determining any of the  
2 following:

3 (a) The appointment of a fiduciary or other protective order was made because the protected  
4 person was a minor, and the protected person has attained the age of majority.

5 (b) The appointment of a fiduciary or other protective order was made because the protected  
6 person was incapacitated, and the protected person is no longer incapacitated.

7 (c) The appointment of a fiduciary or other protective order was made because the protected  
8 person was financially incapable, and the protected person is no longer financially incapable or the  
9 conditions of ORS 125.535 have been met.

10 (d) The protected person has died.

11 (e) The best interests of the protected person would be served by termination of the proceedings.

12 (f) **If the appointment of a guardian was made because the protected person was a vul-**  
13 **nerable youth:**

14 (A) **The protected person has attained 21 years of age;**

15 (B) **The protected person moved the court to terminate the guardianship; or**

16 (C)(i) **The guardian or other person moved the court to terminate the guardianship;**

17 (ii) **The motion is supported by a declaration establishing that a substantial change has**  
18 **occurred in the circumstances of the protected person or of the guardian; and**

19 (iii) **The best interests of the protected person would be served by termination of the**  
20 **guardianship.**

21 (3) The court shall terminate a protective proceeding by entry of a general judgment.

22 **SECTION 9.** ORS 125.150 is amended to read:

23 125.150. (1)(a) The court shall appoint a visitor upon the filing of a petition in a protective  
24 proceeding that seeks the appointment of:

25 (A) A guardian for an adult respondent;

26 (B) A guardian for a minor respondent who is more than 16 years of age, in cases where the  
27 court determines there is the likelihood that a petition seeking appointment of a guardian for the  
28 respondent as an adult will be filed before the date that the respondent attains majority, in ac-  
29 cordance with ORS 125.055 (6)(a), or as an adult; or

30 (C) A temporary fiduciary who will exercise the powers of a guardian for an adult respondent.

31 (b) **Notwithstanding paragraph (a) of this subsection, if a petition in a protective pro-**

35 [(b)] (c) The court may appoint a visitor in any other protective proceeding or in a proceeding

37 (2) A visitor may be an officer, employee or special appointee of the court. The person appointed  
38 may not have any personal interest in the proceedings. The person appointed must have training or  
39 expertise adequate to allow the person to appropriately evaluate the functional capacity and needs  
40 of a respondent or protected person, or each petitioner and the person to be adopted under ORS  
41 109.329. The court shall provide a copy of the petition and other filings in the proceedings that may
