**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs [*State Treasurer*] **Oregon 529 Savings Board** to establish by rule qualified state **ABLE Act** program as described in federal Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014. Allows persons with disabilities to establish savings accounts for disability-related expenses. Excludes distributions from account for qualified disability expenses from federal taxable income. Subtracts contributions made to account from federal taxable income.

**Increases, for biennium beginning July 1, 2015, limitation on expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Treasurer, for purposes of establishing ABLE program.**

Takes effect on 91st day following adjournment sine die.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. As used in this section and section 2 of this 2015 Act:**

7 (1) **"ABLE account"** means an account established by an eligible individual, owned by the  
8 eligible individual and maintained under the qualified ABLE program established by the  
9 Oregon 529 Savings Board under section 2 of this 2015 Act.

10 (2) **"ABLE Act"** means the Stephen Beck, Jr., Achieving a Better Life Experience Act  
11 of 2014 (Division B of P.L. 113-295).

12 (3) **"Designated beneficiary"** has the same meaning as contained in section 529A of the  
13 Internal Revenue Code.

14 (4) **"Eligible individual"** has the same meaning as contained in section 529A of the Inter-  
15 nal Revenue Code.

16 (5) **"Internal Revenue Code"** means the federal Internal Revenue Code as amended and  
17 in effect on the effective date of this 2015 Act.

18 (6) **"Qualified disability expense"** has the same meaning as contained in section 529A of  
19 the Internal Revenue Code.

20 **SECTION 2.** (1) The Oregon 529 Savings Board shall establish by rule and maintain a  
21 qualified ABLE program in accordance with the requirements of the ABLE Act.

22 (2) The rules must:

23 (a) Allow a person to make contributions for a taxable year to an ABLE account estab-

1 **lished for the purpose of meeting the qualified disability expenses of the designated benefi-**  
2 **ciary of the account;**

3 **(b) Limit a designated beneficiary to one ABLE account for purposes of this section;**

4 **(c) Require cash-only contributions to ABLE accounts;**

5 **(d) Provide for a separate accounting for each designated beneficiary of an ABLE ac-**  
6 **count;**

7 **(e) Provide that a designated beneficiary of an ABLE account may not, directly or indi-**  
8 **rectly, direct the investment of contributions to the account, or earnings on the account,**  
9 **more than two times in any calendar year;**

10 **(f) Prohibit the use of a designated beneficiary's interest in an ABLE account as security**  
11 **for a loan;**

12 **(g) Establish limitations on aggregate contributions to an ABLE account on behalf of a**  
13 **designated beneficiary; and**

14 **(h) Satisfy all other requirements of section 529A of the Internal Revenue Code, the**  
15 **ABLE Act, rules adopted by the United States Secretary of the Treasury under the ABLE**  
16 **Act and other applicable federal law.**

17 **SECTION 3.** ORS 316.680 is amended to read:

18 316.680. (1) There shall be subtracted from federal taxable income:

19 (a) The interest or dividends on obligations of the United States and its territories and pos-  
20 sessions or of any authority, commission or instrumentality of the United States to the extent  
21 includable in gross income for federal income tax purposes but exempt from state income taxes un-  
22 der the laws of the United States. However, the amount subtracted under this paragraph shall be  
23 reduced by any interest on indebtedness incurred to carry the obligations or securities described in  
24 this paragraph, and by any expenses incurred in the production of interest or dividend income de-  
25 scribed in this paragraph to the extent that such expenses, including amortizable bond premiums,  
26 are deductible in determining federal taxable income.

27 (b) The amount of any federal income taxes accrued by the taxpayer during the taxable year as  
28 described in ORS 316.685, less the amount of any refunds of federal taxes previously accrued for  
29 which a tax benefit was received.

30 (c) Amounts allowable under sections 2621(a)(2) and 2622(b) of the Internal Revenue Code to the  
31 extent that the taxpayer does not elect under section 642(g) of the Internal Revenue Code to reduce  
32 federal taxable income by those amounts.

33 (d) Any supplemental payments made to JOBS Plus Program participants under ORS 411.892.

34 (e)(A) Federal pension income that is attributable to federal employment occurring before Oc-  
35 tober 1, 1991. Federal pension income that is attributable to federal employment occurring before  
36 October 1, 1991, shall be determined by multiplying the total amount of federal pension income for  
37 the tax year by the ratio of the number of months of federal creditable service occurring before  
38 October 1, 1991, over the total number of months of federal creditable service.

39 (B) The subtraction allowed under this paragraph applies only to federal pension income re-  
40 ceived at a time when:

41 (i) Benefit increases provided under chapter 569, Oregon Laws 1995, are in effect; or

42 (ii) Public Employees Retirement System benefits received for service prior to October 1, 1991,  
43 are exempt from state income tax.

44 (C) As used in this paragraph:

45 (i) "Federal creditable service" means those periods of time for which a federal employee earned

7 described in section 408A of the Internal Revenue Code, to the extent that:

8 (A) The amount was subject to the income tax of another state or the District of Columbia in  
9 a prior tax year; and

10 (B) The taxpayer was a resident of the other state or the District of Columbia for that prior tax  
11 year.

12 (g) Any amounts awarded to the taxpayer by the Public Safety Memorial Fund Board under ORS  
13 243.954 to 243.974 to the extent that the taxpayer has not taken the amount as a deduction in de-  
14 termining the taxpayer's federal taxable income for the tax year.

15 (h) If included in taxable income for federal tax purposes, the amount withdrawn during the tax  
16 year in qualified withdrawals from a [college] savings network account **for higher education** es-  
17 tablished under ORS 348.841 to 348.873.

18 (i) **If included in taxable income for federal tax purposes, any distributions from an ABL**  
19 **account that do not exceed the qualified disability expenses of the designated beneficiary as**  
20 **provided in sections 1 and 2 of this 2015 Act and rules adopted by the Oregon 529 Savings**  
21 **Board.**

22 (2) There shall be added to federal taxable income:

23 (a) Interest or dividends, exempt from federal income tax, on obligations or securities of any  
24 foreign state or of a political subdivision or authority of any foreign state. However, the amount  
25 added under this paragraph shall be reduced by any interest on indebtedness incurred to carry the  
26 obligations or securities described in this paragraph and by any expenses incurred in the production  
27 of interest or dividend income described in this paragraph.

28 (b) Interest or dividends on obligations of any authority, commission, instrumentality and terri-  
29 torial possession of the United States that by the laws of the United States are exempt from federal  
30 income tax but not from state income taxes. However, the amount added under this paragraph shall  
31 be reduced by any interest on indebtedness incurred to carry the obligations or securities described  
32 in this paragraph and by any expenses incurred in the production of interest or dividend income  
33 described in this paragraph.

34 (c) The amount of any federal estate taxes allocable to income in respect of a decedent not  
35 taxable by Oregon.

36 (d) The amount of any allowance for depletion in excess of the taxpayer's adjusted basis in the  
37 property depleted, deducted on the taxpayer's federal income tax return for the taxable year, pur-  
38 suant to sections 613, 613A, 614, 616 and 617 of the Internal Revenue Code.

39 (e) For taxable years beginning on or after January 1, 1985, the dollar amount deducted under  
40 section 151 of the Internal Revenue Code for personal exemptions for the taxable year.

41 (f) The amount taken as a deduction on the taxpayer's federal return for unused qualified busi-  
42 ness credits under section 196 of the Internal Revenue Code.

43 (g) The amount of any increased benefits paid to a taxpayer under chapter 569, Oregon Laws  
44 1995, under the provisions of chapter 796, Oregon Laws 1991, and under section 26, chapter 815,  
45 Oregon Laws 1991, that is not includable in the taxpayer's federal taxable income under the Internal

1 Revenue Code.

2 (h) The amount of any long term care insurance premiums paid or incurred by the taxpayer  
3 during the tax year if:

4 (A) The amount is taken into account as a deduction on the taxpayer's federal return for the  
5 tax year; and

6 (B) The taxpayer claims the credit allowed under ORS 315.610 for the tax year.

7 (i) Any amount taken as a deduction under section 1341 of the Internal Revenue Code in com-  
8 puting federal taxable income for the tax year, if the taxpayer has claimed a credit for claim of right  
9 income repayment adjustment under ORS 315.068.

10 (j) If the taxpayer makes a nonqualified withdrawal, as defined in ORS 348.841, from a [college]  
11 savings network account **for higher education** established under ORS 348.841 to 348.873, the  
12 amount of the withdrawal that is attributable to contributions that were subtracted from federal  
13 taxable income under ORS 316.699.

14 **(k) If the taxpayer makes a distribution from an ABLE account that is not a qualified**  
15 **disability expense of the designated beneficiary as provided in sections 1 and 2 of this 2015**  
16 **Act and rules adopted by the Oregon 529 Savings Board, the amount of the distribution that**  
17 **is attributable to contributions that were subtracted from federal taxable income under ORS**  
18 **316.699.**

19 (3) Discount and gain or loss on retirement or disposition of obligations described under sub-  
20 section (2)(a) of this section issued on or after January 1, 1985, shall be treated for purposes of this  
21 chapter in the same manner as under sections 1271 to 1283 and other pertinent sections of the  
22 Internal Revenue Code as if the obligations, although issued by a foreign state or a political subdivi-  
23 sion of a foreign state, were not tax exempt under the Internal Revenue Code.

24 **SECTION 4.** ORS 316.680, as amended by section 74, chapter 1, Oregon Laws 2015, is amended  
25 to read:

26 316.680. (1) There shall be subtracted from federal taxable income:

27 (a) The interest or dividends on obligations of the United States and its territories and pos-  
28 sessions or of any authority, commission or instrumentality of the United States to the extent  
29 includable in gross income for federal income tax purposes but exempt from state income taxes un-  
30 der the laws of the United States. However, the amount subtracted under this paragraph shall be  
31 reduced by any interest on indebtedness incurred to carry the obligations or securities described in  
32 this paragraph, and by any expenses incurred in the production of interest or dividend income de-

30 **account that do not exceed the qualified disability expenses of the designated beneficiary as**  
31 **provided in sections 1 and 2 of this 2015 Act and rules adopted by the Oregon 529 Savings**  
32 **Board.**

33 (2) There shall be added to federal taxable income:

34 (a) Interest or dividends, exempt from federal income tax, on obligations or securities of any  
35 foreign state or of a political subdivision or authority of any foreign state. However, the amount  
36 added under this paragraph shall be reduced by any interest on indebtedness incurred to carry the

27 **Act and rules adopted by the Oregon 529 Savings Board, the amount of the distribution that**  
28 **is attributable to contributions that were subtracted from federal taxable income under ORS**  
29 **316.699.**

30 (3) Discount and gain or loss on retirement or disposition of obligations described under sub-  
31 section (2)(a) of this section issued on or after January 1, 1985, shall be treated for purposes of this  
32 chapter in the same manner as under sections 1271 to 1283 and other pertinent sections of the  
33 Internal Revenue Code as if the obligations, although issued by a foreign state or a political subdivi-  
34 sion of a foreign state, were not tax exempt under the Internal Revenue Code.

35 **SECTION 5.** ORS 316.699 is amended to read:

36 316.699. (1) There shall be subtracted from federal taxable income the amount contributed to:

37 (a) A [college] savings network account **for higher education** established under ORS 348.841  
38 to 348.873; or

39 (b) **An ABLE account established under section 2 of this 2015 Act and rules adopted by**  
40 **the Oregon 529 Savings Board.**

41 (2) Notwithstanding subsection (1) of this section, a subtraction under this section may not ex-  
42 ceed the lesser of:

43 (a) \$4,000 for the tax year if the taxpayer files a joint return, or \$2,000 for the tax year if the  
44 taxpayer files a return other than a joint return; and

45 (b) If an amount is carried forward to a succeeding tax year under subsection (4) of this section,

1 the balance in the [*college*] savings network account **for higher education or ABLE account** at  
 2 the close of the tax year for which the subtraction is being made.

3 (3)(a) The Department of Revenue shall annually adjust the maximum subtraction allowable un-  
 4 der this section according to the cost-of-living adjustment for the calendar year. The department  
 5 shall make this adjustment by multiplying the amount in subsection (2) of this section by the per-  
 6 centage (if any) by which the monthly averaged U.S. City Average Consumer Price Index for the 12  
 7 consecutive months ending August 31 of the prior calendar year exceeds the monthly averaged U.S.  
 8 City Average Consumer Price Index for the 12 consecutive months ending August 31, 2007.

9 (b) As used in this subsection, "U.S. City Average Consumer Price Index" means the U.S. City  
 10 Average Consumer Price Index for All Urban Consumers (All Items) as published by the Bureau of  
 11 Labor Statistics of the United States Department of Labor.

12 (4) Any amounts contributed to a [*college*] savings network account **for higher education or**  
 13 **an ABLE account** that are not subtracted from federal taxable income because of the monetary  
 14 limitations imposed by subsection (2) of this section may be carried forward for four succeeding tax  
 15 years and subtracted from federal taxable income in any of those succeeding tax years in an amount  
 16 that does not exceed the monetary limitations imposed by subsection (2) of this section.

17 (5) The amount contributed to a [*college*] savings network account **for higher education or an**  
 18 **ABLE account** may be subtracted from a preceding tax year if the contribution is made before the  
 19 taxpayer files a return or before the 15th day of the fourth month following the closing of the  
 20 taxpayer's tax year, whichever is earlier.

21 **SECTION 6.** ORS 348.849 is amended to read:

22 348.849. (1) There is established the Oregon 529 [*College*] Savings Board to administer ORS  
 23 348.841 to 348.873 **and sections 1 and 2 of this 2015 Act.**

24 (2) The board shall consist of:

25 (a) The State Treasurer or a designee of the State Treasurer;

26 (b) [*A member of the State Board of Higher Education, to be selected by the State Board of Higher*  
 27 *Education*] **A representative of persons with intellectual disabilities or other developmental**  
 28 **disabilities, who shall be appointed by the State Treasurer;**

29 (c) A representative of accredited private colleges and universities located in this state, who  
 30 shall be appointed by the State Treasurer; and

31 (d) Two public members, who by reason of their education and experience are qualified to serve,  
 32 and who shall be appointed by the State Treasurer.

33 (3) The State Treasurer shall designate the board chairperson from among the members of the  
 34 board. The chairperson shall serve at the pleasure of the State Treasurer.

35 (4)(a) *The board member who is a member of the State Board of Higher Education shall serve at*  
 36 *the pleasure of the State Board of Higher Education but may not serve on the board following the end*  
 37 *of the member's term on the State Board of Higher Education.]*

38 [*(b) The representative of private colleges and universities and the public members of the board*  
 39 *shall*] **Members of the board appointed by the State Treasurer** serve at the pleasure of the State  
 40 Treasurer for a term of office of three years. [*These*] Members of the board may be reappointed to  
 41 subsequent terms.

42 (5) The State Treasurer [*and the Oregon University System*] shall provide staff and assistance to  
 43 the board in the administration of the Oregon 529 [*College*] Savings Network, **including the quali-**  
 44 **fied ABLE program established under section 2 of this 2015 Act**, as directed by the board.

45 (6) A member of the board is entitled to compensation and expenses as provided in ORS 292.495.

1 (7) A majority of the members of the board constitutes a quorum for the transaction of business.

2 **SECTION 7. (1) The term of the member of the Oregon 529 Savings Board described in**  
3 **ORS 348.849 (2)(b), as in effect immediately before the effective date of this 2015 Act, termi-**  
4 **nates on the effective date of this 2015 Act.**

5 **(2) The State Treasurer shall appoint the new member of the Oregon 529 Savings Board**  
6 **described in ORS 348.849 (2)(b), as in effect on the effective date of this 2015 Act, not later**  
7 **than January 1, 2016.**

8 **SECTION 8.** ORS 348.841, as amended by section 27, chapter 52, Oregon Laws 2014, is amended  
9 to read:

10 348.841. As used in ORS 348.841 to 348.873:

11 (1) "Account" means an individual account established in accordance with ORS 348.841 to  
12 348.873.

13 (2) "Account owner" means the person who has the right to withdraw funds from the account.  
14 The account owner may also be the designated beneficiary of the account.

15 (3) "Board" means the Oregon 529 [College] Savings Board established under ORS 348.849.

16 (4) "Designated beneficiary" means, except as provided in ORS 348.867, the individual designated  
17 at the time the account is opened as having the right to receive a qualified withdrawal for the  
18 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-  
19 cordance with ORS 348.867, the replacement.

20 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,  
21 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a  
22 mutual fund, an investment firm or other similar entity authorized to do business in this state.

23 (6) "Higher education institution" means an eligible education institution as defined in section  
24 529(e)(5) of the Internal Revenue Code.

25 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect  
26 on [December 31, 2013] **the effective date of this 2015 Act.**

27 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the  
28 Internal Revenue Code.

29 (9) "Network" means the Oregon 529 [College] Savings Network established under ORS [348.841  
30 to 348.873] **348.844.**

31 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified  
32 withdrawal.

33 (11) "Qualified higher education expenses" means tuition and other permitted expenses as set  
34 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated  
35 beneficiary at a higher education institution.

36 (12) "Qualified withdrawal" means a withdrawal made as prescribed under ORS 348.870 and  
37 made:

38 (a) From an account to pay the qualified higher education expenses of the designated benefi-  
39 ciary;

40 (b) As the result of the death or disability of the designated beneficiary;

41 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)  
42 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the  
43 extent of the amount of the scholarship, allowance or payment; or

16 **expenses.**

17        **SECTION 10.** ORS 348.853 is amended to read:

18        348.853. The Oregon 529 [*College*] Savings Board shall have the following powers, duties, and  
19 functions:

20        (1) To establish, develop, implement and maintain the Oregon 529 [*College*] Savings Network in  
21 a manner consistent with ORS 348.841 to 348.873, **sections 1 and 2 of this 2015 Act** and [*section*

45        **(7) To adopt rules to establish a qualified ABLE program under section 2 of this 2015 Act**

1 **and to administer and maintain the program in a manner consistent with sections 1 and 2**  
2 **of this 2015 Act and the ABLE Act.**

29 to displaced homemakers or other individuals who have lost home ownership as a result of divorce.

30 (e) The capitalization of a small business. Account moneys may be used for capital, plant,  
31 equipment and inventory expenses or for working capital pursuant to a business plan. The business  
32 plan must have been developed by a financial institution, nonprofit microenterprise program or other  
33 qualified agent demonstrating business expertise and have been approved by the fiduciary organ-  
34 ization. The business plan must include a description of the services or goods to be sold, a marketing  
35 plan and projected financial statements.

36 (f) Improvements, repairs or modifications necessary to make or keep the account holder's pri-  
37 mary dwelling habitable, accessible or visitable for the account holder or a household member. This  
38 paragraph does not apply to improvements, repairs or modifications made to a rented primary  
39 dwelling to achieve or maintain a habitable condition for which ORS 90.320 (1) places responsibility  
40 on the landlord. As used in this paragraph, "accessible" and "visitable" have the meanings given

42 (g) The purchase of equipment, technology or specialized training required to become compet-  
43 itive in obtaining or maintaining employment or to start or maintain a business, as specified in the  
44 account holder's personal development plan for increasing the independence of the person.

45 (2)(a) If an emergency occurs, an account holder may withdraw all or part of the account

1 holder's deposits to an individual development account for a purpose not described in subsection (1)  
2 of this section. As used in this paragraph, an emergency includes making payments for necessary  
3 medical expenses, to avoid eviction of the account holder from the account holder's residence and  
4 for necessary living expenses following a loss of employment.

5 (b) The account holder must reimburse the account for the amount withdrawn under this sub-

7 timely reimbursement to the account is grounds for removing the account holder from the individual

9 may not withdraw any matching deposits or accrued interest on matching deposits from the account.

10 (3) If an account holder withdraws moneys from an individual development account for other  
11 than an approved purpose, the fiduciary organization may remove the account holder from the pro-

13 (4) If an account holder moves from the area where the program is conducted or is otherwise  
14 unable to continue in the program, the fiduciary organization may remove the account holder from  
15 the program.

16 (5) If an account holder is removed from the program under subsection (2), (3) or (4) of this  
17 section, all matching deposits in the account and all interest earned on matching deposits shall re-  
18 vert to the fiduciary organization. The fiduciary organization shall use the reverted funds as a  
19 source of matching deposits for other accounts.

20 **SECTION 21.** ORS 458.690 is amended to read:

21 458.690. (1) Notwithstanding ORS 315.271, a fiduciary organization selected under ORS 458.695  
22 may qualify as the recipient of account contributions that qualify the contributor for a tax credit

25 (a) The fiduciary organization matches amounts deposited by the account holder according to a

19      and Community Services Department with an annual report of the fiduciary organization's individual

- 22      (a) The number of individual development accounts administered by the fiduciary organization;
- 23      (b) The amount of deposits and matching deposits for each account;

- 25      (d) The number of withdrawals made; and
- 26      (e) Any other information the department may require for the purpose of making a return on

27      investment analysis.

28      (5) A fiduciary organization that is the account owner of a [college] savings network account **for**  
29      **higher education under ORS 348.841 to 348.873:**

30      (a) May make a qualified withdrawal only at the direction of the designated beneficiary and only  
31      after the [college] savings network account of the account holder that was established for the des-  
32      ignated beneficiary has been reduced to a balance of zero exclusively through qualified withdrawals

34      (b) May make nonqualified withdrawals only if the [college] savings network account of the ac-  
35      count holder that was established for the designated beneficiary has a balance of less than \$100 or

39      (6) The department may make all reasonable and necessary rules to ensure fiduciary organiza-  
40      tion compliance with this section and ORS 458.685, 458.690 and 458.695.

41      **SECTION 23.** ORS 458.700, as amended by section 10, chapter 765, Oregon Laws 2007, is  
42      amended to read:

43      458.700. (1) Subject to Housing and Community Services Department rules, a fiduciary organ-  
44      ization has sole authority over, and responsibility for, the administration of individual development  
45      accounts. The responsibility of the fiduciary organization extends to all aspects of the account pro-

5 Notwithstanding ORS 458.670 (5) and 458.680 (2), a fiduciary organization may establish income and  
6 net worth limitations for account holders that are lower than the income and net worth limitations  
7 established by ORS 458.670 (5) and 458.680 (2).

8 (2) A fiduciary organization may act in partnership with other entities, including businesses,  
9 government agencies, nonprofit organizations, community development corporations, community  
10 action programs, housing authorities and congregations to assist in the fulfillment of fiduciary or-  
11 ganization responsibilities under this section and ORS 458.685 and 458.695.

12 (3) A fiduciary organization may use a reasonable portion of moneys allocated to the individual  
13 development account program for administration, operation and evaluation purposes.

14 (4) A fiduciary organization selected to administer moneys directed by the state to individual  
15 development account purposes or receiving tax deductible contributions shall provide the Housing  
16 and Community Services Department with an annual report of the fiduciary organization's individual  
17 development account program activity. The report shall be filed no later than 90 days after the end  
18 of the fiscal year of the fiduciary organization. The report shall include, but is not limited to:

19 (a) The number of individual development accounts administered by the fiduciary organization;

20 (b) The amount of deposits and matching deposits for each account;

21 (c) The purpose of each account;

22 (d) The number of withdrawals made; and

23 (e) Any other information the department may require for the purpose of making a return on  
24 investment analysis.

25 (5) A fiduciary organization that is the account owner of a [college] savings network account **for**  
26 **higher education under ORS 348.841 to 348.873:**

27 (a) May make a qualified withdrawal only at the direction of the designated beneficiary and only  
28 after the [college] savings network account of the account holder that was established for the des-  
29 ignated beneficiary has been reduced to a balance of zero exclusively through qualified withdrawals  
30 by the designated beneficiary; and

31 (b) May make nonqualified withdrawals only if the [college] savings network account of the ac-  
32 count holder that was established for the designated beneficiary has a balance of less than \$100 or  
33 if the account holder or designated beneficiary has granted permission to make the withdrawal.  
34 Moneys received by a fiduciary organization from a nonqualified withdrawal made under this para-  
35 graph must be used for individual development account purposes.

36 (6) The department may make all reasonable and necessary rules to ensure fiduciary organiza-  
37 tion compliance with this section and ORS 458.685 and 458.695.

38 **SECTION 24. Notwithstanding any other law limiting expenditures, the limitation on**  
39 **expenditures established by section 1 (2), chapter \_\_\_, Oregon Laws 2015 (Enrolled House Bill**  
40 **5041), for the biennium beginning July 1, 2015, as the maximum limit for payment of expenses**  
41 **from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery**  
42 **funds and federal funds, collected or received by the State Treasurer, is increased by \$896,391**  
43 **for the purpose of carrying out the provisions of sections 1 and 2 of this 2015 Act.**

44 **SECTION 25. (1) The amendments to ORS 348.849 by section 6 of this 2015 Act are in-**  
45 **tended to change the name of the Oregon 529 College Savings Board to the Oregon 529**

1 **Savings Board.**

2 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel  
3 may substitute for words designating the Oregon 529 College Savings Board, wherever they  
4 occur in statutory law, other words designating the Oregon 529 Savings Board.

5 **SECTION 26.** (1) The amendments to ORS 348.844 by section 9 of this 2015 Act are in-  
6 tended to change the name of the Oregon 529 College Savings Network to the Oregon 529  
7 Savings Network.

8 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel  
9 may substitute for words designating the Oregon 529 College Savings Network, wherever they  
10 occur in statutory law, other words designating the Oregon 529 Savings Network.

11 **SECTION 27.** (1) The amendments to ORS 348.856 by section 11 of this 2015 Act are in-  
12 tended to change the name of the Oregon 529 College Savings Network Fund to the Oregon  
13 529 Savings Network Fund.

14 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel  
15 may substitute for words designating the Oregon 529 College Savings Network Fund, wher-  
16 ever they occur in statutory law, other words designating the Oregon 529 Savings Network  
17 Fund.

18 **SECTION 28.** Sections 1 and 2 of this 2015 Act and the amendments to ORS 316.680 and  
19 316.699 by sections 3 to 5 of this 2015 Act apply to distributions from and contributions to  
20 ABLE accounts for tax years beginning on or after January 1, 2015.

21 **SECTION 29.** This 2015 Act takes effect on the 91st day after the date on which the 2015  
22 regular session of the Seventy-eighth Legislative Assembly adjourns sine die.
