

Senate Bill 797

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Tina Kotek for Oregon Board of Accountancy)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws about C.P.A.s and P.A.s. (Flesch Readability Score: 95.1).
Modifies laws regulating public accountancy professionals.

A BILL FOR AN ACT

Relating to public accountancy; creating new provisions; amending ORS 284.368, 305.261, 410.480, 673.010, 673.050, 673.060, 673.075, 673.100, 673.150, 673.153, 673.160, 673.165, 673.170, 673.185, 673.210, 673.220, 673.320, 673.325, 673.345, 673.380, 673.385, 673.390, 673.410, 673.440, 673.455, 673.457, 673.465, 673.605, 673.610 and 703.411; and repealing ORS 673.040 and 673.103.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 673.010 is amended to read:

673.010. As used in ORS 673.010 to 673.465:

(1) "Attestation services" means the following professional services required to be performed under rules adopted by the Oregon Board of Accountancy:

(a) Any audit or other engagement for which performance standards are included in the Statements on Auditing Standards (SAS);

(b) Any review of a financial statement for which performance standards are included in the Statements on Standards for Accounting and Review Services (SSARS);

(c) Any examination of prospective financial information for which performance standards are included in the Statements on Standards for Attestation Engagements (SSAE);

(d) Any examination, review or agreed upon procedures engagement other than an examination described in paragraph (c) of this subsection for which performance standards are included in the Statements on Standards for Attestation Engagements (SSAE); and

(e) Any engagement for which performance standards are included in the Auditing Standards of the Public Company Accounting Oversight Board.

(2) "Business organization" means any form of business organization authorized by law, including but not limited to a proprietorship, partnership, corporation, limited liability company, limited liability partnership or professional corporation.

[(3) "Certificate" means a certificate of certified public accountant issued under ORS 673.040.]

[(4) "Client" means a person who agrees with a licensee or employer of a licensee to receive any professional service from the licensee or employer of a licensee.]

(3) "Certified public accountant" means a person who holds an active certified public accountant license for the practice of public accountancy.

(4) "Client" means a person who receives professional services or a person who agrees

1 **to receive professional services.**

2 (5) "Commission" means money or other consideration recognized by the Oregon Board of
3 Accountancy as a commission by rule.

4 (6) "Compilation services" means professional services required to be performed in accordance
5 with the Statements on Standards for Accounting and Review Services (SSARS) under rules adopted
6 by the board in which the person performing the services presents a financial statement that:

7 (a) Is based on the representation of the owner or management of the company for which the
8 statement is presented; and

9 (b) Does not include assurances by the person that the representations in the financial statement
10 conform to generally accepted accounting principles.

11 (7) "Contingent fee" means a fee established for the performance of any professional service and
12 directly or indirectly paid to a [*licensee*] **person who holds a license** pursuant to an arrangement
13 in which no fee will be charged unless a specified finding or result is attained, or in which the
14 amount of the fee is otherwise dependent upon the finding or result of such service. A fee is not
15 contingent if the fee:

16 (a) Is fixed by courts or other public authorities; or

17 (b) In tax matters, is determined based on the results of judicial proceedings or the findings of
18 governmental agencies.

19 [(8) "*License*" means:]

20 [(a) *A certificate, permit or registration, or a license issued under ORS 673.100, enabling the holder*
21 *thereof to practice public accountancy in this state; or]*

22 [(b) *A certificate, permit, registration or other authorization issued by a jurisdiction outside this*
23 *state enabling the holder thereof to practice public accountancy in that jurisdiction.]*

24 [(9) "*Licensee*" means the holder of a license as defined in subsection (8)(a) of this section.]

25 **(8) "License" means a document issued by this state or any other jurisdiction as evidence**
26 **of authorization to practice public accountancy.**

27 [(10) (9) "Manager" means a manager of a limited liability company.

28 [(11) (10) "Member" means a member of a limited liability company.

29 **(11) "Oregon licensee" means the holder of a license issued by this state.**

30 (12) "Peer review" means a study, appraisal or review of one or more aspects of the public
31 accountancy work of [*a holder of a permit under ORS 673.150,*] **an Oregon licensee** or of a regis-
32 tered business organization that performs attestation services or compilation services, that is con-
33 ducted by:

34 (a) A certified public accountant who holds an active [*permit issued under ORS 673.150 or an*
35 *active*] license issued by the licensing authority for the practice of public accountancy in **this state**
36 **or** another state and who is independent of the [*permit*] **license** holder or registered business or-
37 ganization being reviewed; or

38 (b) A public accountant who holds an active [*permit*] **license** issued [*under ORS 673.150*] **by the**
39 **board** and who is independent of the [*permit*] **license** holder or registered business organization
40 being reviewed.

41 [(13) "*Permit*" means a permit to practice public accountancy issued under ORS 673.150.]

42 [(14) "*Principal place of business*" means the office location designated by a person for purposes
43 of substantial equivalency and reciprocity.]

44 **(13) "Principal place of business" means the location of the principal office where a per-**
45 **son practices public accounting or as otherwise further defined by the board by rule.**

1 [(15)] (14) “Professional” means arising out of or related to the specialized knowledge or skills
 2 associated with certified public accountants and public accountants, **including but not limited to**
 3 **attestation, compilation, audit, management advisory, financial advisory, tax or consulting**
 4 **services or issuance of reports on financial statements, or as further defined by the board.**

5 [(16)] (15) “Public accountant” means a public accountant licensed under ORS 673.100.

6 [(17)] (16) “Referral fee” means a fee recognized by the board as a referral by rule.

7 [(18)] (17) “Registration” means the authority issued under ORS 673.160 by the board to a busi-
 8 ness organization to practice public accountancy in this state.

9 [(19)(a)] (18)(a) “Report,” when used with reference to attestation services or compilation ser-
 10 vices, means an opinion or other form of written language that states or implies assurance as to the
 11 reliability of the attested information or the compiled financial statements and that includes or is
 12 accompanied by a statement or implication that the person issuing the report has special knowledge
 13 or competence in public accountancy. Such a statement or implication of special knowledge or
 14 competence may arise from use by the issuer of the report of names or titles indicating that the
 15 issuer is a public accountancy professional or organization or may arise from the language of the
 16 report itself.

17 (b) “Report” includes any form of written language that:

18 (A) Disclaims an opinion when the form of language implies any positive assurance as to the
 19 reliability of the attested information or the compiled financial statements referred to, or of the
 20 special knowledge or competence on the part of the person issuing the language;

21 (B) Implies any positive assurance as to the reliability of the attested information or compiled
 22 financial statements referred to, or of the special knowledge or competence on the part of the person
 23 issuing the language; or

24 (C) Relates to the affairs of a person and that is conventionally used [*by licensees*] in reports
 25 or financial statements.

26 (c) “Report” does not include:

27 (A) The following statement signed by a person who does not hold a [*certificate, license or permit*
 28 *under ORS 673.010 to 673.465*] **license issued by this state** as long as the statement is not accom-
 29 panied by any wording indicating the person is an accountant or auditor or any other language
 30 prohibited by ORS 673.310 or 673.320:

 33 The accompanying balance sheet (or _____) of XYZ Company as of (date), and the related
 34 statements of income (or retained earnings or cash flow) for the year then ended have been prepared
 35 by me (us).

36 The information presented in these financial statements is the representation of management
 37 (owners).

 40 (B) Any other financial statements or reports that are not and do not purport to be in compli-
 41 ance with national standards, including but not limited to Statements on Standards for Accounting
 42 and Review Services (SSARS) and Statements on Standards for Attestation Engagements (SSAE)
 43 adopted by the board by rule, when the statements or reports are issued by persons not otherwise
 44 subject to regulation by the board under ORS 673.010 to 673.465.

45 [(20)] “State” means any state, territory or insular possession of the United States, and the District

1 of Columbia.]

2 [(21) "Substantial equivalency" means that:]

3 [(a) An individual holds a valid license as a certified public accountant from another state that
4 requires an individual, as a condition of licensure as a certified public accountant, to:]

5 [(A) Complete at least 150 semester hours of college education and obtain a baccalaureate or higher
6 degree conferred by a college or university;]

7 [(B) Achieve a passing grade on the Uniform Certified Public Accountant Examination; and]

8 [(C) Possess at least one year of experience, verified by a licensee, providing any type of service
9 or advice involving the use of accounting, attestation, compilation, management advisory, financial ad-
10 visory, tax or related consulting skills, obtained through public practice or government, industry or
11 academic work; or]

12 [(b) An individual has the qualifications specified in paragraph (a) of this subsection and holds a
13 valid license as a certified public accountant from another state that does not require an individual to
14 have the qualifications specified in paragraph (a) of this subsection as a condition of licensure as a
15 certified public accountant.]

16 **(19) "State" includes any state of the United States, the District of Columbia, Puerto
17 Rico, the United States Virgin Islands, American Samoa, Guam and the Commonwealth of
18 the Northern Mariana Islands, except where the context requires otherwise.**

19 **(20) "Substantially equivalent" means a license from another state that requires an in-
20 dividual, as a condition of licensure as a certified public accountant, to achieve a passing
21 grade on the Uniform Certified Public Accountant Examination and:**

22 **(a) Complete at least 150 semester hours of college education, obtain a baccalaureate or
23 higher degree conferred by a college or university and possess at least one year of experience
24 verified by a license holder and providing any type of service involving the use of accounting,
25 attestation, compilation, management advisory, financial advisory, tax or related consulting
26 skills, obtained through public practice or government, industry or academic work;**

27 **(b) Obtain a baccalaureate degree and possess at least two years or more of experience:**

28 **(A) Verified by a license holder; and**

29 **(B) Providing any type of service or advice involving the use of accounting, attestation,
30 compilation, management advisory, financial advisory, tax or related consulting skills, ob-
31 tained through public practice or government, industry or academic work;**

32 **(c) Obtain a master's degree and possess at least one year or more of experience:**

33 **(A) Verified by a license holder; and**

34 **(B) Providing any type of service or advice involving the use of accounting, attestation,
35 compilation, management advisory, financial advisory, tax or related consulting skills, ob-
36 tained through public practice or government, industry or academic work; or**

37 **(d) Meets requirements otherwise prescribed by the board.**

38 **SECTION 2. ORS 673.050 is amended to read:**

39 673.050. [(1) Except as provided in subsection (2) of this section, a candidate for admission to the
40 examination for a certified public accountant certificate shall present satisfactory evidence of gradu-
41 ation with a baccalaureate or higher degree from a college or university that is accredited by one of
42 the six regional accrediting associations or by another accrediting body that is recognized by the
43 Oregon Board of Accountancy, and shall have completed 120 or more semester hours or 180 or more
44 quarter hours or the equivalent thereof, including courses in the study of accounting, business, eco-
45 nomics, finance, written and oral communications and other subjects as determined by the board as

1 *appropriate for the accountancy profession.]*

2 *[(2) A person may apply to take the examination for the certificate of certified public accountant for*
 3 *the purpose of obtaining a license as a public accountant under ORS 673.100 if the person presents*
 4 *satisfactory evidence of graduation from a high school with a four-year course or of having acquired*
 5 *an equivalent education, and has completed two years of public accountancy experience or the equiv-*
 6 *alent that meets the experience requirements established by the board by rule.]*

7 **(1) A person seeking admission to take the certified public accountant examination to**
 8 **obtain a certified public accountant license or public accountant license shall:**

9 **(a) Submit an application in a form prescribed by the Oregon Board of Accountancy;**

10 **(b) Furnish evidence satisfactory to the board of the applicant's good moral character;**

11 **(c) Pay a fee as prescribed by the board; and**

12 **(d) Provide one of the following:**

13 **(A) For a person applying for admission to take the certified public accountant exam-**
 14 **ination to obtain a certified public accountant license, present evidence satisfactory to the**
 15 **board of:**

16 **(i) Graduation with a baccalaureate or higher degree from a college or university that is**
 17 **accredited by a regional accrediting association or by another accrediting body that is re-**
 18 **cognized by the board; and**

19 **(ii) Completed courses in the study of accounting, business, economics, finance, written**
 20 **and oral communications and other subjects as prescribed by the board by rule as appropri-**
 21 **ate for the accountancy profession; or**

22 **(B) For a person applying for admission to take the certified public accountant exam-**
 23 **ination to obtain a public accountant license, present evidence satisfactory to the board of:**

24 **(i) Graduation from a high school with a diploma or of having acquired an equivalent**
 25 **education; and**

26 **(ii) Two years of public accountancy experience or the equivalent that meets the experi-**
 27 **ence requirements established by the board by rule.**

28 **(2) The board shall adopt rules to carry out the provisions of this section.**

29 **SECTION 3.** ORS 673.060 is amended to read:

30 *673.060. [(1) A person must pass an examination as a condition of the issuance of a certificate of*
 31 *certified public accountant under ORS 673.040 or of a license as a public accountant under ORS*
 32 *673.100 by the Oregon Board of Accountancy. The examination shall test the person's knowledge of*
 33 *the subjects of accounting and auditing and other related subjects. The board may contract with any*
 34 *organization, governmental or private, for examination development and administration.]*

35 *[(2) A person must pass all sections of the examination in order to qualify for a certificate of cer-*
 36 *tified public accountant and must pass the sections of the examination described in ORS 673.100 (1)(c)*
 37 *to qualify for a license as a public accountant.]*

38 *[(3) The board shall charge each person who applies to take the examination a nonrefundable ap-*
 39 *plication fee in an amount determined by the board by rule.]*

40 **(1) The certified public accountant examination must test a person's knowledge of the**
 41 **subjects of accounting and auditing and other related subjects as provided by the Oregon**
 42 **Board of Accountancy by rule.**

43 **(2) The board may contract with any organization, governmental or private, for exam-**
 44 **ination development and administration.**

45 **SECTION 4.** ORS 673.075 is amended to read:

1 673.075. (1) The Oregon Board of Accountancy may, in accordance with its rules, grant credit
2 to an applicant for one or more sections of an examination for which the applicant received passing
3 grades from the licensing authority in any other state.

4 (2) Any examination for which credit is granted an applicant under subsection (1) of this section
5 shall be [*substantially*] equivalent to examination requirements described in ORS 673.060.

6 **SECTION 5. Section 6 of this 2025 Act is added to and made a part of ORS 673.010 to**
7 **673.465.**

8 **SECTION 6. Certified public accountant license; application; fees; rules.** (1) **The Oregon**
9 **Board of Accountancy may issue a certified public accountant license to a person who:**

10 (a) **Submits an application in a form prescribed by the board;**

11 (b) **Provides evidence satisfactory to the board of graduation from a college or university**
12 **that is accredited by a regional accrediting association or by another accrediting body that**
13 **is recognized by the board; and**

14 (c) **Provides evidence satisfactory to the board of experience meeting the requirements**
15 **prescribed by the board by rule and verified by a certified public accountant, public ac-**
16 **countant or chartered accountant, as follows:**

17 (A) **If the applicant has obtained a baccalaureate degree, two years or more of experience**
18 **that meets requirements prescribed by the board by rule;**

19 (B) **If the applicant has obtained a master's degree, one year or more of experience that**
20 **meets requirements prescribed by the board by rule; or**

21 (C) **If the applicant has obtained a baccalaureate degree or higher and has completed 150**
22 **semester hours of college education or more, one year or more of experience that meets**
23 **requirements prescribed by the board by rule.**

24 (2) **All experience obtained by an applicant as described in subsection (1) of this section**
25 **must be verified by a certified public accountant, public accountant or chartered accountant**
26 **who:**

27 (a) **Is licensed and in good standing with the professional licensing board that issued the**
28 **person's license; and**

29 (b) **Has been licensed for a minimum period of time set by the Oregon Board of**
30 **Accountancy by rule.**

31 (3) **In addition to the requirements provided in subsections (1) and (2) of this section, the**
32 **applicant shall provide evidence satisfactory to the board of the following:**

33 (a) **Passing an examination on the code of professional ethics adopted by the board;**

34 (b) **Meeting the requirements of ORS 673.050 for admission to the certified public ac-**
35 **countant examination;**

36 (c) **Passing all sections of the certified public accountant examination; and**

37 (d) **Paying the application fee required by the board by rule.**

38 (4) **A license issued under this section expires every two years. To renew a certified**
39 **public accountant license, a person shall comply with the requirements described in ORS**
40 **673.150.**

41 **SECTION 7.** ORS 673.100 is amended to read:

42 673.100. [(1) *The Oregon Board of Accountancy shall issue a license as a public accountant to a*
43 *person who applies for the license and who:*]

44 [(a) *Passes an examination on the code of professional ethics adopted by the board;*]

45 [(b) *Meets the requirements of ORS 673.050 for admission to the examination for the certificate of*

1 *certified public accountant;]*

2 *[(c) Takes the examination for the certificate of certified public accountant pursuant to ORS 673.060*
 3 *and receives a passing grade in those sections of the examination that the board may require by rule;*
 4 *and]*

5 *[(d) Has at least one year of public accountancy experience or the equivalent satisfactory to the*
 6 *board.]*

7 *[(2) An applicant for a license as a public accountant must make application on a form provided*
 8 *by the board. The board shall charge each applicant a fee for application in an amount determined by*
 9 *the board by rule.]*

10 **(1) The Oregon Board of Accountancy may issue a public accountant license to a person**
 11 **who submits an application in a form prescribed by the board and who provides evidence**
 12 **satisfactory to the board of the following:**

13 **(a) Passing an examination on the code of professional ethics adopted by the board;**

14 **(b) Meeting the requirements of ORS 673.050 for admission to take the certified public**
 15 **accountant examination to obtain a license as a public accountant;**

16 **(c) In addition to meeting the experience requirements of ORS 673.050, providing evidence**
 17 **of one year of public accountancy experience or the equivalent that meets the experience**
 18 **requirements established by the board by rule; and**

19 **(d) Paying the fee required by the board by rule.**

20 **(2) A person licensed as a public accountant under this section may not perform audits.**

21 **(3) A license issued under this section expires every two years. To renew a public ac-**
 22 **countant license, a person shall comply with the requirements described in ORS 673.150.**

23 **SECTION 8. Sections 9 and 10 of this 2025 Act are added to and made a part of ORS**
 24 **673.010 to 673.465.**

25 **SECTION 9. License by reciprocity; application; rules; fees.** (1) **The Oregon Board of**
 26 **Accountancy may issue a certified public accountant license to a person who is licensed in**
 27 **good standing as a certified public accountant in another state and who:**

28 **(a) Submits an application in a form prescribed by the board;**

29 **(b) Passes an examination on the code of professional ethics adopted by the board;**

30 **(c) Pays the fee required by the board by rule; and**

31 **(d) Provides evidence satisfactory to the board of one of the following:**

32 **(A) That the certified public accountant license held by the person is issued by a state**
 33 **that has licensing requirements that are substantially equivalent to the Oregon certified**
 34 **public accountant initial licensure requirements; or**

35 **(B) That the person has been practicing as a certified public accountant for a period of**
 36 **four years or more within the last 10 years immediately preceding the person's application**
 37 **for an Oregon certified public accountant license.**

38 **(2) A license issued under this section expires every two years. To renew a certified**
 39 **public accountant license, a person shall comply with the requirements described in ORS**
 40 **673.150.**

41 **SECTION 10. Licensing of certified public accountants from foreign countries; rules; fees.**

42 **(1) As used in this section, "foreign country" means a government other than:**

43 **(a) The United States; or**

44 **(b) A state.**

45 **(2) The Oregon Board of Accountancy may issue a certified public accountant license to**

1 a person who holds a certified public accountant license or chartered accountant certificate
2 issued in a foreign country if the person:

3 (a) Submits an application in a form prescribed by the board;

4 (b) Is in good standing with the issuing professional licensing governing body in which
5 the person holds a certified public accountant license or chartered accountant certificate;

6 (c) Meets requirements that are substantially equivalent to the education, experience and
7 other requirements that must be satisfied for the issuance of an initial Oregon certified
8 public accountant license;

9 (d) Passes an examination on the code of professional ethics adopted by the board; and

10 (e) Pays the fee required by the board by rule.

11 (3) The board may adopt rules as necessary to carry out this section.

12 **SECTION 11.** ORS 673.150 is amended to read:

13 673.150. *[(1) The Oregon Board of Accountancy shall issue biennially a permit to engage in the
14 practice of public accountancy in this state to an applicant who is:]*

15 *[(a) A holder of the certificate of certified public accountant issued under ORS 673.040 to 673.075;
16 or]*

17 *[(b) A public accountant licensed under ORS 673.100.]*

18 *[(2) Permits issued under this section must be renewed biennially.]*

19 *[(3) Applications for permits or for renewals of permits may be submitted to the board on a form
20 and in a manner prescribed by the board by rule. Applications for permits or for renewals of permits
21 must be accompanied by a fee in the amount of \$255.]*

22 *[(4) Applications for renewals of permits must be accompanied by evidence satisfactory to the board
23 that the applicant has complied with continuing education requirements under ORS 673.165 unless
24 those requirements have been waived by the board.]*

25 *[(5)(a) A permit that is not renewed by the close of the permit period may be restored upon payment
26 of a delinquent renewal fee in an amount determined by the board by rule. A permit lapses if the permit
27 is not timely renewed after the close of the permit period for which it was issued, as determined by the
28 board by rule.]*

29 *[(b) The board may restore a lapsed permit if the person who held the permit meets any condition
30 established by the board by rule.]*

31 *[(c) A permit expires if it is not renewed for six years after the close of the permit period. If a
32 permit expires, the licensee's certificate of certified public accountant issued under ORS 673.040 to
33 673.075 and license as a public accountant issued under ORS 673.100 also expire.]*

34 *[(d) The board may restore an expired permit if the board determines that it has just cause to re-
35 store the permit.]*

36 *[(6) The board may establish a permit renewal option for retired permit holders and establish by
37 rule a reduced fee for retired permit holders who renew permits.]*

38 (1) To renew a license issued by the Oregon Board of Accountancy, an Oregon licensee
39 shall submit to the board every two years:

40 (a) A completed renewal application;

41 (b) The renewal fee in the amount of \$255; and

42 (c) Evidence satisfactory to the board that the Oregon licensee has complied with con-
43 tinuing education requirements under ORS 673.165, unless those requirements have been
44 waived by the board.

45 (2)(a) A license lapses if the license is not timely renewed after the close of the license

1 **period for which it was issued, as determined by the board by rule.**

2 **(b) The board may restore a lapsed license upon payment of a delinquent renewal fee in**
 3 **an amount determined by the board by rule and any other conditions established by the**
 4 **board by rule.**

5 **(3) A license expires if it is not renewed for six years after the close of the license period.**

6 **(4) The board may restore an expired license if the board determines that it has just**
 7 **cause to restore the expired license as determined by the board by rule.**

8 **(5) The board may establish by rule a process for Oregon licensees to obtain and renew**
 9 **a retired license and establish by rule a reduced renewal fee for retired license holders.**

10 **SECTION 12.** ORS 673.153 is amended to read:

11 673.153. (1) A holder of a license with a principal place of business in another state may practice
 12 public accountancy in this state if: *[the holder has a license from another state that is of substantial*
 13 *equivalency, as defined in ORS 673.010 (21)]*

14 **(a) The holder has an active certified public accountant license;**

15 **(b) The requirements to obtain the license in the other state are substantially equivalent**
 16 **to the requirements in this state; and**

17 **(c) The holder is in good standing with the professional licensing board of the issuing**
 18 **state.**

19 (2)(a) A holder authorized under subsection (1) of this section meets this state's requirements to
 20 practice public accountancy and has all the rights and privileges of *[certificate holders and licensees*
 21 *of this state without the need to obtain a certificate under ORS 673.040 or a permit under ORS*
 22 *673.150]* **a person who holds a certified public accountant license issued by the Oregon Board**
 23 **of Accountancy and is not required to obtain a certified public accountant license in this**
 24 **state.**

25 (b) The *[Oregon Board of Accountancy]* **board** may not require, as a condition for practicing
 26 public accountancy under this section, an authorized holder to:

27 (A) Provide notice that the holder practices or intends to practice public accountancy in this
 28 state;

29 (B) Pay an annual fee for the authorization; or

30 (C) Provide any other submission.

31 (3) An authorized holder practicing public accountancy under this section is deemed to:

21 (b) The office may charge the filmmaker or local media production services company for costs
 22 reasonably incurred to verify the actual Oregon expenses, including but not limited to the cost for
 23 a review or audit of the supporting documentation by an accountant or auditor. The office may re-
 24 quire the department to deduct the costs incurred by the office in performing its review or audit
 25 from any reimbursement made to the filmmaker or local media production services company under
 26 this section.

27 (c) The office may adopt rules that establish a procedure for the submission and verification of
