The department shall adopt by rule a schedule 16 17 establishing the amount of civil penalty that may be imposed for a violation, except that a civil penalty may be no less than 18 19 \$1,000 and no more than \$2,500 per violation.
- (c) Grant. -- Money collected by the department under this section shall be used to establish a grant program within the 21 department for the purpose of recruitment and retention of 22 registered nurses. Grants may only be awarded to rural hospitals and high medical assistance hospitals. The department shall develop an application form and shall post the form 26 electronically on the department's publicly accessible Internet website.
  - (d) Applicability. --
- 29 (1) Except as provided under paragraph (2), this section shall not apply to hospitals until one year after the 30 effective date of this section. 31
- (2) This section shall not apply to rural hospitals or 32 33 high medical assistance hospitals until two years after the 34 effective date of this section.
