AN ACT

1 Prohibiting the use of taxpayer funds for certain contracts.

2 The General Assembly of the Commonwealth of Pennsylvania

3 hereby enacts as follows:

4 Section 1. Short title.

5 This act shall be known and may be cited as the Prohibited
6 Contracts Act.

7 Section 2. Definitions.

8 The following words and phrases when used in this act shall
9 have the meanings given to them in this section unless the
10 context clearly indicates otherwise:

11 "Commonwealth agency." An executive agency, a legislative
12 agency, a judicial agency, an independent agency or a State-
13 affiliated entity.

14 "Executive agency."

15 (1) Any of the following:

16 (i) The Governor and the departments, boards,

1 commissions, authorities and other officers and agencies
2 of the executive branch.

3 (ii) The State Treasurer and the Office of the State
4 Treasurer.

5 (iii) The Auditor General and the Office of the
6 Auditor General.

7 (iv) The Attorney General and the Office of Attorney
8 General.

9 (2) The term does not include a judicial agency,
10 legislative agency, independent agency, State-affiliated
11 entity, State-related institution, political subdivision or
12 local, regional or metropolitan transportation authority.

13 "Governmental body." A department, authority, commission,
14 committee, council, board, bureau, division, service, office,
15 officer, administration, legislative body or other establishment
16 in the executive, legislative or judicial branch of the
17 Commonwealth.

18 "Independent agency." Boards, commissions and other agencies
19 and officers of the Commonwealth which are not subject to the
20 policy supervision and control of the Governor. The term does
21 not include an executive agency, judicial agency, legislative
22 agency, State-affiliated entity, State-related institution,
23 political subdivision or local, regional or metropolitan
24 transportation authority.

25 "Judicial agency." A court of the Commonwealth or any other
26 entity, office or officer of the unified judicial system. The
27 term does not include an executive agency, an independent
28 agency, legislative agency, State-affiliated entity, State-
29 related institution, political subdivision or local, regional or
30 metropolitan transportation authority.

1 "Legislative agency."

2 (1) Any of the following:

3 (i) The Senate and a member thereof.

4 (ii) The House of Representatives and a member
5 thereof.

6 (iii) Another agency or officer of the General
7 Assembly.

8 (2) The term does not include an executive agency, an
9 independent agency, a judicial agency, State-affiliated
10 entity, State-related institution, political subdivision or
11 local, regional or metropolitan transportation authority.

12 "Lobbying." As defined in 65 Pa.C.S. § 13A03 (relating to
13 definitions).

14 "Lobbying firm." As defined in 65 Pa.C.S. § 13A03 (relating
15 to definitions).

16 "Lobbyist." As defined in 65 Pa.C.S. § 13A03 (relating to
17 definitions). The term shall not include an individual exempt
18 from the registration and reporting requirements of 65 Pa.C.S.
19 Ch. 13A under 65 Pa.C.S. § 13A06(1), (7), (8) or (10) (relating
20 to exemption from registration and reporting).

21 "Public funds." Money collected, received or held by, for or
22 on account of a governmental body.

23 "State-affiliated entity." A Commonwealth authority or
24 Commonwealth entity. The term includes the Pennsylvania Turnpike
25 Commission, the Pennsylvania Housing Finance Agency, the
26 Pennsylvania Municipal Retirement System, the Pennsylvania
27 Infrastructure Investment Authority, the State Public School
28 Building Authority, the Pennsylvania Higher Educational
29 Facilities Authority and the State System of Higher Education
30 and any member or officer of the foregoing. The term does not

1 include an executive agency, an independent agency, legislative
2 agency, judicial agency, State-related institution, political
3 subdivision or local, regional or metropolitan transportation
4 authority.

5 "State-related institution." The Pennsylvania State
6 University, the University of Pittsburgh, Lincoln University and
7 Temple University.

8 Section 3. Prohibited contracts.

9 A Commonwealth agency shall not enter into a contract with,
10 or otherwise expend public funds for the services of, a lobbyist
11 or lobbying firm in order to lobby another Commonwealth agency.
12 A contract entered into in violation of this section after the
13 effective date of this section shall be void.

14 Section 20. Effective date.

15 This act shall take effect immediately.
