AN ACT

1 Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An
2 act relating to tax reform and State taxation by codifying
3 and enumerating certain subjects of taxation and imposing
4 taxes thereon; providing procedures for the payment,
5 collection, administration and enforcement thereof; providing
6 for tax credits in certain cases; conferring powers and
7 imposing duties upon the Department of Revenue, certain
8 employers, fiduciaries, individuals, persons, corporations
9 and other entities; prescribing crimes, offenses and
10 penalties," in entertainment production tax credit, further
11 providing for carryover, carryback and assignment of credit.

12 The General Assembly of the Commonwealth of Pennsylvania
13 hereby enacts as follows:

14 Section 1. Sections 1714-D(c), (e) and (f) and 1755-D(c),
15 (e) and (f) of the act of March 4, 1971 (P.L.6, No.2), known as
16 the Tax Reform Code of 1971, are amended to read:

17 Section 1714-D. Carryover, carryback and assignment of credit.

18 * * *

19 (c) No carryback [or], refund, sale or assignment.--[A
20 taxpayer is not entitled to carry back or obtain a refund of] A
21 taxpayer is not entitled to carry back, obtain a refund, sell or

1 assign all or any portion of an unused tax credit granted to the
2 taxpayer under this subarticle.

4 (e) [Sale or assignment.--The following shall apply:

5 (1) A taxpayer, upon application to and approval by the
6 department, may sell or assign, in whole or in part, a tax
7 credit granted to the taxpayer under this subarticle.

8 (2) The department and the Department of Revenue shall
9 jointly promulgate regulations for the approval of
10 applications under this subsection.

11 (3) Before an application is approved, the Department of
12 Revenue must make a finding that the applicant has filed all
13 required State tax reports and returns for all applicable
14 taxable years and paid any balance of State tax due as
15 determined at settlement, assessment or determination by the
16 Department of Revenue.

17 (4) Notwithstanding any other provision of law, the
18 Department of Revenue shall settle, assess or determine the
19 tax of an applicant under this subsection within 90 days of
20 the filing of all required final returns or reports in
21 accordance with section 806.1(a)(5) of the act of April 9,
22 1929 (P.L.343, No.176), known as The Fiscal Code.]

23 (Reserved).

24 (f) [Purchasers and assignees.--Except as set forth in
25 subsection (g), the following apply:

26 (1) The purchaser or assignee of all or a portion of a
27 tax credit under subsection (e) shall immediately claim the
28 credit in the taxable year in which the purchase or
29 assignment is made.

30 (2) The amount of the tax credit that a purchaser or

1 assignee may use against any one qualified tax liability may
2 not exceed 50% of such qualified tax liability for the
3 taxable year.

4 (3) The purchaser or assignee may not carry forward,
5 carry back or obtain a refund of or sell or assign the tax
6 credit.

7 (4) The purchaser or assignee shall notify the
8 Department of Revenue of the seller or assignor of the tax
9 credit in compliance with procedures specified by the
10 Department of Revenue.] (Reserved).

14 (c) No carryback ~~[or], refund, sale or assignment.--[A~~
15 ~~taxpayer is not entitled to carry back or obtain a refund of]~~ A

20 (e) [Sale or assignment.--The following shall apply:

21 (1) A taxpayer, upon application to and approval by the

9 (f) [Purchasers and assignees.--The purchaser or assignee of
10 all or a portion of a tax credit under subsection (e) shall
11 immediately claim the tax credit in the taxable year in which
12 the purchase or assignment is made. The amount of the tax credit
13 that a purchaser or assignee may use against any one qualified
14 tax liability may not exceed 50% of such qualified tax liability
15 for the taxable year. The purchaser or assignee may not carry
16 forward, carry back or obtain a refund of or sell or assign the
17 tax credit. The purchaser or assignee shall notify the
18 Department of Revenue of the seller or assignor of the tax
19 credit in compliance with procedures specified by the Department
20 of Revenue.] Reserved.

21 Section 2. This act shall take effect in 60 days.
